- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The Boeing Co. must coordinate with the local Society of Broadcast Engineers coordinator prior to operation to protect the Low Power Broadcast Auxiliary operations on 450-451 MHz & 455-456 MHz.
- (4) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
 - Paging Service licensees in 454 MHz/459 MHz
 - General Aviation Air-Ground Service in 454 MHz/459 MHz
