- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.
- (4) Operation must be prior coordinated with the local SBE frequency coordinator prior to accessing to 515 MHz and 671 MHz.
- (5) If the demonstration is successful and DARPA plans on fielding the project, frequency support must be obtained through proper frequency management channels.
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number HR0011-12-D-0001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
