Purpose: Demonstrate time modulated Ultra-Wideband (UWB) Radar at TABES 2000 as discussed below.

Note: According to the FCC TOWAIR database, the nearest landing area to the Von Braun Center is Redstone Arsenal, which is 5.0 miles away.

Number of units: one RadarVision™ unit

Antenna gain: nominally 0 dB

Radiated power: less than – 73dBW/MHz
