The Commission has heretofore found it to be in the public interest to explore the development of ultra-wideband technology. *See Notice of Inquiry* in ET Docket 98-153 released September 1, 1998 and *Notice of Proposed Rulemaking*, released May 11, 2000.

The purpose of the operations to be conducted under this requested authority will be to evaluate UWB as a potential technology in support of products that our company is considering developing. We realize that U.S. regulations at the time of this request have not been adopted by the Commission and that the Commission may not adopt regulations for UWB or may adopt regulations that are significantly different from the regulations proposed in the May 11 *Notice of Proposed Rulemaking* and that the regulations may affect any products that we design.
