The Commission has heretofore found it to be in the public interest to explore the development of ultra-wideband technology. *See Notice of Inquiry* in ET Docket 98-153 released September 1, 1998 and *Notice of Proposed Rulemaking*, released May 11, 2000.

The purpose of the operations to be conducted under this requested authority will be to evaluate UWB as a potential technology in support of products that our company is considering developing.
