- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

- (4) Trimble Navigation Limited shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (5) The test equipment shall only be used indoors and shall be under the control of Trimble Navigation Limited.
- (6) Testing radionavigation satellite service (RNSS) equipment and systems using 1227.6 MHz and 1575.42 MHz.
- (7) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (8) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
