Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (4) The test equipment shall only be used indoors and shall be under the control of the Union Pacific Railroad Company.
- (5) The Union Pacific Railroad Company shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (6) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (7) The designated point-of-contact to terminate transmissions if interference occurs is David LaChapelle (402) 544-0392.
- (8) Due to anticipated harmful interferences to Omaha, NE Airport operations, a request to operate at this location is denied. Further testing must be ceased at Omaha, NE location.
- (9) Licensee is required to file a PROGRESS REPORT every 6 months from the date of grant.
