This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Upon receipt of a conjunction warning from the JSpOC or other source, the licensee must review the warning and take all possible steps to assess and, if necessary, to mitigate collision risk, including, but not limited to: contacting the operator of any active spacecraft involved in such warning; sharing ephemeris data and other appropriate operational information with any such operator; modifying spacecraft attitude and/or operations.
- (4) Following launch of the satellite, the licensee must notify the FCC through electronic submission to the license file, of the status of the satellite (transmissions commenced, etc.), not later than 7 days after commencement or expected commencement of transmissions, and of termination of transmissions, not later than three months after such termination.
- (5) Due to potential impact to AF radar operations in the UHF band, University of Michigan Ann Arbor is required to provide stop buzzer POC, orbital and schedule updates to AF at AFSPC.A6CE.SMO@us.af.mil , two weeks prior to operation.
- (6) POINT OF COMMUNICATION: MiTEE-1 Satellite
- (7) At least 30 business days prior to operating, University of Michigan Ann Arborn shall provide POC info, orbital and schedule updates at AFSPC.A6CE.SMO@us.af.mil
