This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) After Verizon Wireless has completed coordination and the provisions adopted in FCC 16-89 go into force, this earth station is considered grandfathered in this band pursuant to 47 CFR § 25.136(a)(3).
- (5) In each proposed venue, the applicant must coordinate with the Fixed Microwave Service licensees prior to commencing test operations in accordance with 47 CFR, Part 101.103(d)..

Special Conditions:

- (6) Prior to operation, licensee must coordinate with stations authorized to operate in these frequency bands that are located within a within a 25 mile radius of the transmitter.
- (7) Experimental station shall use the minimum power level necessary to close the communications link to minimize potential interference to licensed users.
- (8) Licensee must avoid pointing the transmitting antenna within 10 degrees of any point on the geostationary orbital arc while transmitting signals in the 27.5-28.5 GHz band.
- (9) Licensee shall ensure that the transmitting base fixed station antenna(s) tip down when possible and avoid pointing above the horizon in order to protect satellite stations in the geostationary orbital arc.
