This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Operation is NOT permitted on the frequency band 1822 MHz -1828 MHz due to potential interference to Federal operations.
- (5) Licensee should note that this operation is in a Primary Federal Allocated Band.
- (6) Licensees must reduce the requested powers to minimum amounts just enough to carry out the desired tests.
- (7) Licensee must get consent from the Advanced Wireless Service licensees and coordinate with the Fixed Microwave users prior to operating on the proposed frequency bands.
