- (3) Operation is subject to prior coordination with the local Society of Broadcast Engineer frequency coordinator and the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d)
- (4) Operation is subject to prior coordination with the existing users of the 71-76 GHz, 81-86 GHz and 92-95 GHz.
- (5) Prior to activation, the applicant must coordinate with coordination required if operation within 50 km of Navy, NMCSO PAC at 808-477-9606; within 50 km of Army, ARMY FAS at 301-225-3778 and within 50 km of Air Force, AF FAS at 301-225-3744.
