## Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) During all testing, the point of contact, James McComb, (818-425-4751) shall be available, if necessary, to stop testing due to interference to government operations in the area.
- (5) Operation is subject to coordination with the Western Area Frequency Coordinator in the Navy Pacific Missile Test Center Point Mugu, CA, prior to use within a 322 kilometer radius of Point Mugu or in California South of Latitude 37' 30" North.

**Special Conditions:**

- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Department of Defense, contract number FA8750-09-C-0233. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
