Special Conditions:

- (1) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee must consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the proposed area.
- (5) Prior to operating, Vivint Wireless, Inc., must notify licensees of earth stations operating in adjacent band above 3700 - 4200 MHz within 13 kilometers radius of each location from which experimental operations will occur. Vivint Wireless, Inc., must also provide such notification to the National Spectrum Managers Association frequency coordinators by email. (see http://wireless.fcc.gov/services/index.htm?job=licensing_1&id=microwave). The notice must include the name and contact information of the stop buzzer personnel that will be available to cease operations in the event of reported interference. The notification should include the testing parameters (specific location(s), antenna gain(s), antenna height(s), antenna orientation, eirp density) and day and times of each test. Consult the IBFS database to identify licensed earth station above 3700 - 4200 MHz band.
- (6) Licensee must maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees.

Special Conditions:

- (7) Licensee must ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic area.
