Dear Mr. Ghaffari:

Thank you for giving us the opportunity to update our applications to provide the additional information. The supplemental information should now be in the electronic applications. In addition, below are responses to your questions. Please let me know if you need any additional information.

1. Why the need for experimental licenses for this number of locations? (total of 35 locations) We are seeking to measure and test deployments in a wide variety of topographies and markets.
2. Will you be performing any type of market study? We have asked for authority for limited market studies in a handful of the markets in our most recent applications (0413-EX-PL-2007, 0418-EX-PL-2007, 0420-EX-PL-2007, 0421-EX-PL-2007, 0422-EX-PL-2007, 0423-EX-PL-2007, 0424-EX-PL-2007, 0425-EX-PL-2007, 0426-EX-PL-2007, 0427-EX-PL-2007).
3. Will you provide services to public and gain any profit if experimental license(s) are approved? In the areas where we are seeking limited market studies, we are intending to operate on a cost-sharing basis only (i.e., we do not intend to make a profit).
4. What will you do with your equipment when the experiment/demonstration is completed or terminated? If permanent authority is obtained, we will offer the equipment for sale to the customers; in other instances we will reclaim the equipment and redeploy it to areas where we are authorized to offer service on a commercial, for-profit basis.
5. Are you building a network? No, we are not intending to build a network pursuant to the experimental authority sought in these applications. We are, however, intending to build a network once the FCC issues the procedures for nationwide licensing and registration for the 3650-3700 MHz band. The work we are performing pursuant to the experimental authorizations will allow us to accelerate the construction of that network by providing valuable information with regard to design and deployment of the necessary equipment and service rollout.
