Conducted Peak Output Power_DH5_2402



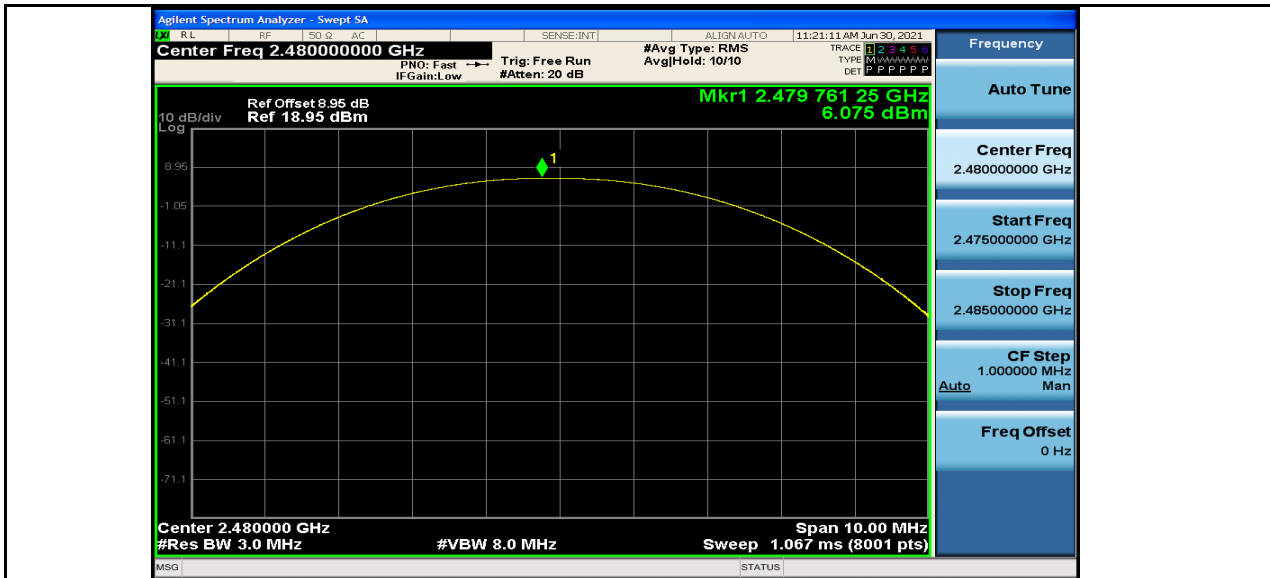

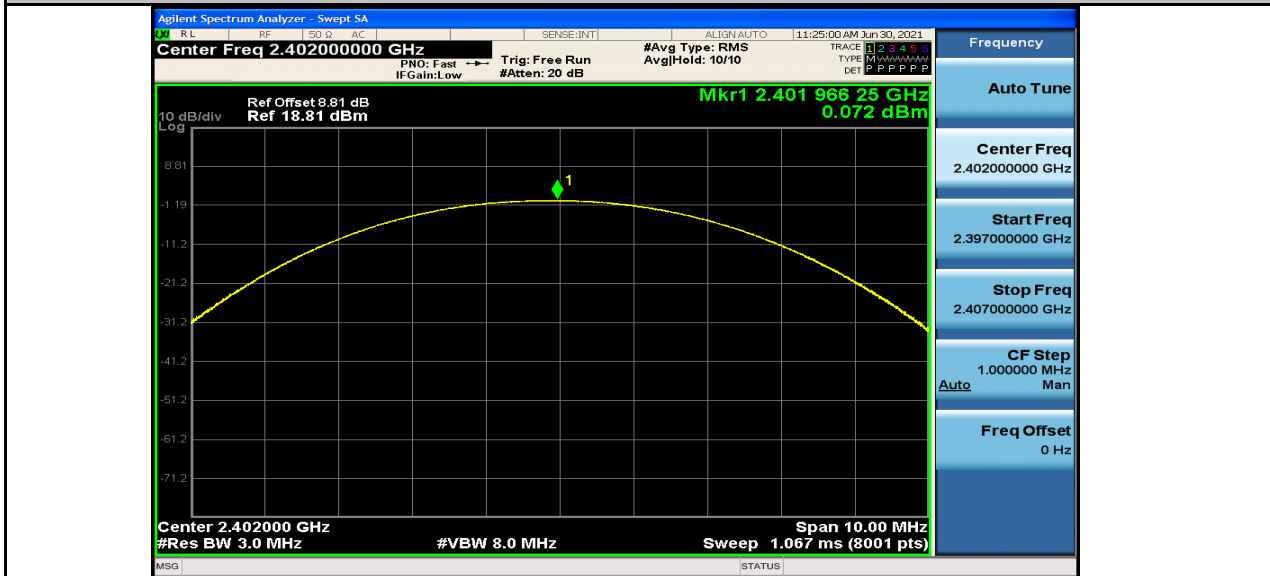

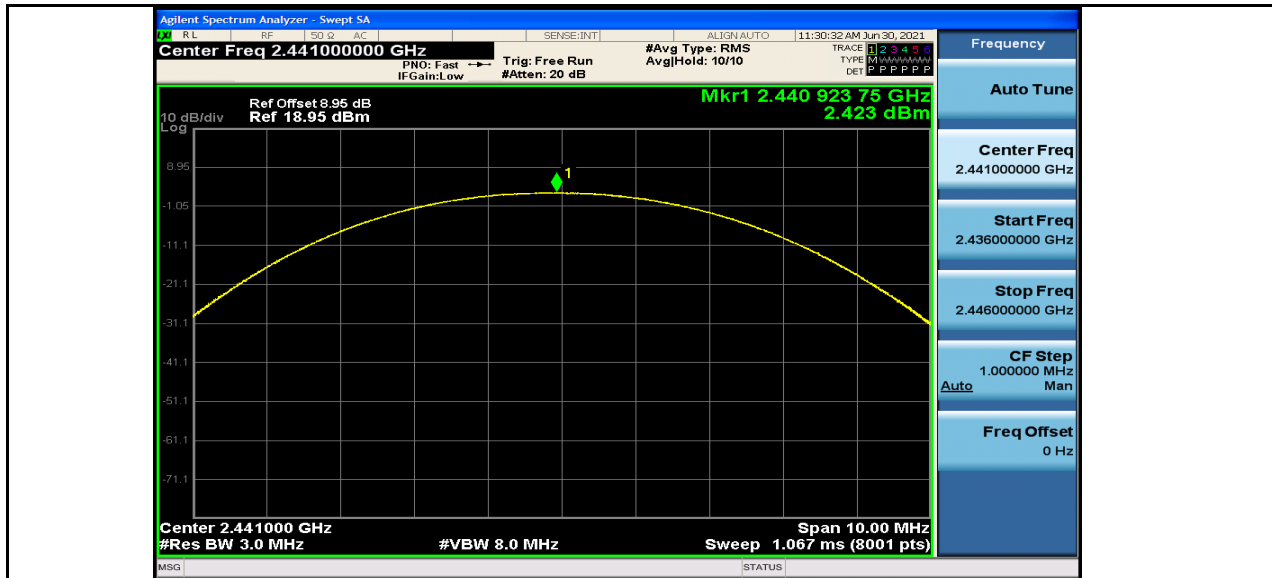
Conducted Peak Output Power_2DH5_2402



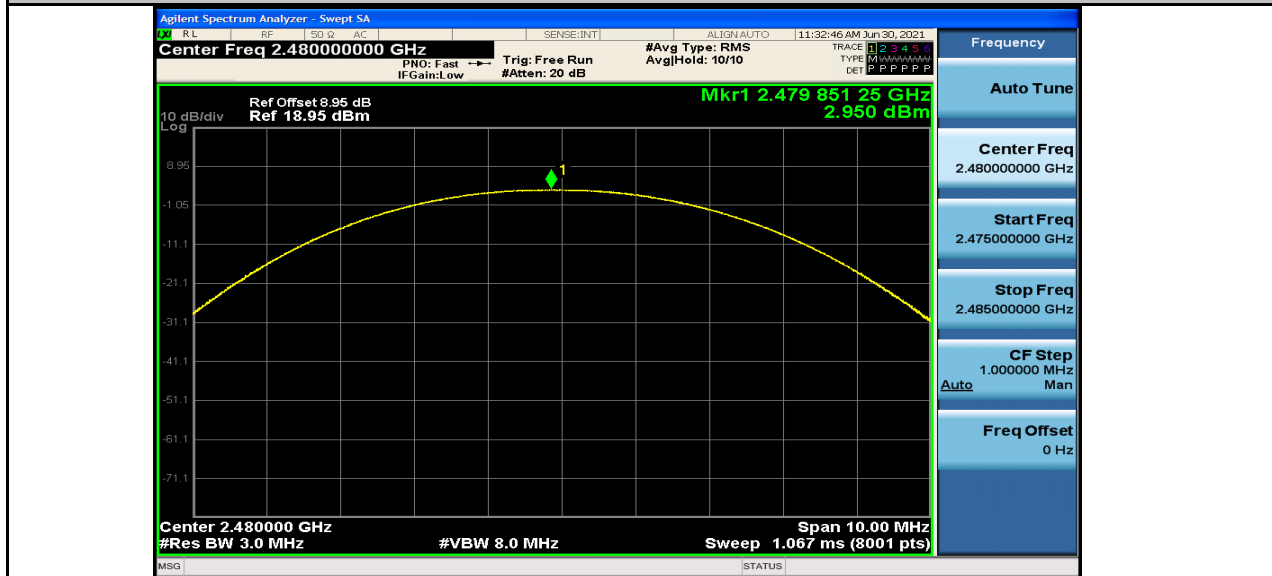

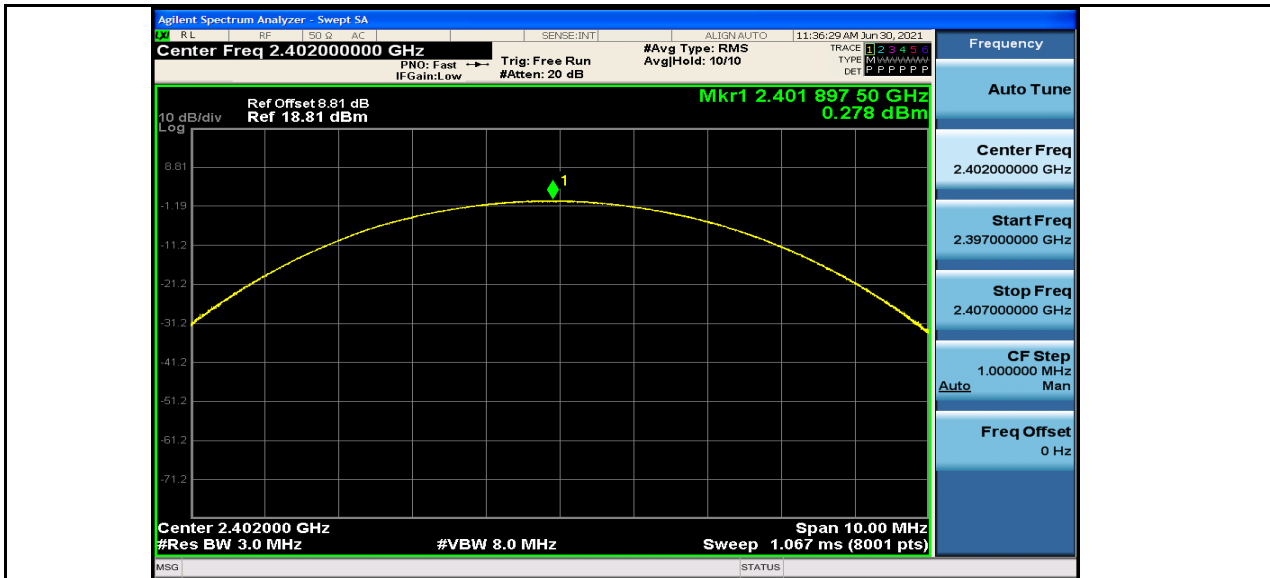

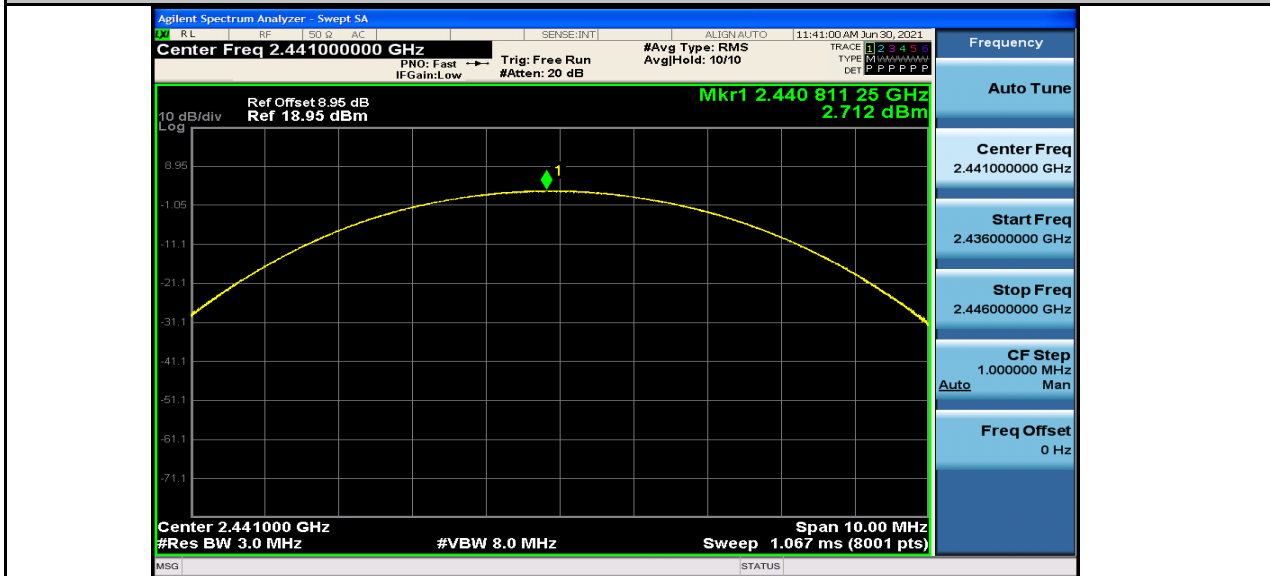

Conducted Peak Output Power_3DH5_2441

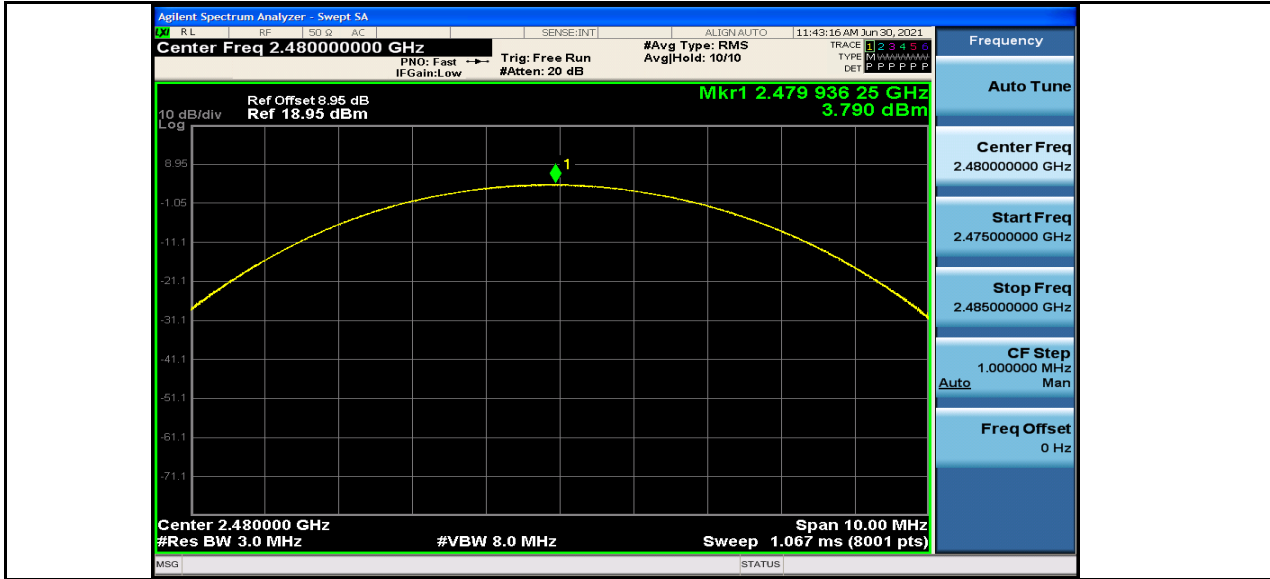

Band-edge for RF Conducted Emissions_2DH5_2480_Hopping Off

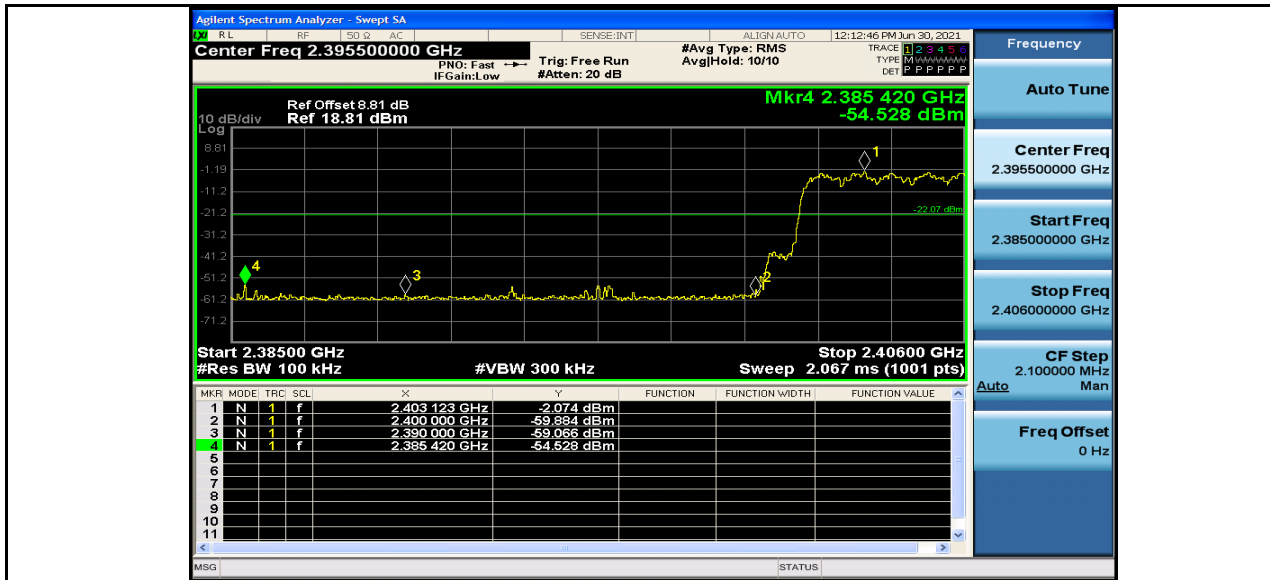
