






- (1) For all test, we have verified the construction and function in typical operation. And all the test modes were carried out with the EUT in transmitting operation in maximum power with all kinds of data rate.
  - According to ANSI C63.10 standards, the measurements are performed at the highest, middle, lowest available channels.
- (2) During the testing procedure, the continuously transmitting with the maximum power mode was programmed by the customer.
- (3) The EUT is considered a Mobile unit; in normal use it was positioned on X-plane. The worst case was found positioned on X-plane. Therefore only the test data of this X-plane was used for radiated emission measurement test.


#### Radiated measurement

#### **Below 1000MHz Test Setup**



#### 6.3 Test Procedure

#### ---Radiated measurement

- ●The measuring distance of 3m shall be used for measurements at frequency up to 1GHz and above 1 GHz. The EUT was placed on a rotating 0.8m high above ground, the table was rotated 360 degrees to determine the position of the highest radiation.
- Measurements at frequency above 1GHz. The EUT was placed on a rotating 1.5m high above the ground. RF absorbers covered the ground plane with a minimum area of 3.0m by 3.0m between the EUT and measurement receiver antenna. The RF absorber shall not exceed 30cm in high above the conducting floor. The table was rotated 360 degrees to determine the position of the highest radiation.
- The Test antenna shall vary between 1m and 4m, Both Horizontal and Vertical antenna are set to make measurement.
- The initial step in collecting conducted emission data is a spectrum analyzer peak detector mode pre-scanning the measurement frequency range. Significant peaks are then marked and then Quasi Peak detector mode re-measured.
- If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit Below 1 GHz, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed. But the Peak Value and average value both need to comply with applicable limit above 1 GHz.
- Testing frequency range 30MHz-1GHz the measuring instrument use VBW=120 kHz with Quasi-peak detection. Testing frequency range 9KHz-150Hz the measuring instrument use VBW=200Hz with Quasi-peak detection. Testing frequency range 9KHz-30MHz the measuring instrument use VBW=9kHz with Quasi-peak detection.





- d) Step a) through step c) might require iteration to adjust within the specified range.
- e) Video averaging is not permitted. Where practical, a sample detection and single sweep mode shall be used. Otherwise, peak detection and max hold mode (until the trace stabilizes) shall be used.

#### 12.3 Test Procedure

- The EUT shall have its hopping function enabled. Use the following spectrum analyzer settings:
- a) Span: Zero span, centered on a hopping channel.
- b) RBW shall be  $\Box$  channel spacing and where possible RBW should be set >> 1 / T, where T is the expected dwell time per channel.
- c) Sweep: As necessary to capture the entire dwell time per hopping channel; where possible use a video trigger and trigger delay so that the transmitted signal starts a little to the right of the start of the plot. The trigger level might need slight adjustment to prevent triggering when the system hops on an adjacent channel; a second plot might be needed with a longer sweep time to show two successive hops on a channel.

Repeat the measurement using a longer sweep time to determine the number of hops over the period specified in the requirements. Determine the number of hops over the sweep time and calculate the total number of hops in the period specified in the requirements, using the following equation:

(Number of hops in the period specified in the requirements) = (number of hops on spectrum analyzer)x(period specified in the requirements / analyzer sweep time)

The average time of occupancy is calculated from the transmit time per hop multiplied by the number of hops in the period specified in the requirements. 


## Band Edge (Hopping) NVNT LoRa 902.3MHz Ant1 Hopping Emission





#### **Burst Repetition During Observation Period Duration**




