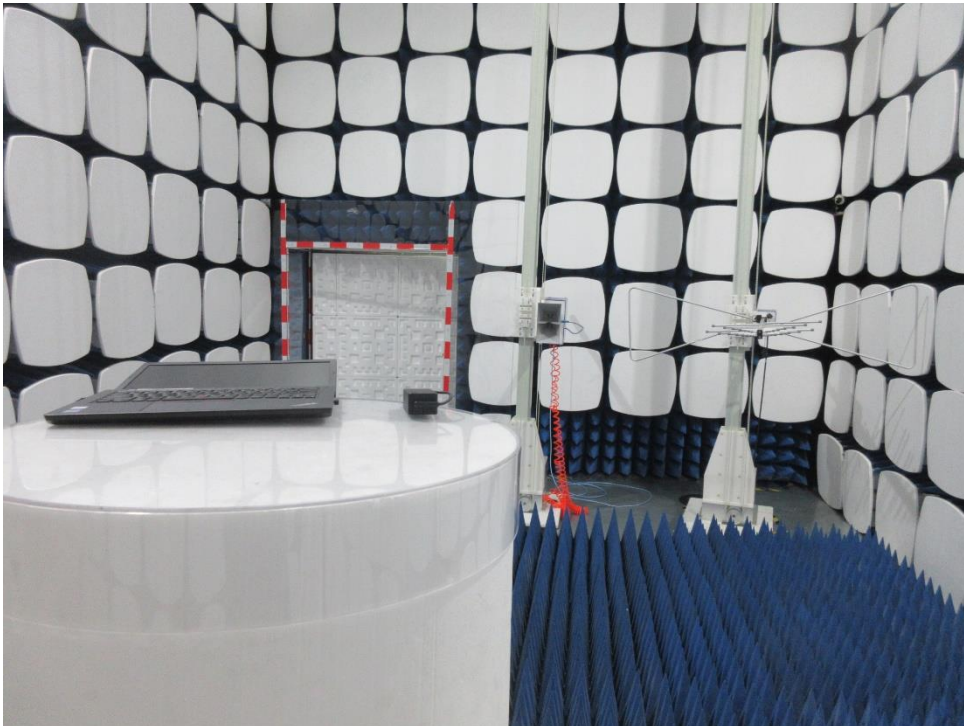

Conducted Emissions at AC Power Line (150kHz-30MHz)



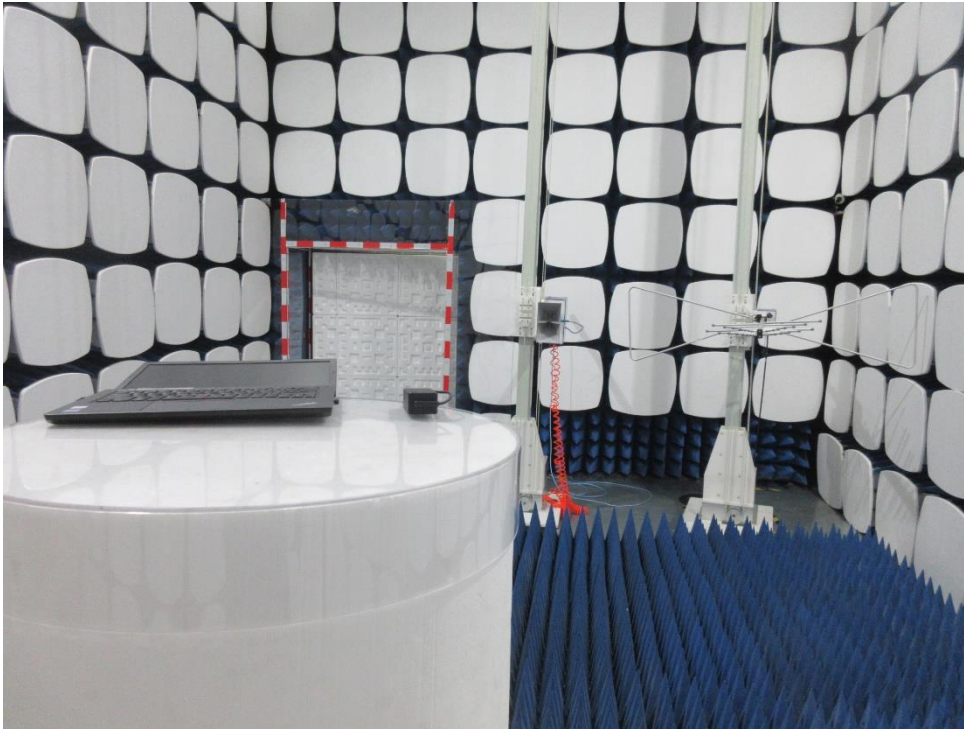
Field Strength of the Fundamental Signal (15.249(a))



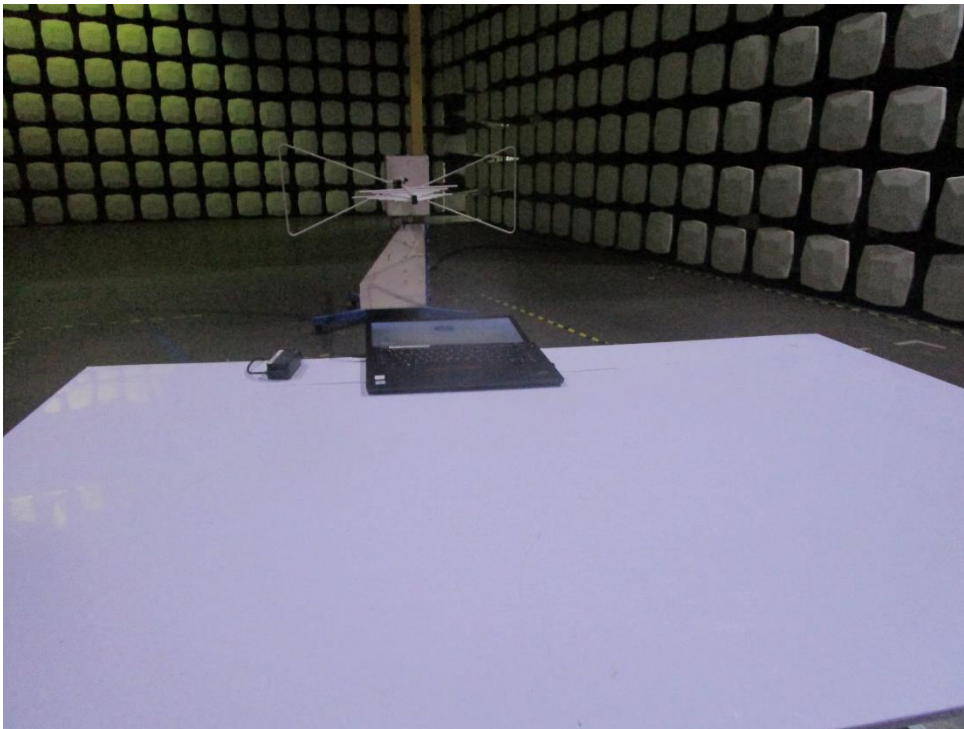

Restricted Band Around Fundamental Frequency

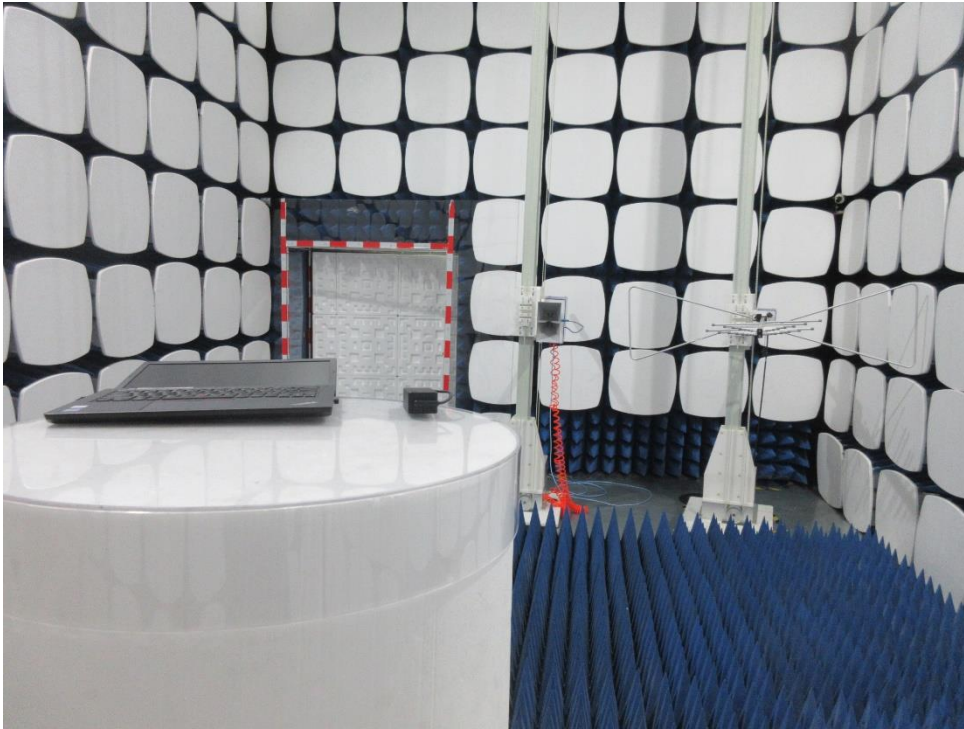


Radiated Emissions (below 1GHz)
