





# 7.5. FREQUENCY STABILITY






#### TEST PROCEDURE

Refer to ANSI C63.10-2013 clause 6.2.

The EUT is put on a table of non-conducting material that is 80 cm high. The vertical conducting wall of shielding is located 40 cm to the rear of the EUT. The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.). A EMI Measurement Receiver (R&S Test Receiver ESR3) is used to test the emissions from both sides of AC line. According to the requirements in Section 6.2 of ANSI C63.10-2013.Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode. The bandwidth of EMI test receiver is set at 9 kHz.

The arrangement of the equipment is installed to meet the standards and operating in a manner, which tends to maximize its emission characteristics in a normal application.





### **10. ANTENNA REQUIREMENT**

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. When measurements at the antenna port are used to determine the RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna's manufacturer. The test report shall state the RF power, output power setting and spurious emission measurements with each antenna type that is used with the transmitter being tested. For licence-exempt equipment with detachable antennas, the user manual shall also contain the following notice in a conspicuous location: This radio transmitter [enter the device's ISED certification number] has been approved by Innovation, Science and Economic Development Canada to operate with the antenna types listed below, with the maximum permissible gain indicated. Antenna types not included in this list that have a gain greater than the maximum gain indicated for any type listed are strictly prohibited for use with this device.

Immediately following the above notice, the manufacturer shall provide a list of all antenna types which can be used with the transmitter, indicating the maximum permissible antenna gain (in
dBi) and the required impedance for each antenna type.




