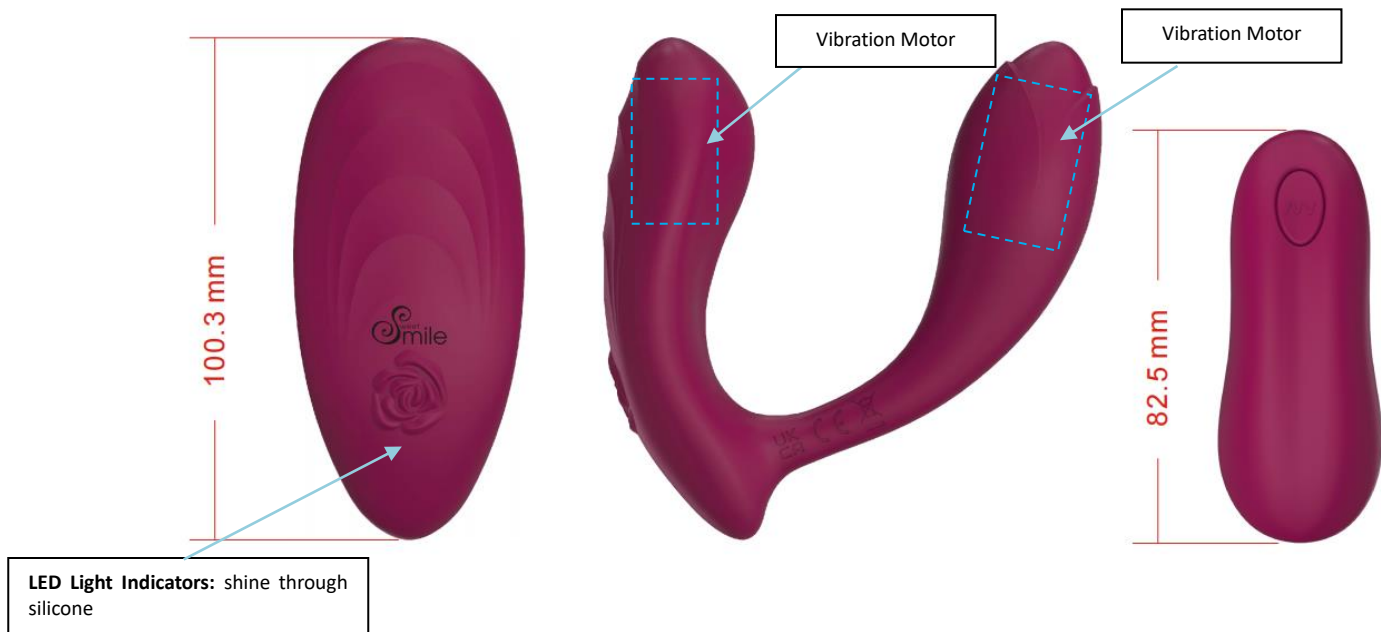


User's Manual for 558559



** GENERAL PRODUCT INFORMATION **

- Materials: Liquid Silicone
- DC (pin) Rechargeable
- Vibration Function: 10 modes (3 speeds + 7 patterns)


** IMPORTANT NOTICE FOR INITIAL USE **


- Make sure the product is 100% dry before charging.
- Before first use, the vibrator needs to be charged between 4-6 hours using the designated DC charging cable (included).
- Normal Charging Time after the first use: 2 ~3 hours
- Indicator light on power button blinks: indicates that device is charging
- Indicator light steadily on: indicates that device is fully charged
- The Vibrator will run for 60 minutes on highest speed


** OPERATING INSTRUCTIONS **

a. Operating the Wearable Panty Vibrator through its own buttons

- **To turn on toy & start the Vibration Function:**

Press and hold  button for 2 seconds, Wearable Panty Vibrator does not start working, pink LED light is on. You're now on StandBy mode.



Short Press  button to cycle between 3 speeds + 7 patterns, pink LED light is constantly on while vibration function is working.



Press and hold  button for 2 seconds to stop vibration function, and the Wearable Panty Vibrator is turn off, pink LED light is also off.


b. Operating the Wearable Panty Vibrator through PAIR MODE (Wearable Panty Vibrator and remote work as a pair)

● **To start & operate the Vibration Function:**

First, press and hold  button on Wearable Panty Vibrator for 2 seconds, white LED light is on. You're now on StandBy mode.

Short press  button on the remote to start vibration function and continue pressing the  button on the remote to cycle between 3 speeds + 7 patterns.

Press and hold  button on the remote for 2 seconds, The toy will back to StandBy mode. Then Short press  button on the remote to start vibration at speed 1.

Press and hold  button for 2 seconds to stop vibration function, and the Wearable Panty Vibrator is turn off, pink LED light is also off.
