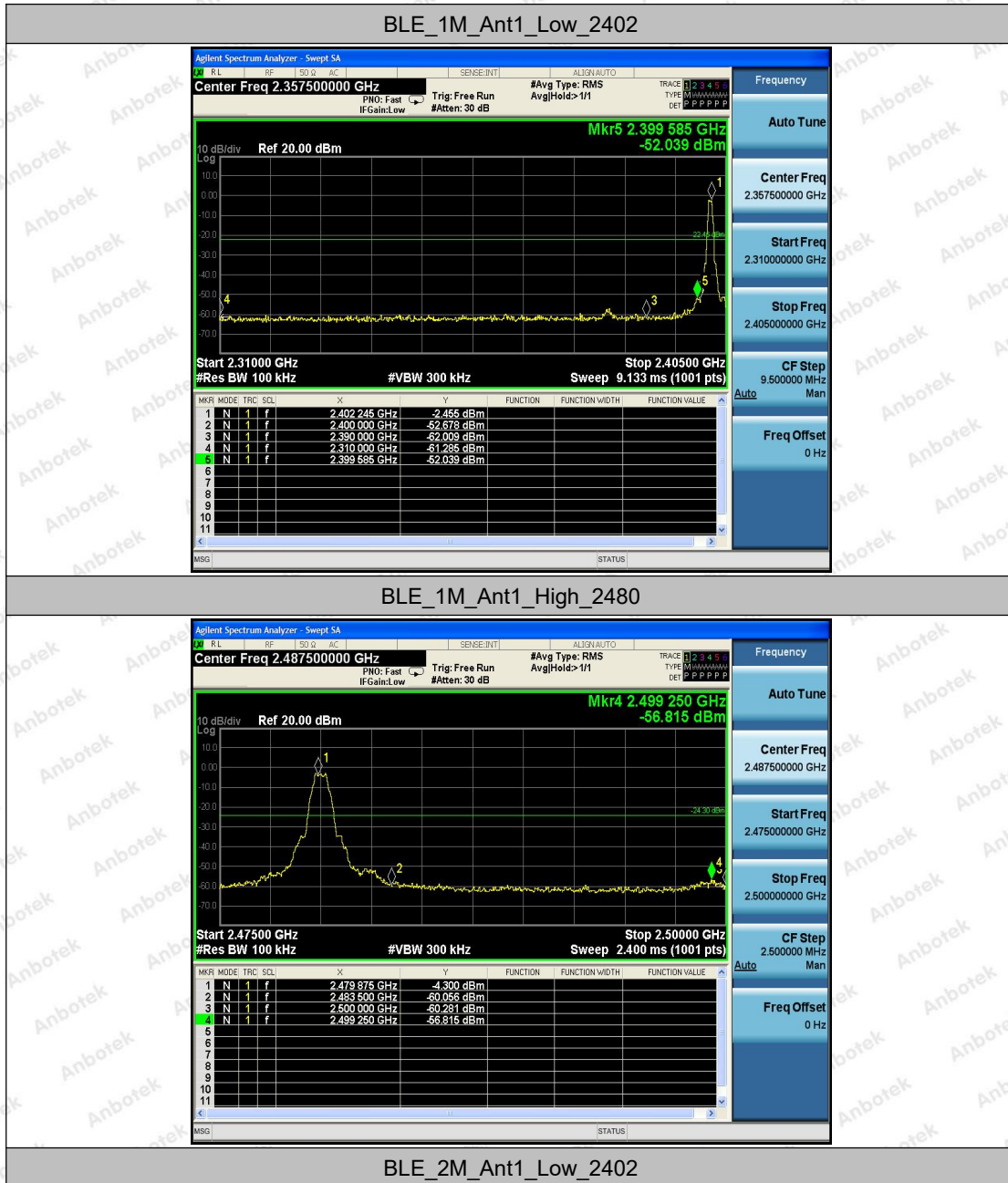

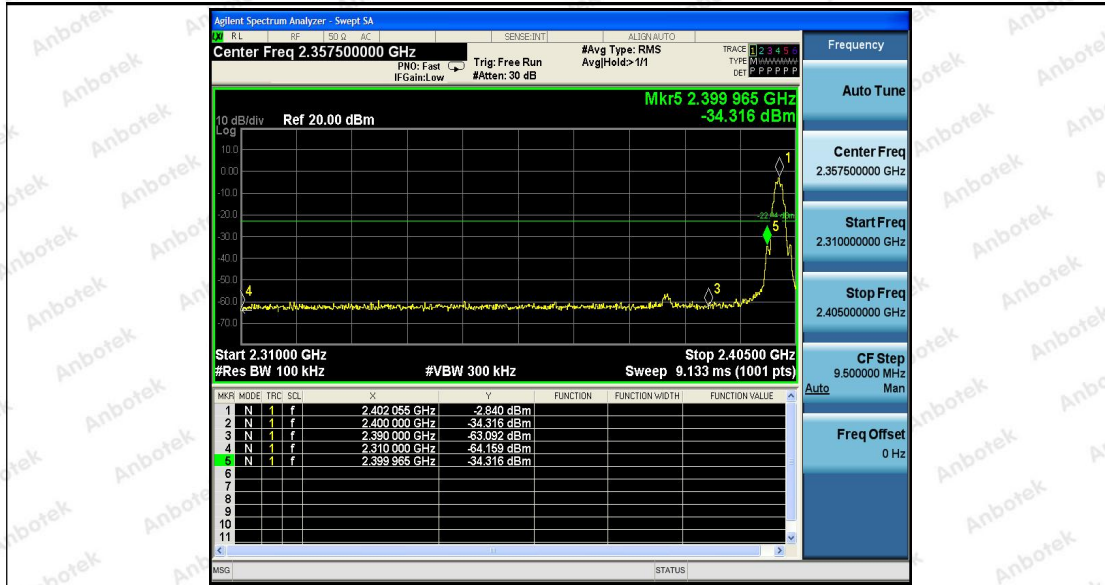

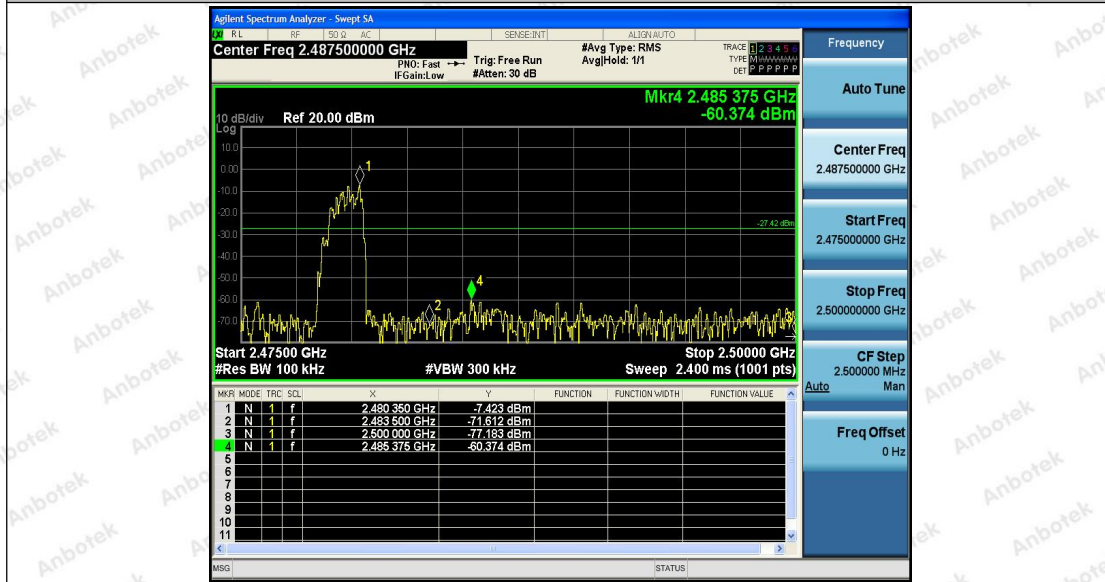

BLE_2M_Ant1_High_2480

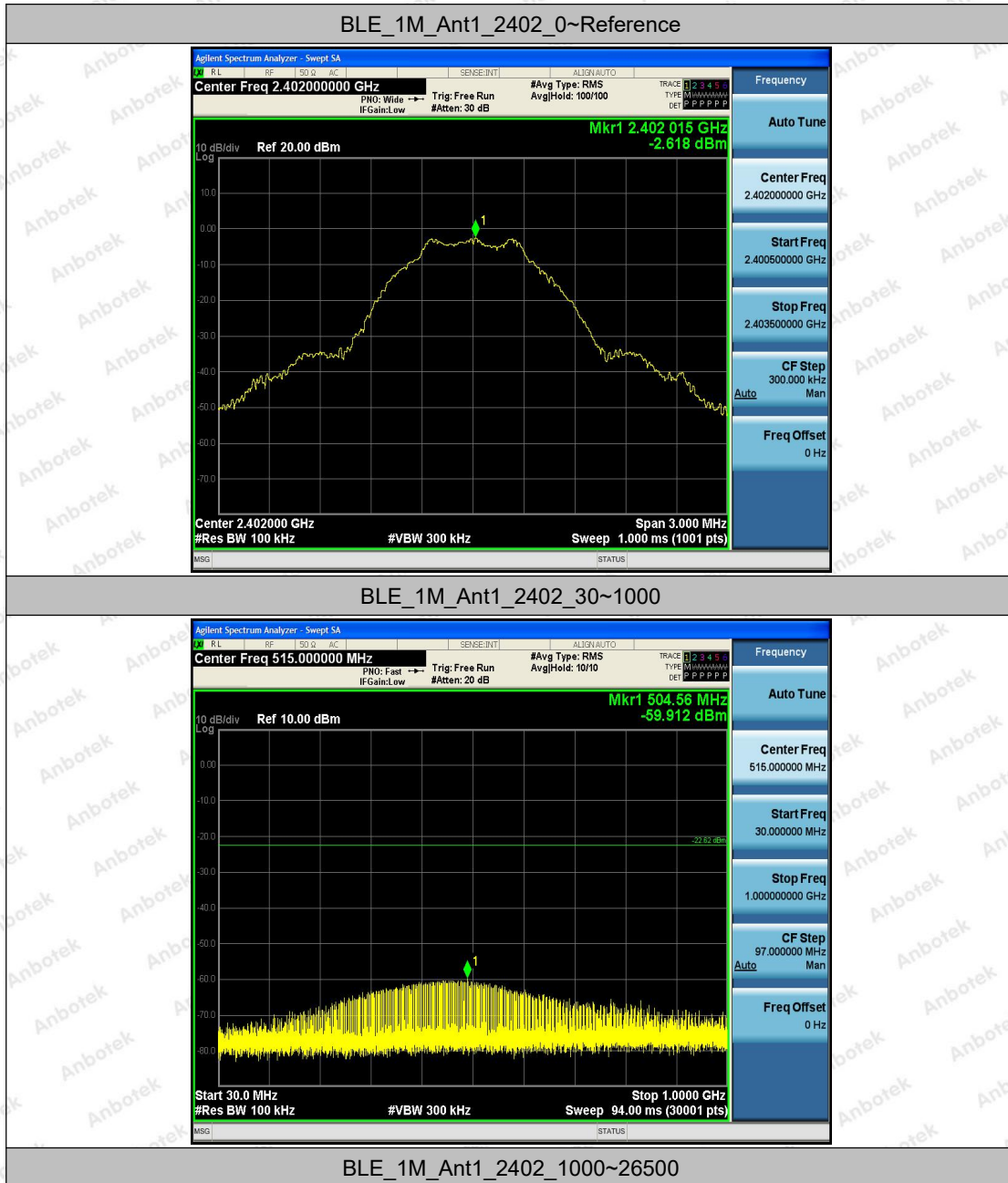
