Test Graphs Peak

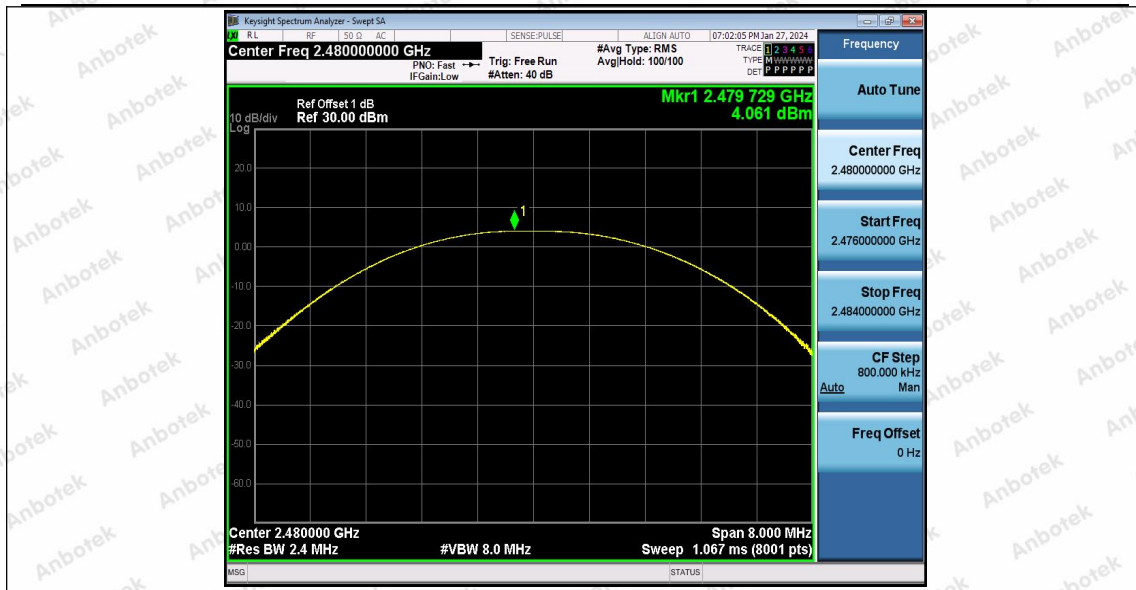
