***Danger**

- 1.Do not put charging dock in water or any liquid.If charging dock is already fall off water,switch off before taking it out from water.To ensure it is totally dry before next use.
- 2.Do not recharge ,use and store beside the area of fire and high temperature atmosphere.
- 3.Do not recharging near to strong magnetic field.

***Caution**

- 1.checking if the voltage of product adapt to your local voltage before recharging it.
- 2.One set include replacements like charge dock,handle and USB line.Any part breaks down,replace it to avoid dangers.(only replace it by assorted replacements from us)Giving it away when it can not replace.
- 3.Do not put product on place children&infant child can reach.Do not play it as a play toy
- 4.Please ask your doctor before using it if you have a operation in 2 months.
- 5.Do not using it for other purpose except for oral health care
- 6.Clearing up brush heads after using when your toothpaste with hydrogen peroxide,dicarbonate and bicarbonate.
- 7.Do not using it when taking shower.Turning it off when not using it to avoid fire a dangers.


*Following below for the first time

- 1.Aligning toothbrush heads with handle.
- 2.Pushing toothbrush heads to handle
- 3.Putting charging dock on safe,balance,dry and shade place
- 4.Turning on charging dock
- 5.Putting handle on recharging dock,the indicator light on.



FAULT DIAGNOSIS

SITUATION	REASONS	SOLUTION
Vibration reduction	Stronger push on tooth Too close between handle&brush head	Put brush heads on tooth lightly Leave out a gap between brush head&handle
Short battery life after full charging	no energy in when charging battery low	Put handle straight on charging dock and ensure the indicator light on
Toothbrush heads break down	Charging time is not enough Not use for 6 months	recharging it Exchange battery from after-service stuffs

CHARGING BATTERY

- 1.Running out all the energy for the first time to use.Recharging it for next time.Running out all energy for every month to protect the battery life.
- 2.Recharging for 6-8h after 6-months no use
- 3.Putting handle on charging dock&ensure indicator light on
- 4.Long time no recharging,the indicator light will on after about 6-10min.

***Normal charging-red indicator**


***full charging-green indicator**

CAUTION

- *do not charging it in bath room!do not put charging dock beside water or bath tuns
- *do not break off products or recharge battery,if need change battery,ask for help from stuffs
- *do not change USB charging line&charging dock,send it to after-service department if need.

MAINTENANCE




CLEARING

- *Clearing brush head after using and drying it by air
- *Do not draw brush to avoid falling brush




CLEARING BODY

- *Clear body by soft cloth
- *Do not put it in the water
- *Do not clear it by 40 °C above water or acid solvent



CLEARING CHARGING DOCK

- *Sweep dirty away from dock
- *Switch off before clearing dock to avoid electric shock
- *Sweep it by soft cloth to avoid short circuit



REPLACE BRUSH HEAD

- *replace brush head for 3 month as dentist suggests

5 MODES


3500vpm/min combine to wide toothbrush head will make deep and excellent clearing results

FUNCTION DESCRIPTION

1.5 modes: clean, white, sensitive, massage and gum care.

2.different modes:clear >whit> sensitive> massage > gum care>stop,each mode have 8s timer-remainder


3.function button sequence: clear >whit> sensitive> massage > gum care>stop



MODES

In any modes,it will pause for 0.3s to remind you to brush next area. The total brushing time will be 2 mins.

TIME




*Brushing tooth for 2min as dentist suggest

* The device will record the mode after every single use


STEP 1

Running out all power of toothbrush for the first time, then recharging it for 6 hours.




STEP 2

normal performance.




STEP 3

Squeezing toothpaste on toothbrush




STEP 4

Putting toothbrush head on between tooth and gums




STEP 5

Turning the device on and clearing up.





STEP 6

Turning off before taking out toothbrush heads.




STEP 7
