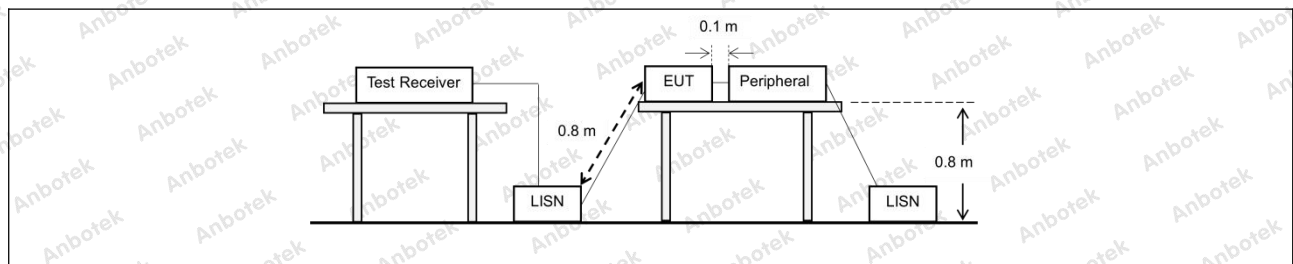

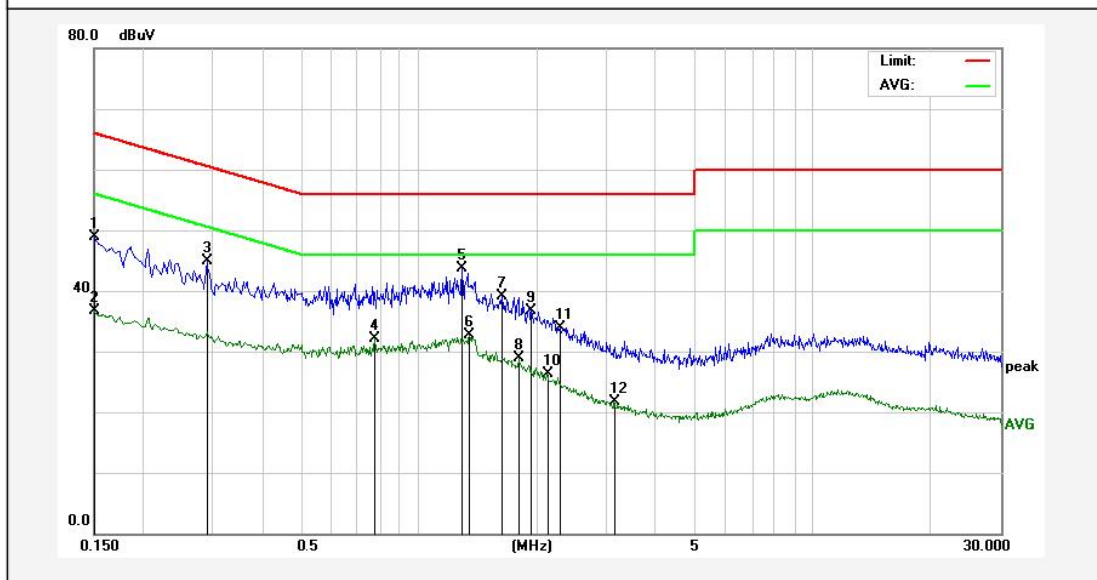

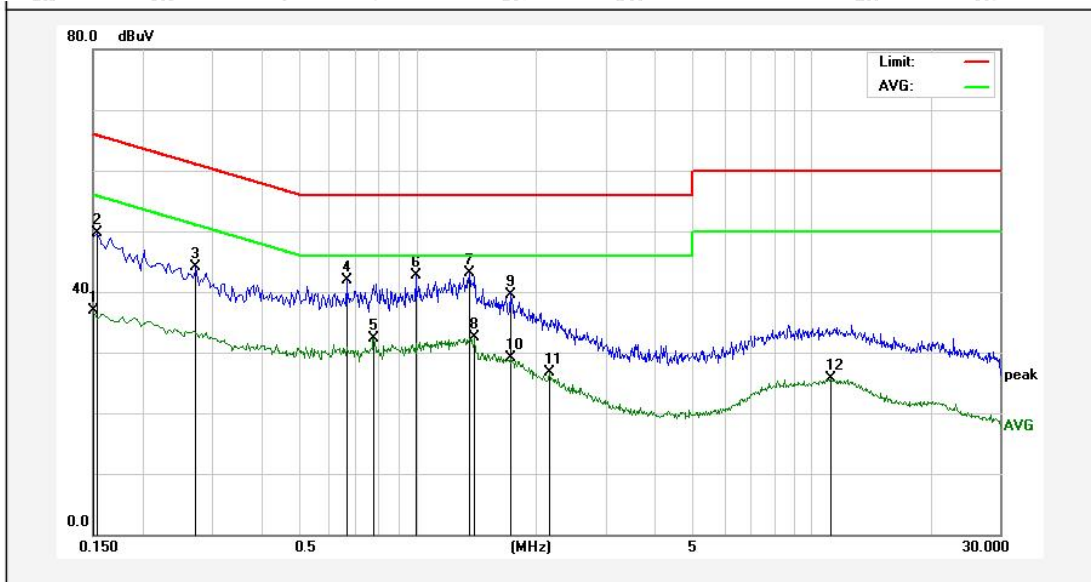

4. Occupied Bandwidth
