5. TEST CONDITIONS AND RESULTS

5.1. Antenna Requirement

REQUIREMENT

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responseble party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator, the manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

(i) Systems operating in the 2400-2483.5 MHz band that is used exclusively for fixed. 


TEST PROCEDURE


- 1. The EUT was setup according to ANSI C63.10 requirements.
- 2. The EUT was placed on a platform of nominal size, 1 m by 1.5 m, raised 80 cm above the conducting ground plane. The vertical conducting plane was located 40 cm to the rear of the EUT. All other surfaces of EUT were at least 80 cm from any other grounded conducting surface.
- 3. The EUT and simulators are connected to the main power through a line impedances stabilization network (LISN). The LISN provides a 50 ohm /50uH coupling impedance for the measuring equipment.
- 4. The peripheral devices are also connected to the main power through a LISN. (Please refer to the block diagram of the test setup and photographs)
- 5. Each current-carrying conductor of the EUT power cord, except the ground (safety) conductor, was individually connected through a LISN to the input power source.
- 6. The excess length of the power cord between the EUT and the LISN receptacle were folded back and forth at the center of the lead to form a bundle not exceeding 40 cm in length.
- 7. Conducted emissions were investigated over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9 kHz.
- 8. During the above scans, the emissions were maximized by cable manipulation.

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. FCC CFR Title 47 Part 15 Subpart C Section 15.247 (a)(1):Frequency hopping systems shall have hopping channel carrier fre-quencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hop-ping channel, whichever is greater. Al-ternatively, frequency hopping systems operating in the 2400–2483.5 MHz band may have hopping channel carrier fre-quencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW. The system shall hop to chan-nel frequencies that are selected at the system hopping rate from a pseudo ran-domly ordered list of hopping fre-quencies. Each frequency must be used equally on the average by each trans-mitter. The system receivers shall have input bandwidths that match the hop-ping channel bandwidths of their cor-responding transmitters and shall shift frequencies in synchronization with the transmitted signals.


The pseudorandom frequency hopping sequence may be generated in a nice-stage shift register whose 5th and 9th stage outputs are added in a modulo-two addition stage. And the result is fed back to the input of the friststage. The sequence begins with the frist one of 9 consecutive ones, for example: the shift register is initialized with nine ones.
