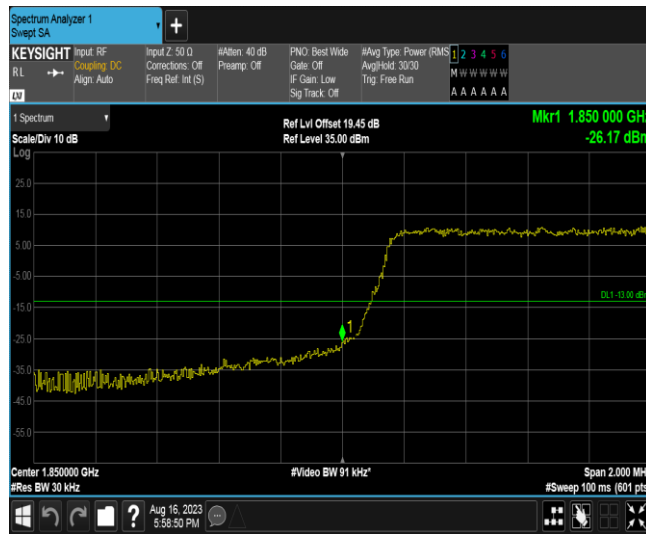


Band2-1.4MHz-QPSK-18607-1RB#5
