Band41-15MHz-16QAM-40620-1RB#0-Range1:30~1000MHz

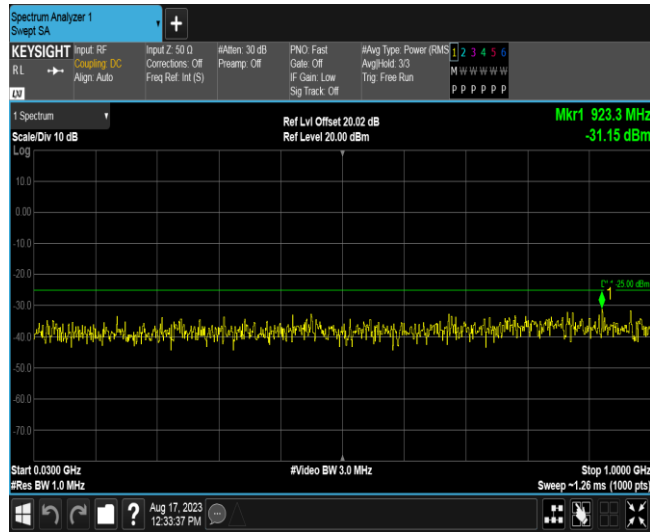


Band41-15MHz-16QAM-40620-1RB#0-Range2:1000~27000MHz

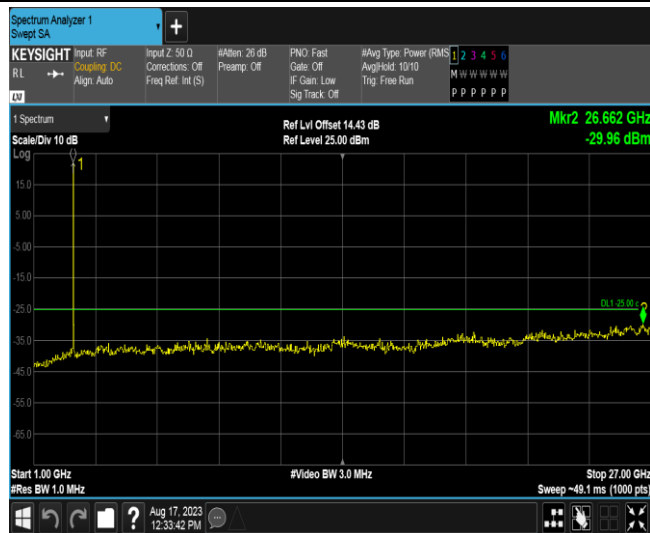

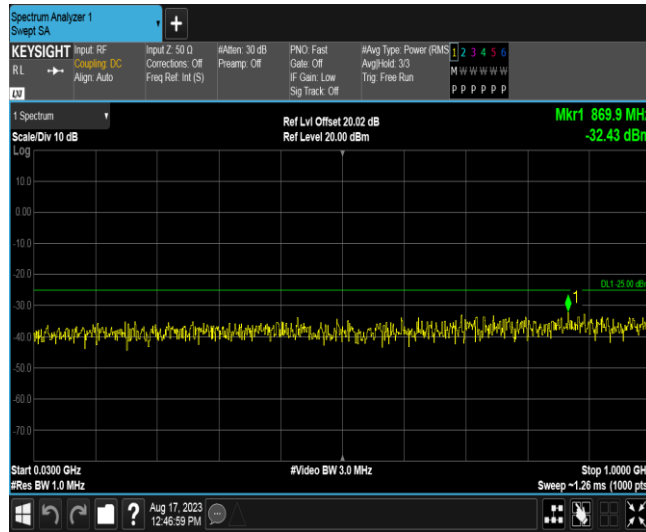

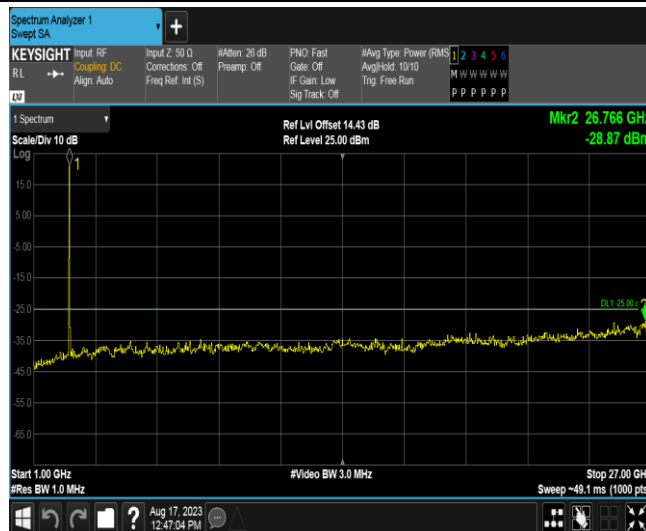
