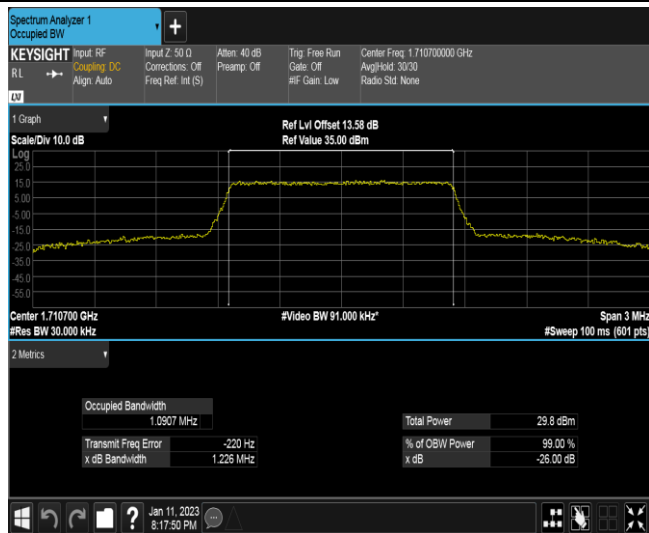

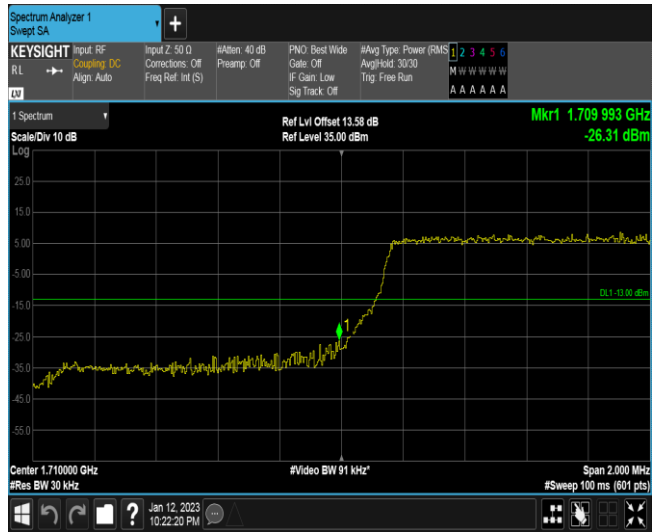


Band4-1.4MHz-QPSK-19957-1RB#5
