Band4-15MHz-QPSK-20025-1RB#0-Range1:30~1000MHz

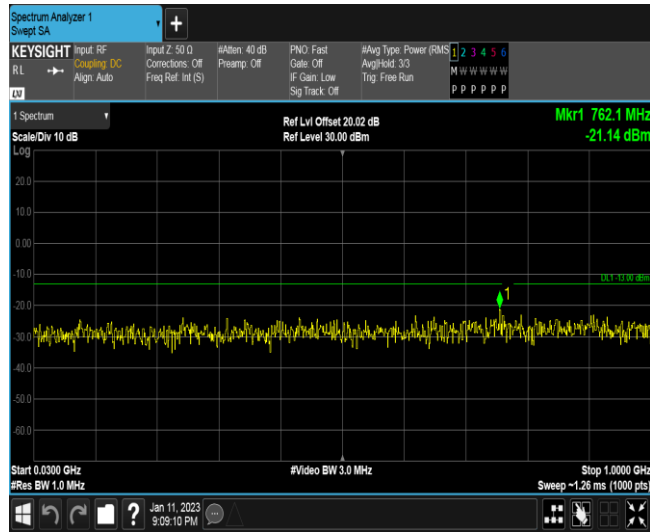


Band4-15MHz-QPSK-20025-1RB#0-Range2:1000~20000MHz

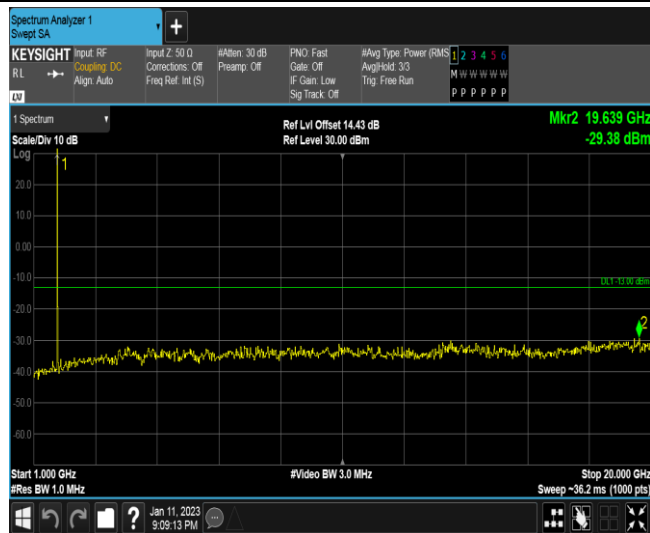

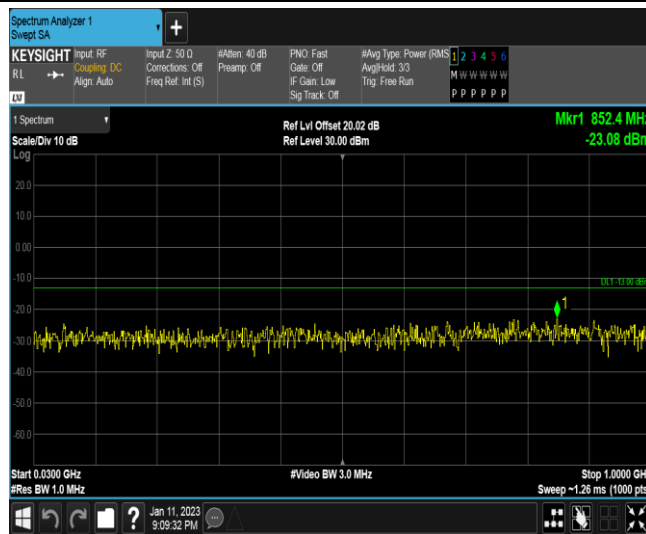


Band4-15MHz-QPSK-20175-1RB#0-Range2:1000~20000MHz

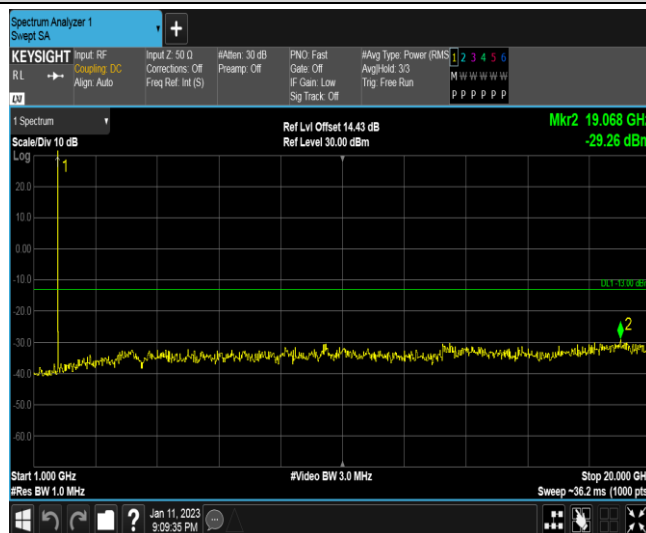

Band4-15MHz-16QAM-20325-1RB#0-Range1:30~1000MHz

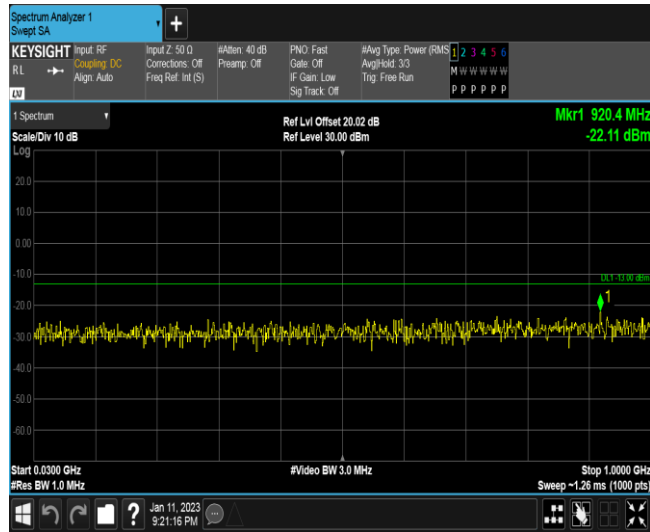


Band4-15MHz-16QAM-20325-1RB#0-Range2:1000~20000MHz

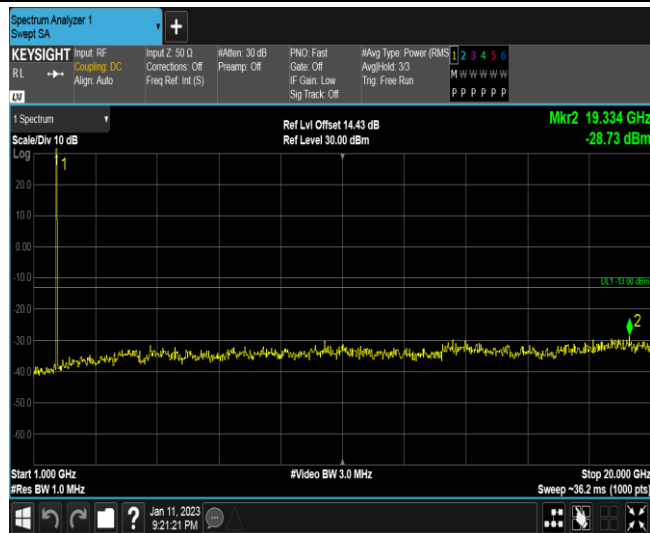

Band4-20MHz-QPSK-20175-1RB#0-Range2:1000~20000MHz

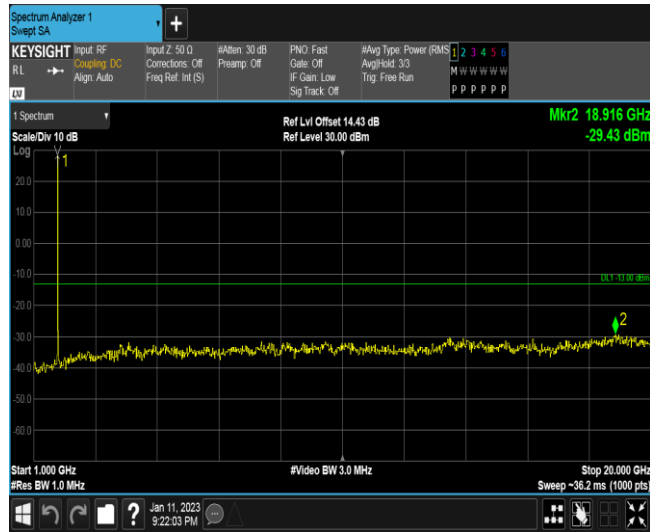


Band4-20MHz-QPSK-20300-1RB#0-Range1:30~1000MHz

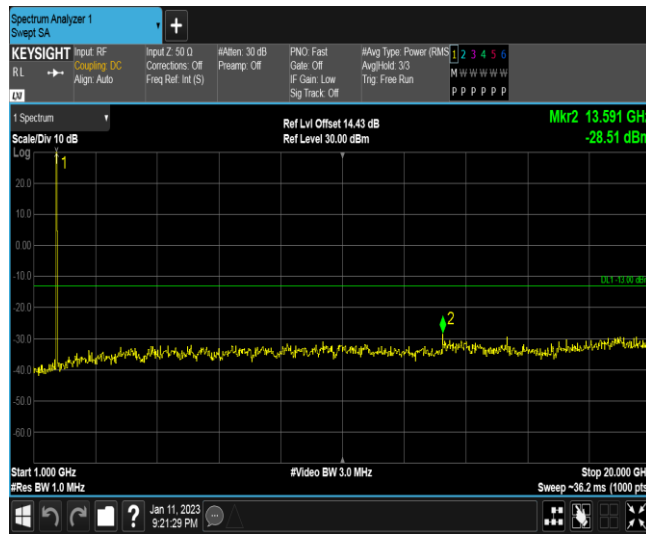


Band4-20MHz-16QAM-20050-1RB#0-Range1:30~1000MHz

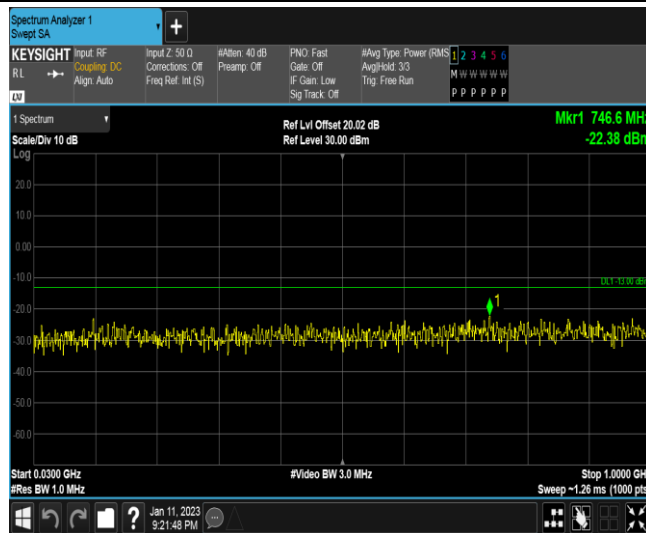

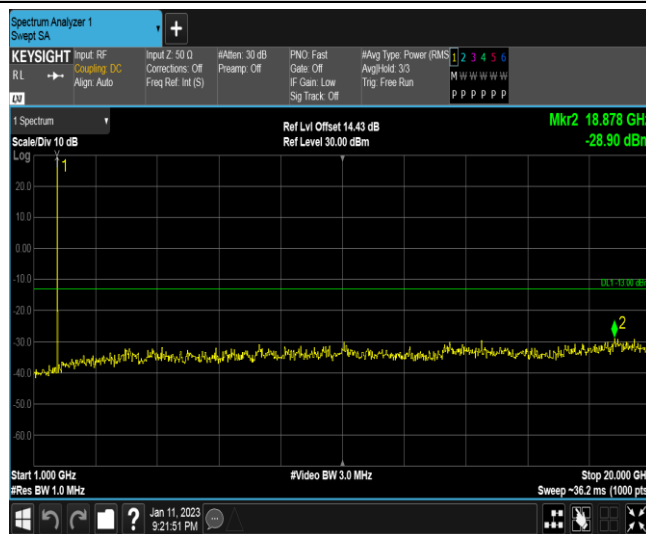

Band4-20MHz-16QAM-20175-1RB#0-Range1:30~1000MHz

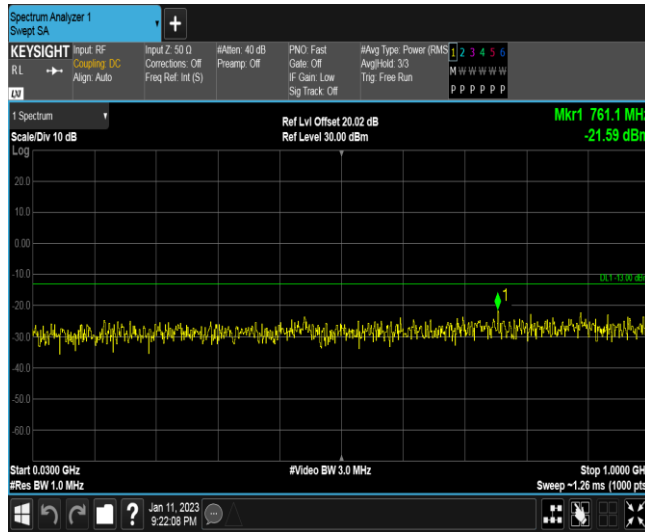

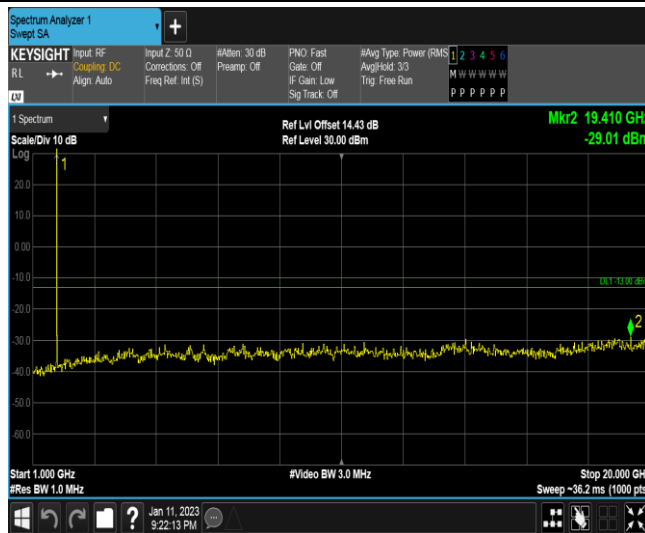
