Band13-5MHz-QPSK-23230-25RB#0

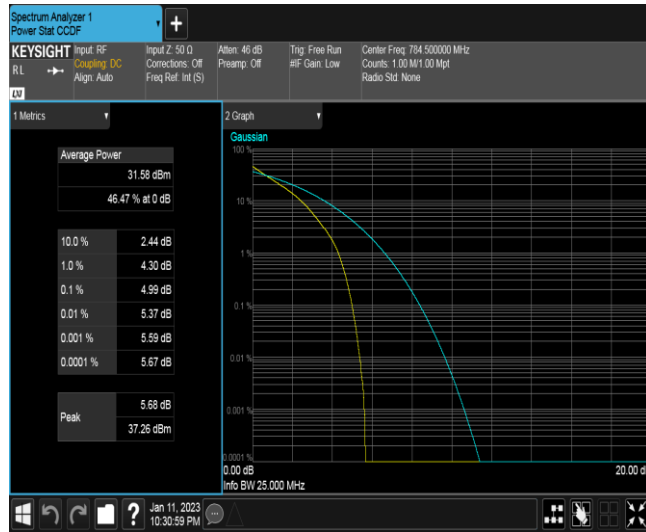

Band13-5MHz-16QAM-23230-1RB#0

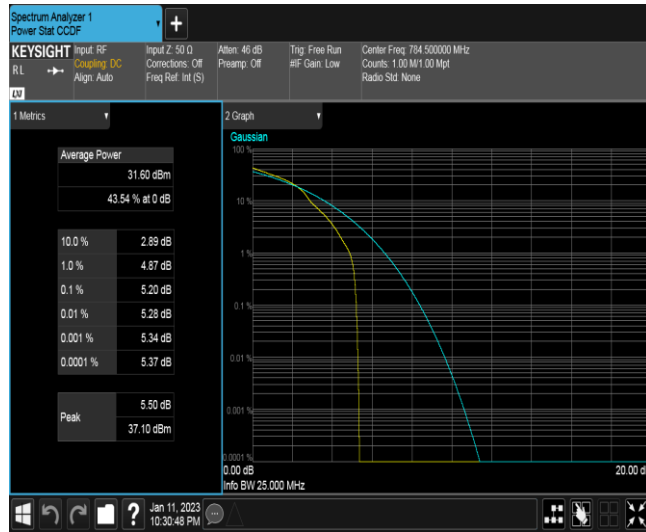

Band13-10MHz-QPSK-23230-50RB#0

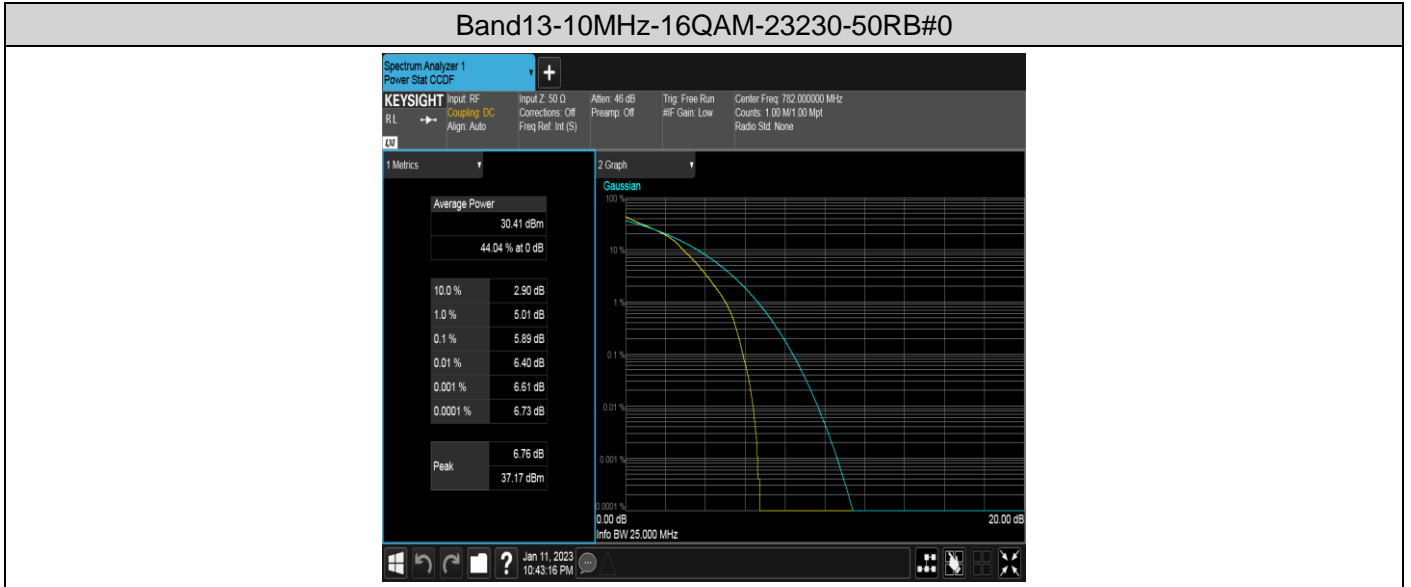

Band13-5MHz-QPSK-23255-25RB#0

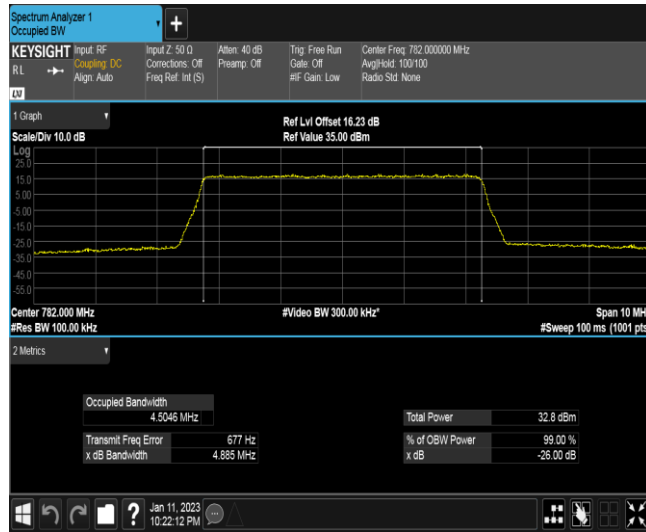

Band13-10MHz-16QAM-23230-50RB#0



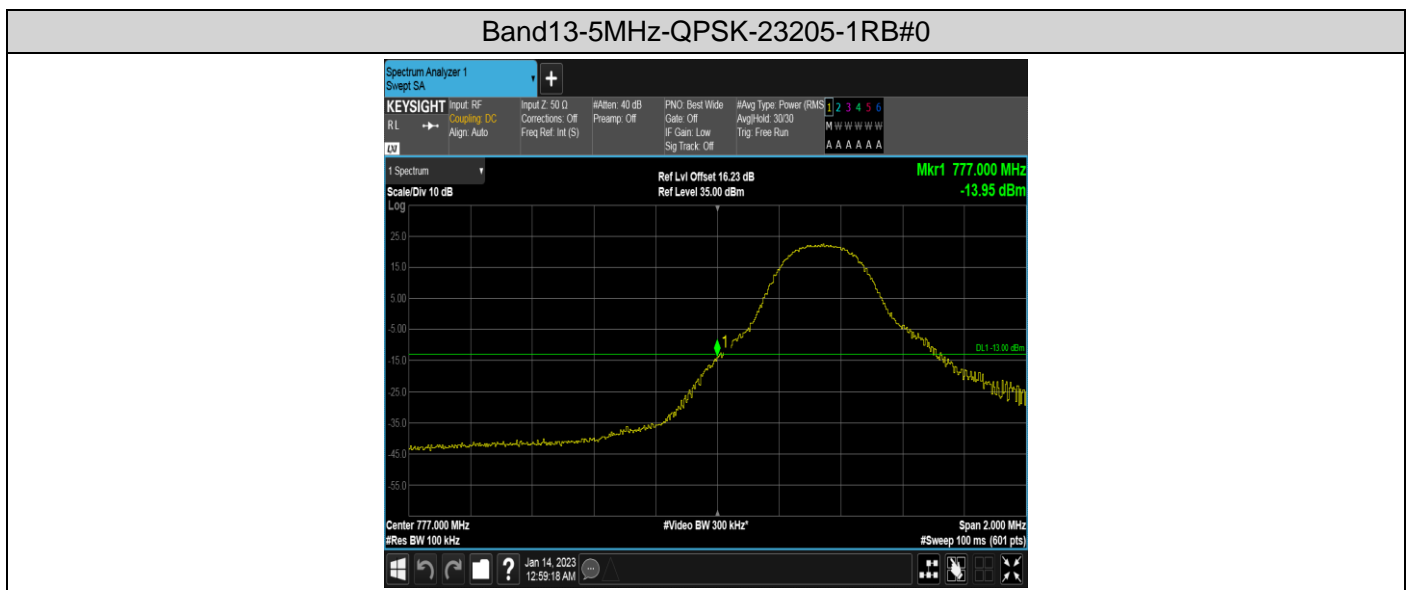
