Band12-3MHz-QPSK-23025-1RB#0

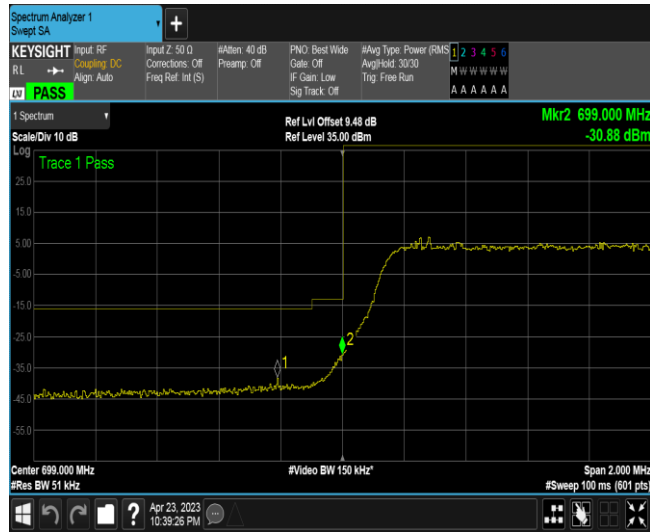

Band12-3MHz-16QAM-23165-1RB#14

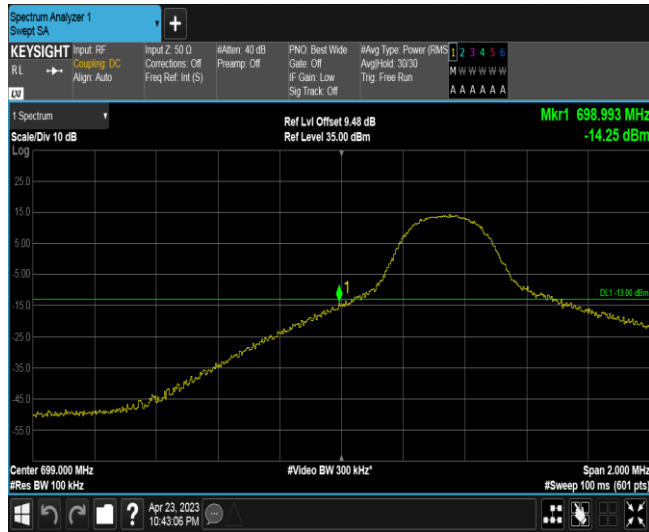

Band12-5MHz-16QAM-23035-25RB#0

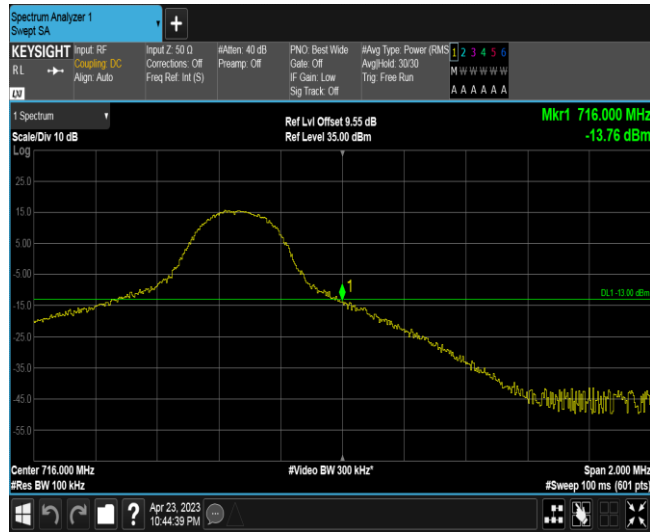

Band12-10MHz-QPSK-23060-1RB#49

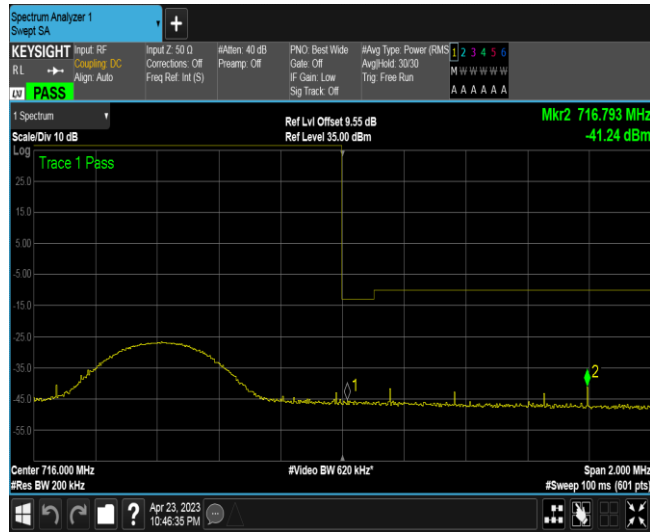

Band12-10MHz-16QAM-23060-1RB#0

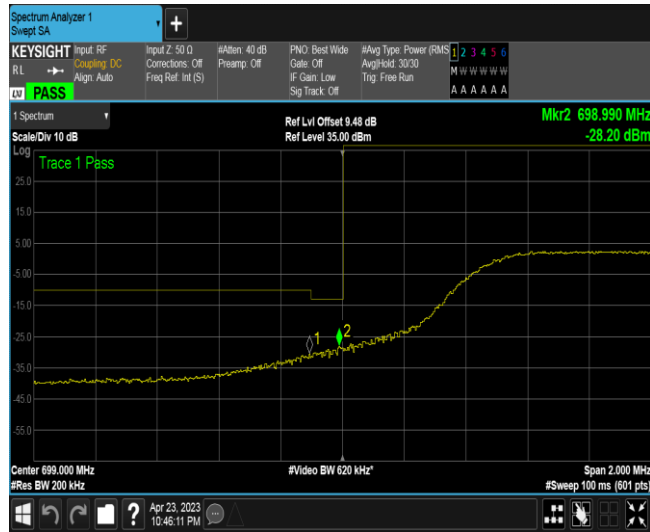
