Band26-1.4MHz-16QAM-27033-1RB#0-Range2:1000~10000MHz

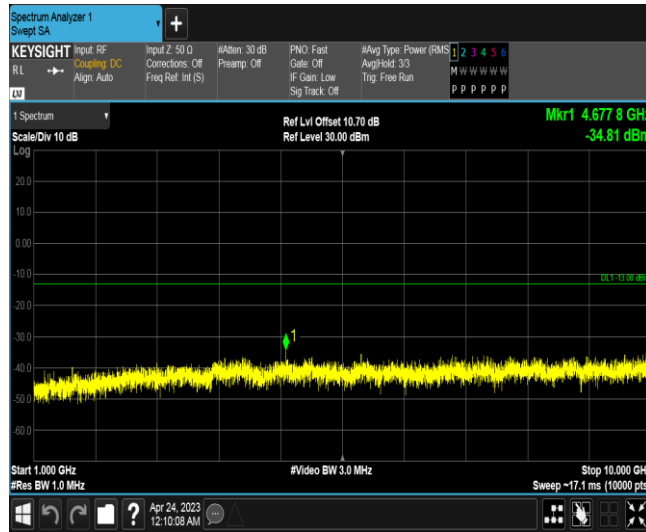


Band26-3MHz-QPSK-26805-1RB#0-Range1:30~1000MHz

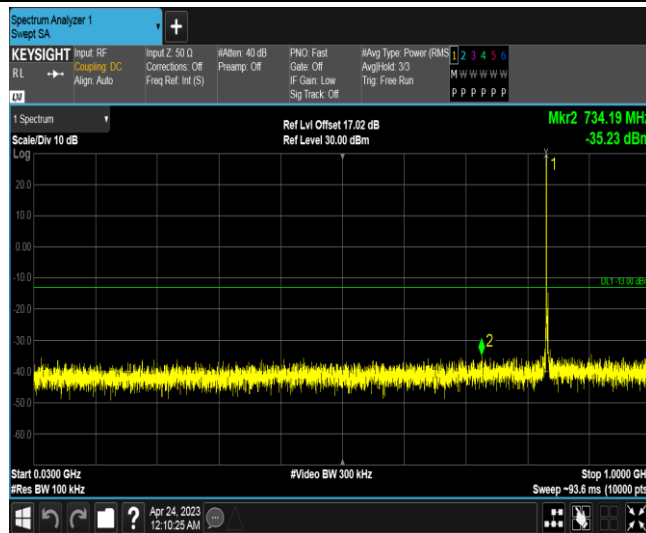

Band26-3MHz-16QAM-26915-1RB#0-Range2:1000~10000MHz

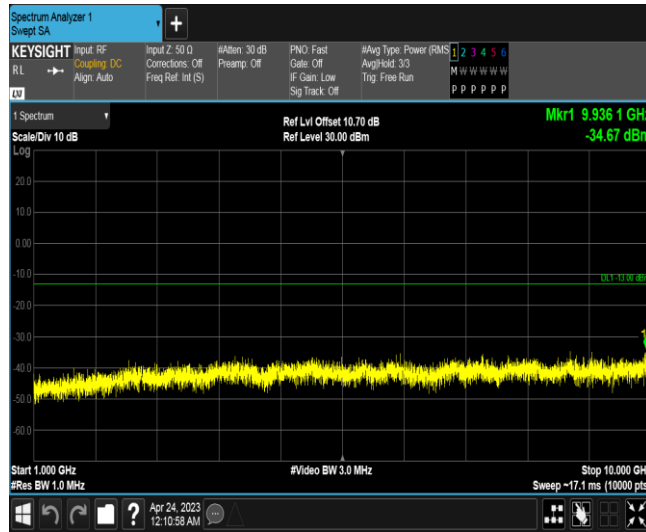

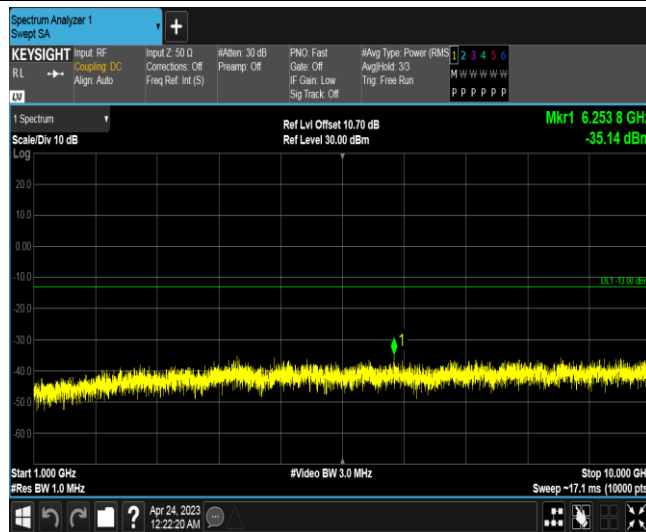




Band26-5MHz-QPSK-26915-1RB#0-Range1:30~1000MHz

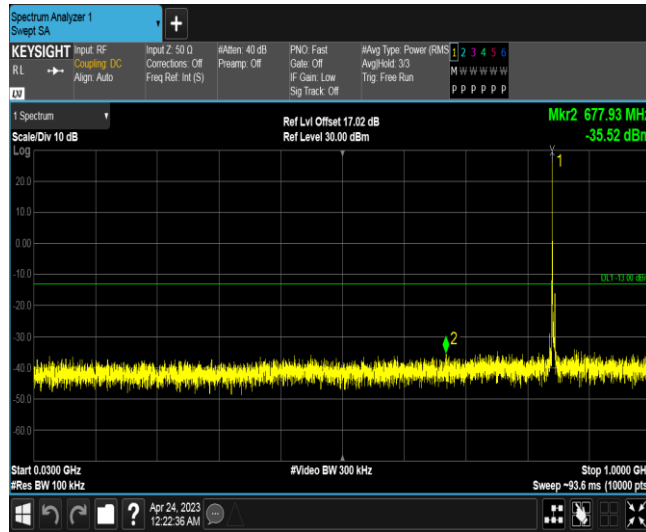

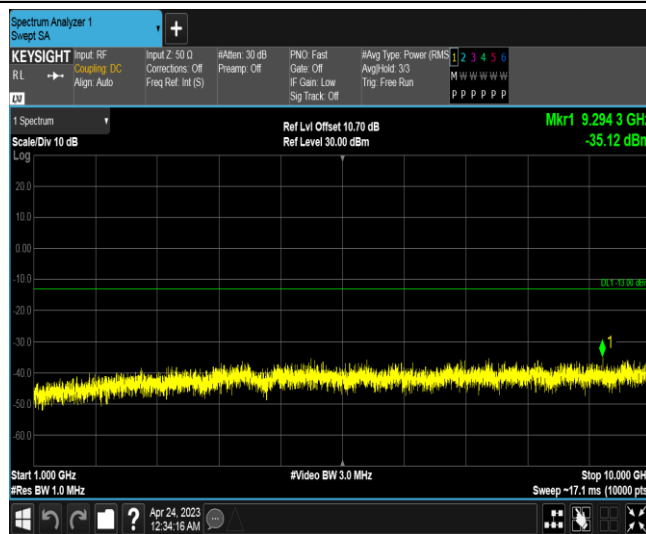




Band26-10MHz-16QAM-26990-1RB#0-Range1:30~1000MHz

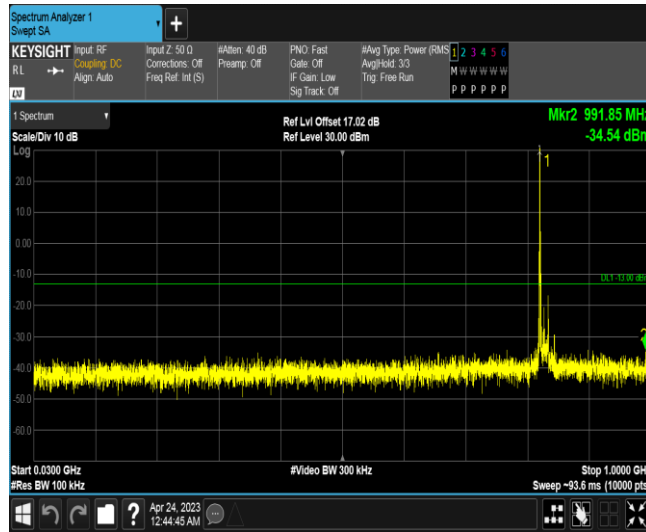

Band26-15MHz-QPSK-26915-1RB#0-Range2:1000~10000MHz

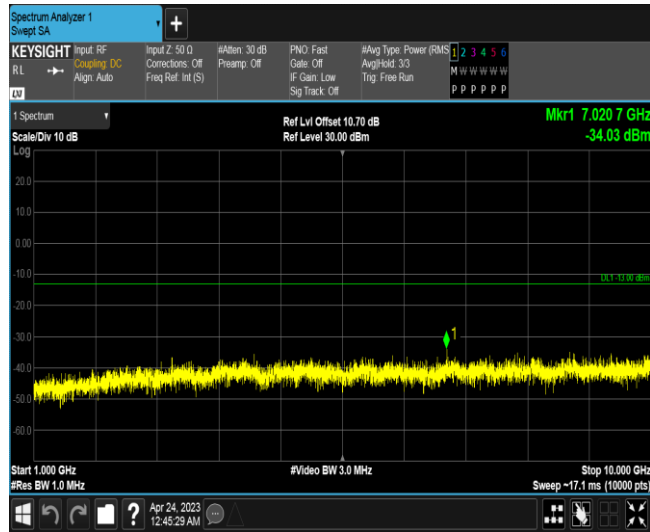
