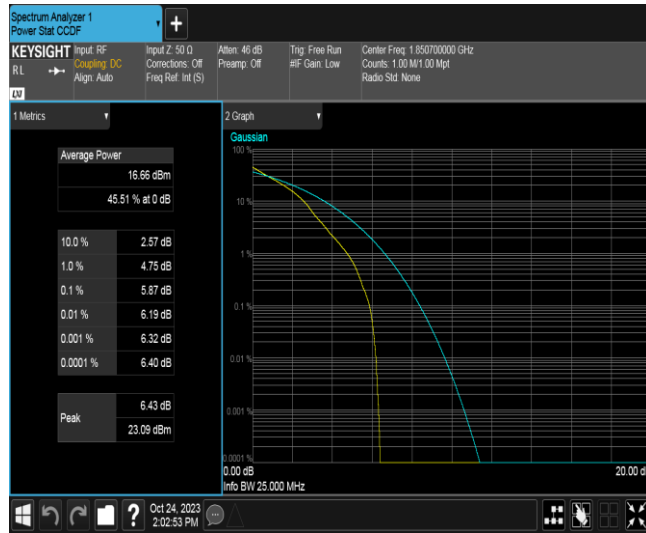

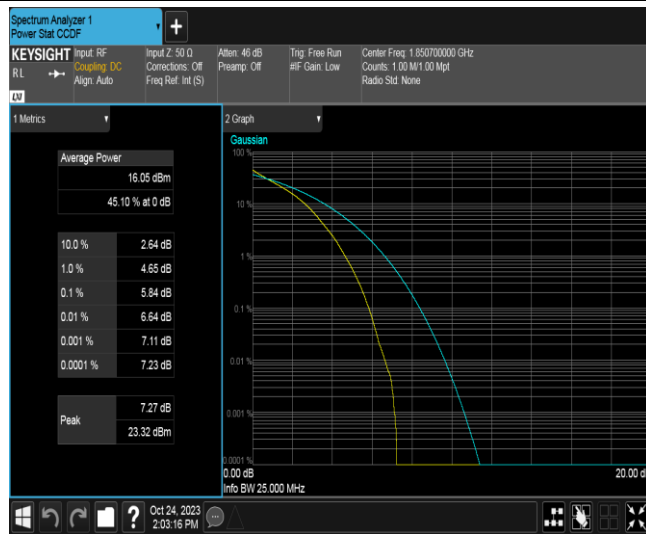

Band2-1.4MHz-QPSK-18607-6RB#0

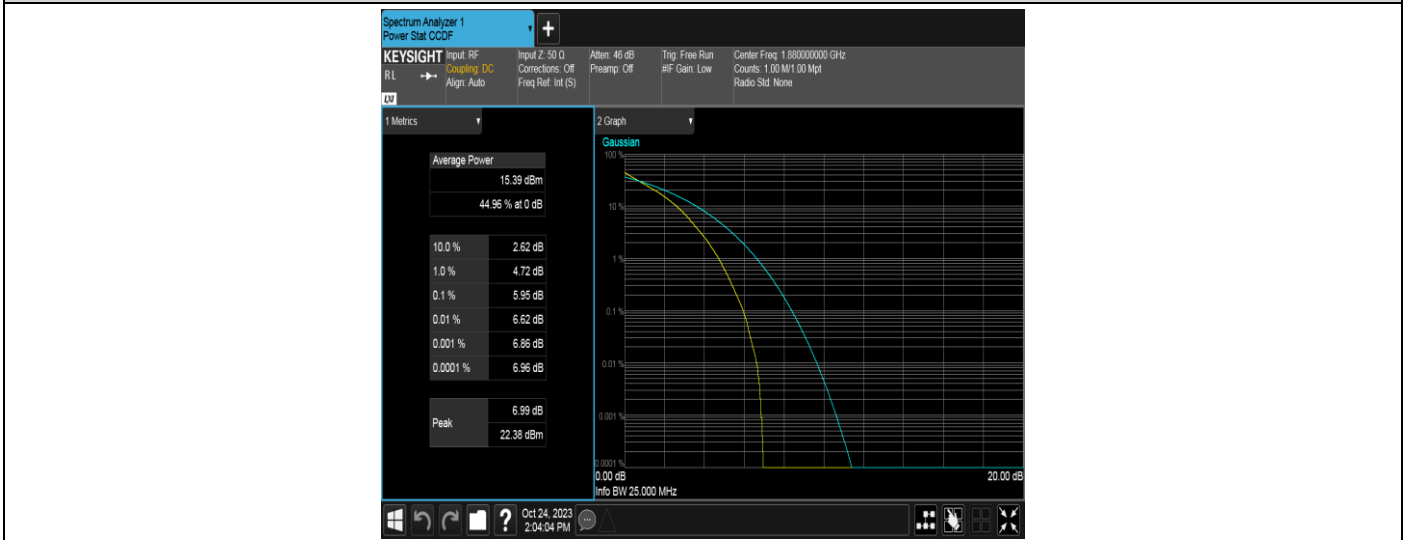
