Band2-1.4MHz-16QAM-18607-6RB#0

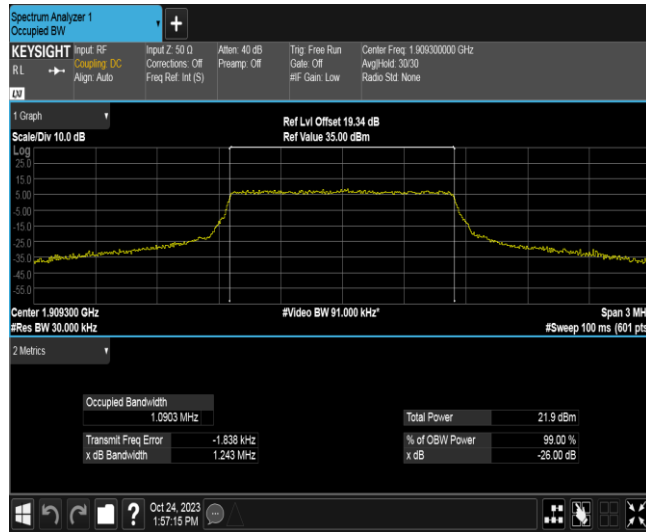
