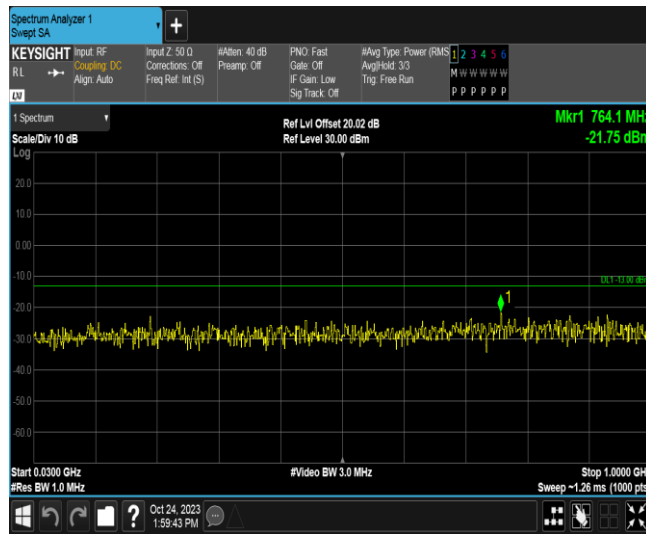

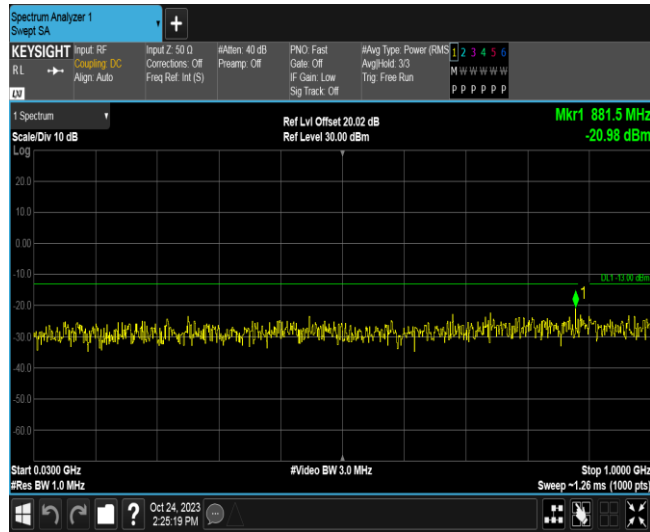


Band2-5MHz-QPSK-19175-1RB#0-Range2:1000~20000MHz

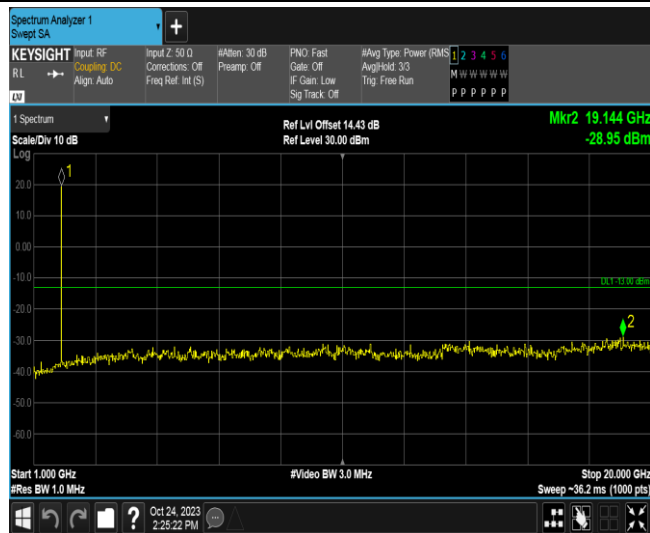

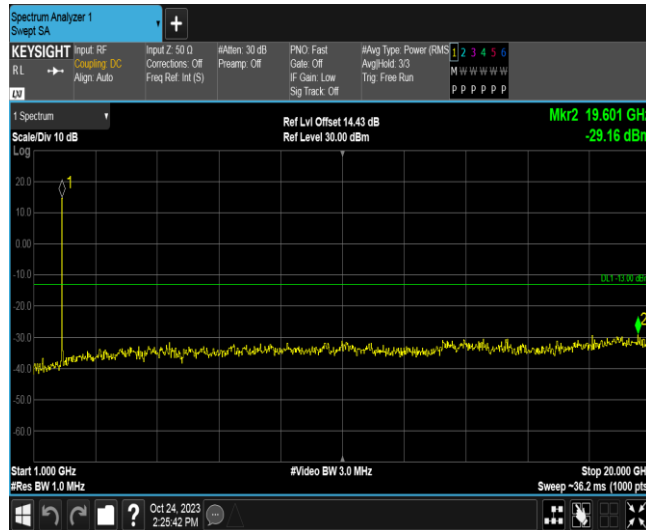

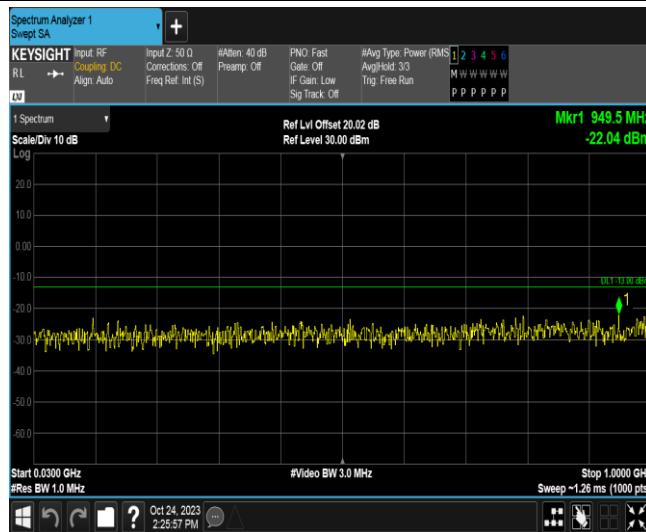
