Band12-1.4MHz-16QAM-23017-1RB#5

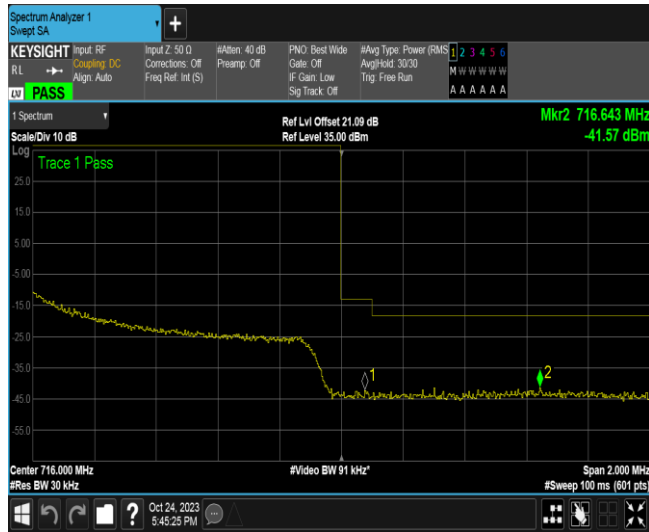
