Plug the large connector into a USB power source such as the USB port on a computer, or a <b>5V USB wall adapter</b> (not included).</div> <div>The charging case's LED at the bottom will blink RED while charging. The LED will be solid RED when the case is fully charged.</div> <div>Charging the Earbuds</div> <div>Make sure the case is charged.</div> <div>To charge the earbuds, place them in the correct ports in the case. They will automatically begin charging. The earbud LED indicators will be solid RED while charging then turn OFF when fully charged.</div> <div>On low power, a tone will be heard from the earbuds, indicating charging is required.</div> <div>Powering ON/OFF</div> <div><ul style="list-style-type: none"><li>The earbuds will automatically power ON when removed from the case. The earbud LED indicators will flash RED and White, then turn OFF when the earbuds are placed into the case.</li><li>The earbuds can also be powered ON/OFF by <b>pressing + holding (appx. 5s)</b> the Multi buttons.</li><li>When powered ON, the earbuds will automatically pair with one another.
