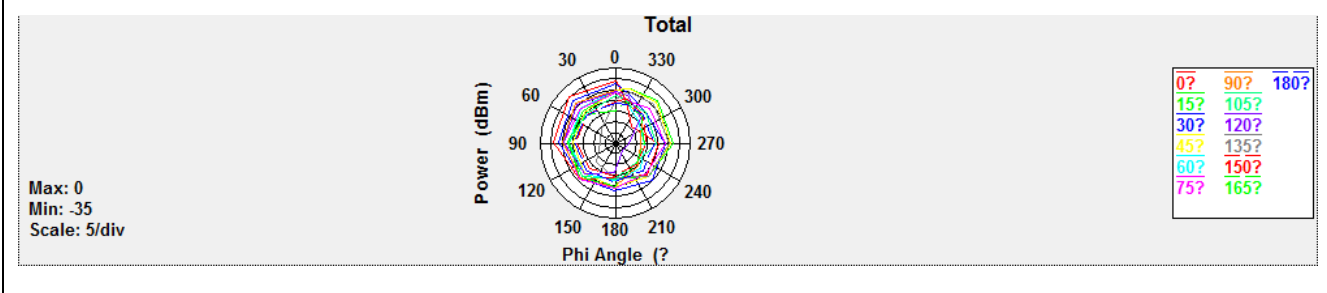

2D POLAR RADIATION PATTERN

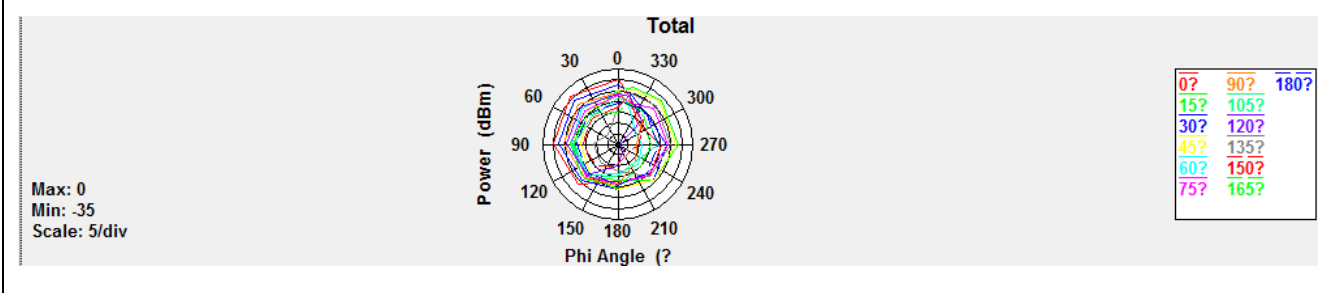

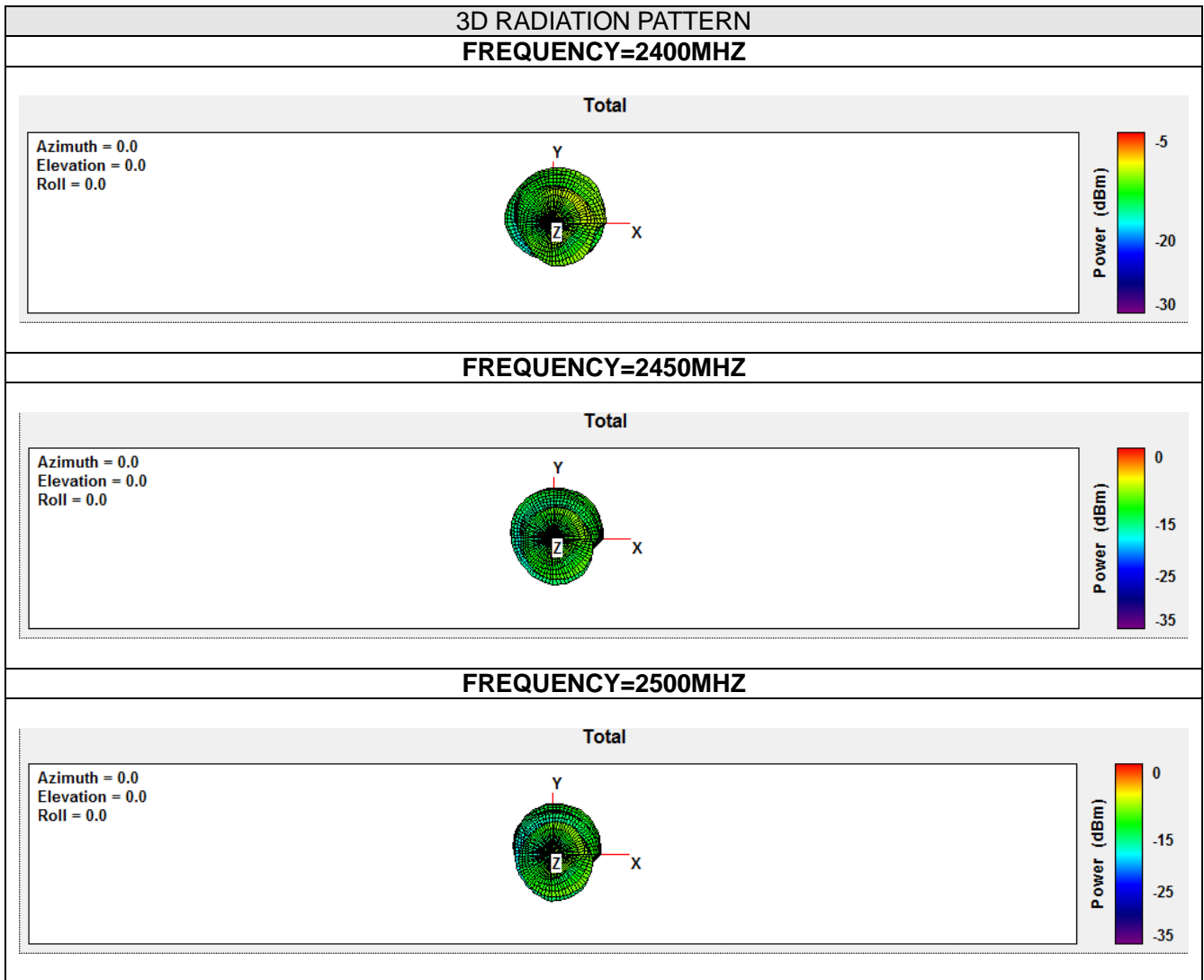
FREQUENCY=2450MHZ



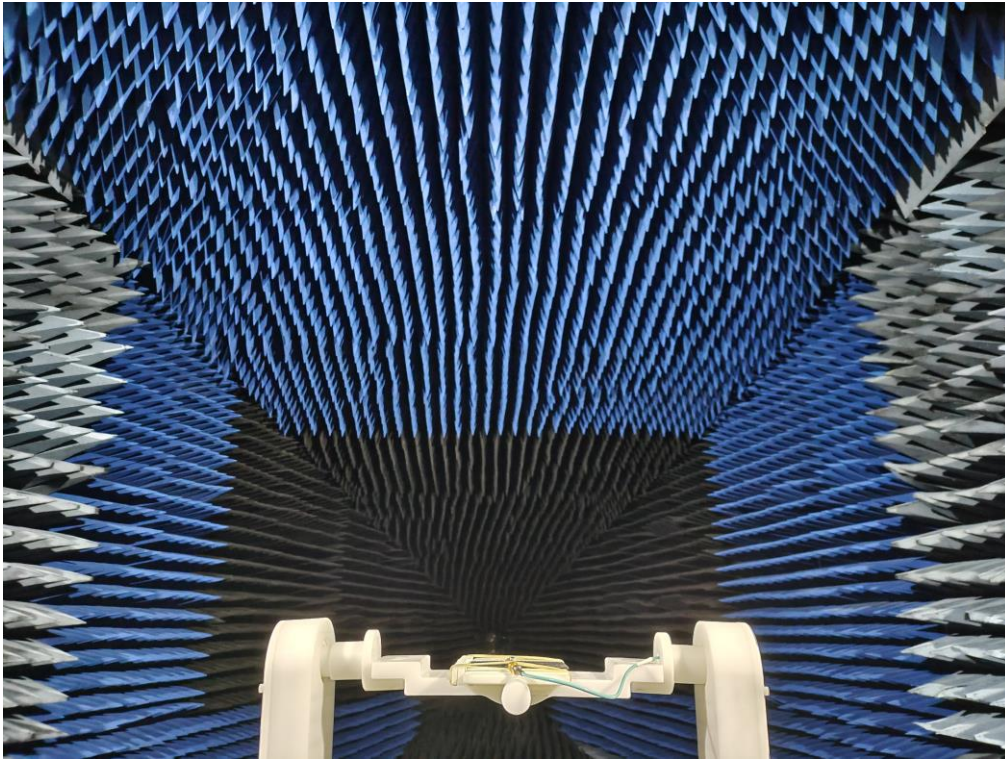
FREQUENCY=2500MHZ

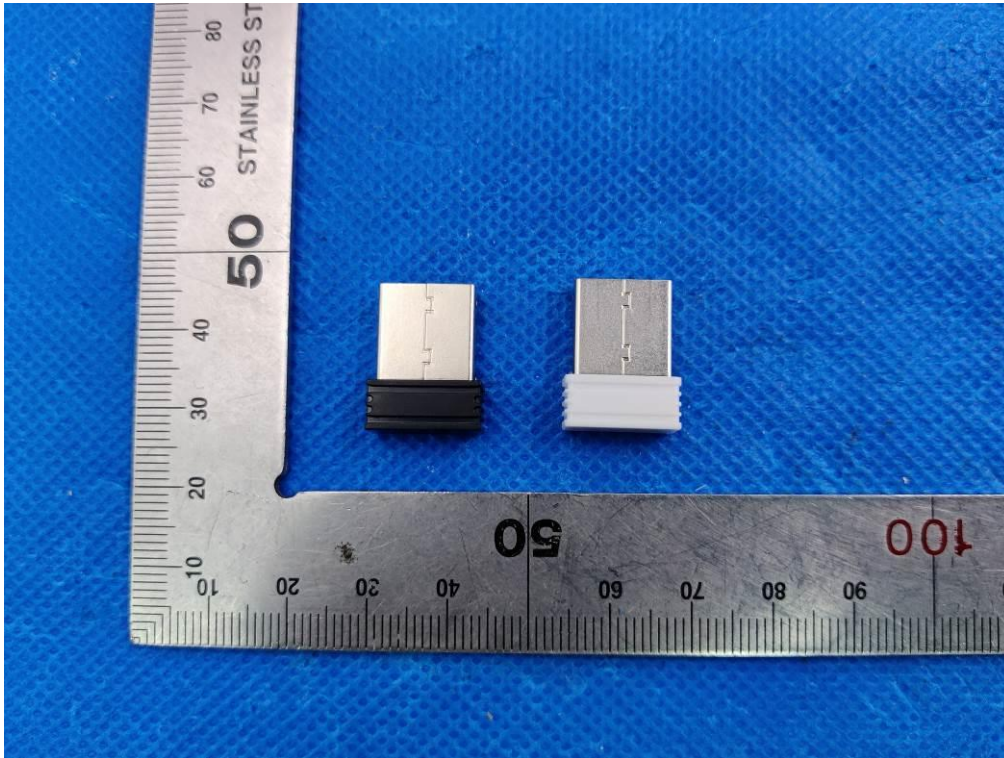

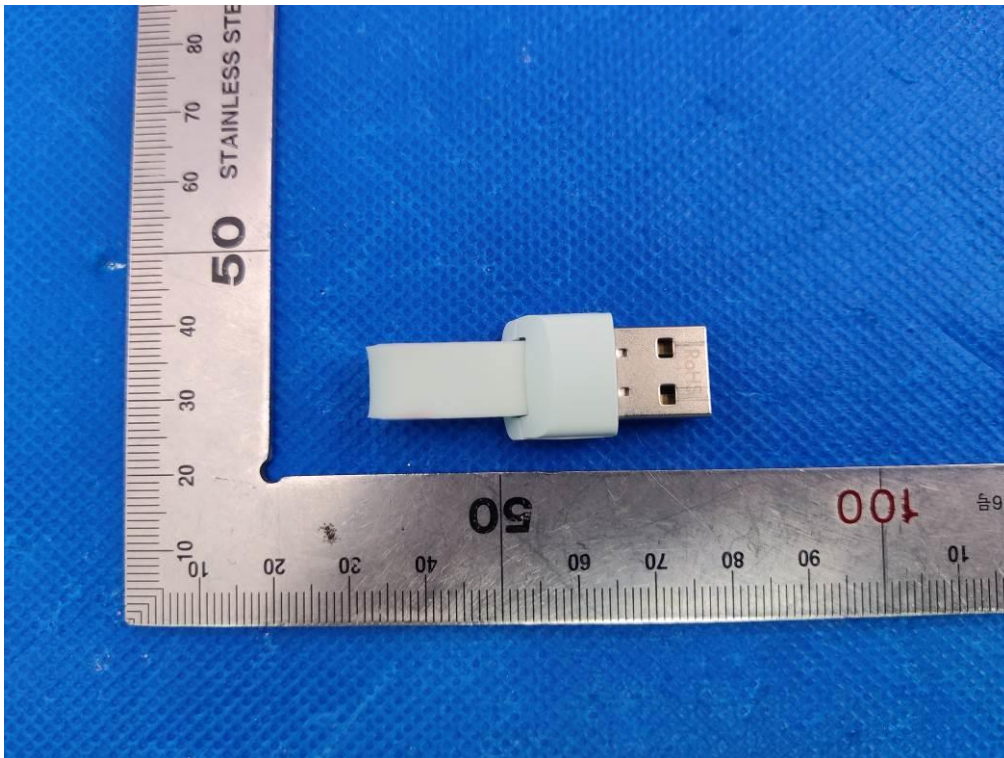

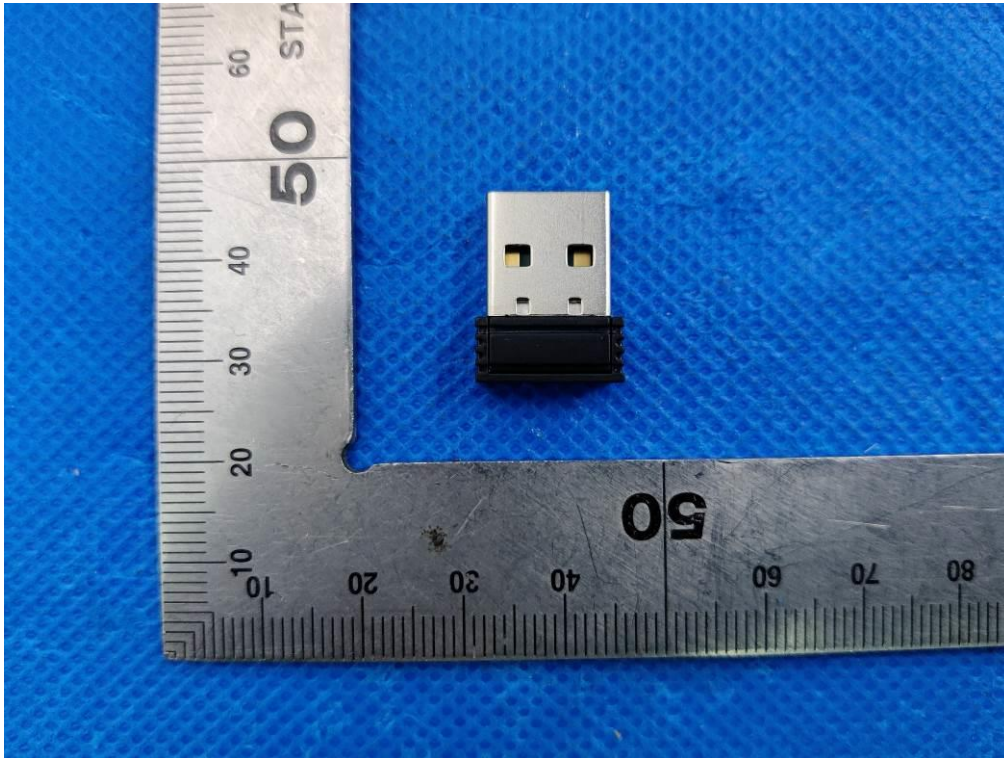


All VIEW OF EUT-2

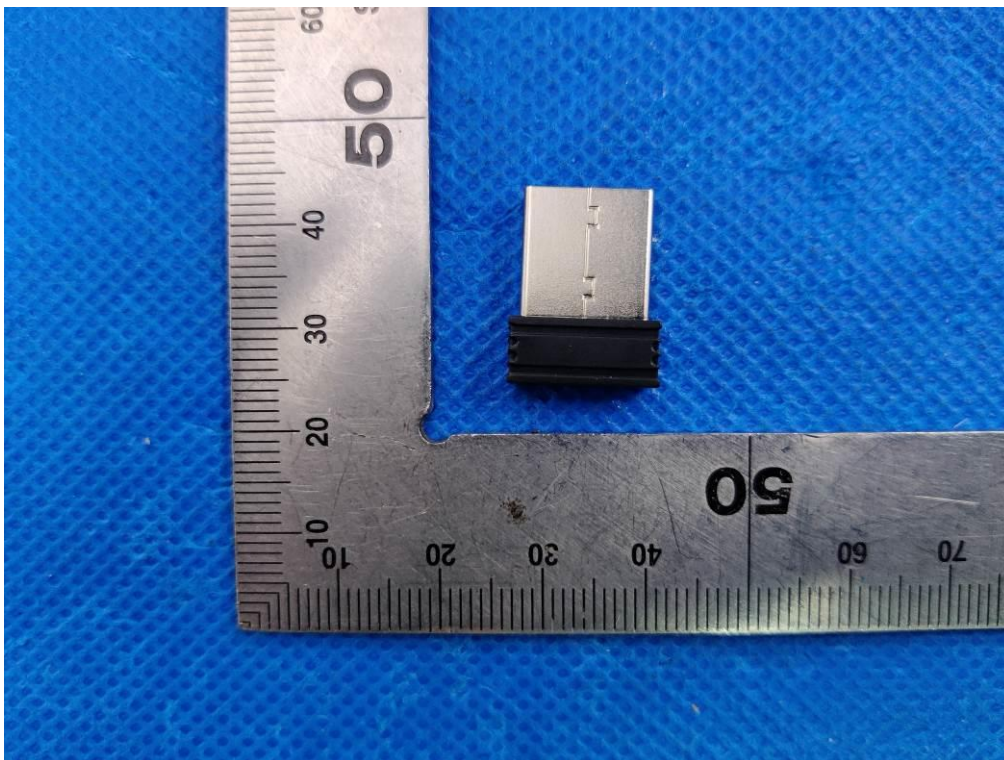

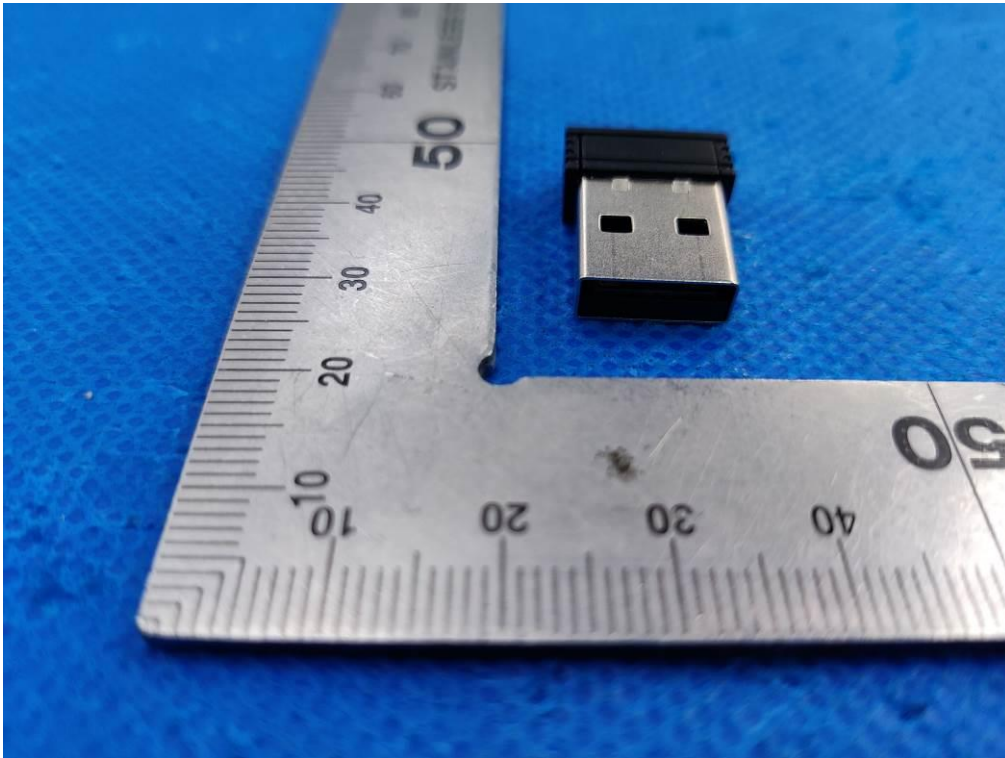


BOTTOM VIEW OF EUT

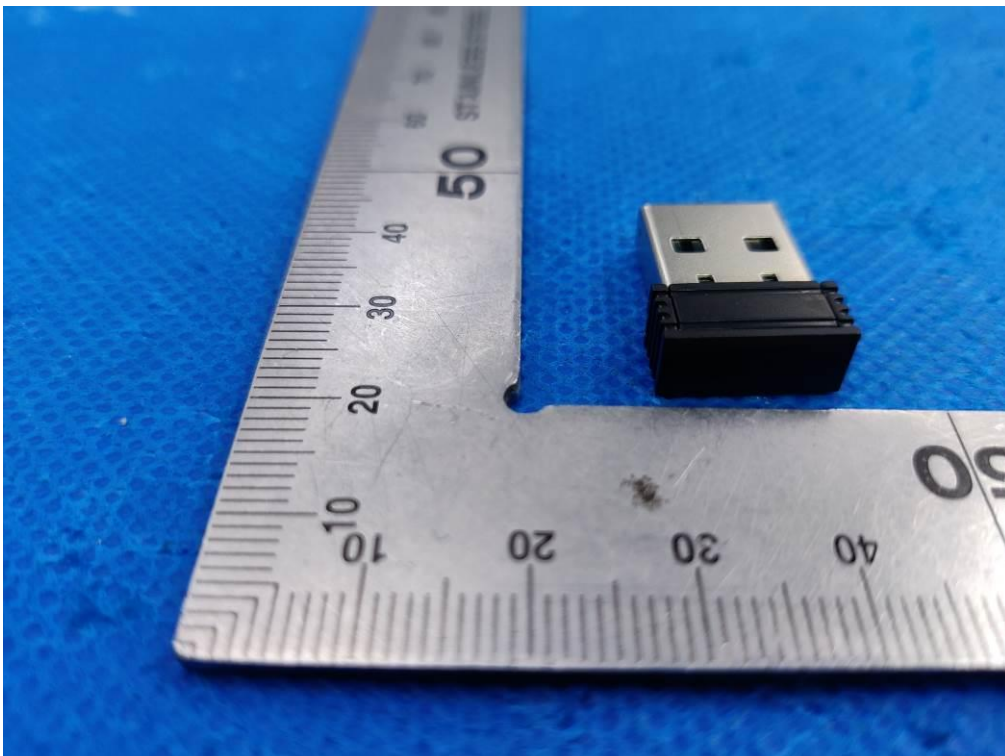

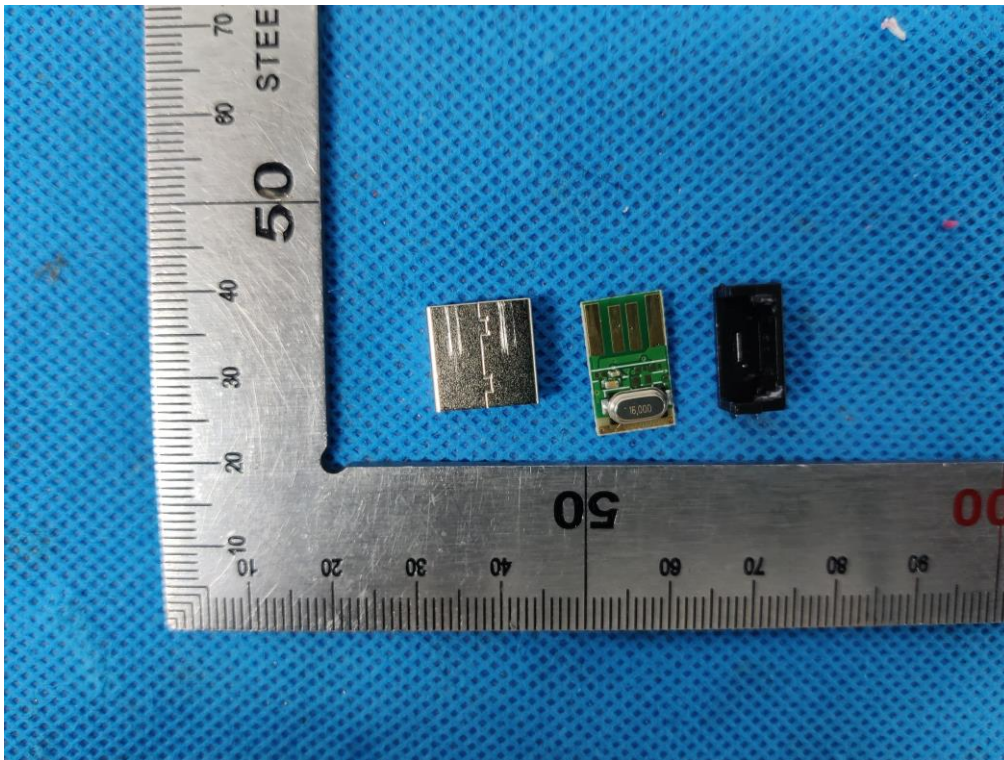


RIGHT VIEW OF EUT

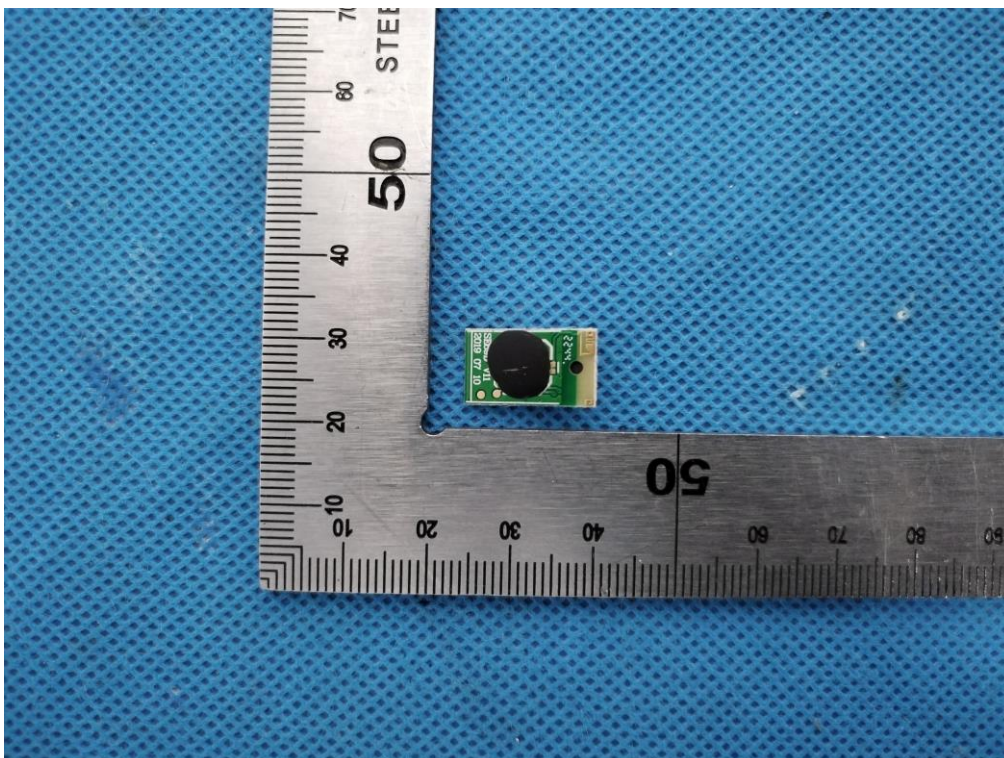

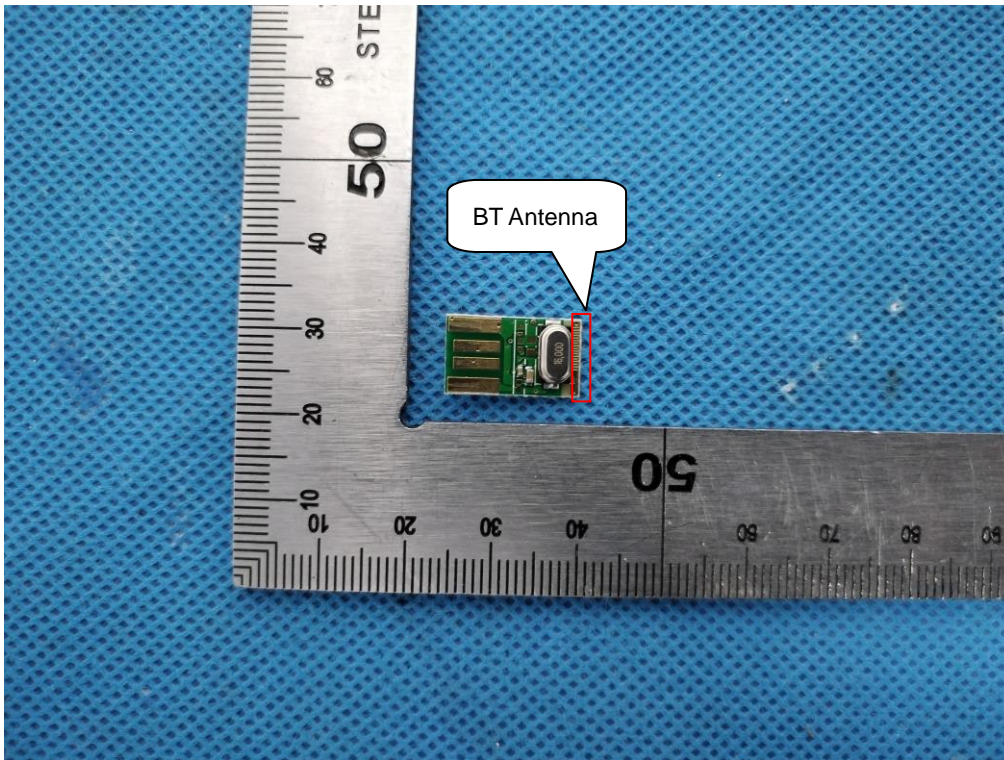


INTERNAL VIEW OF EUT-1

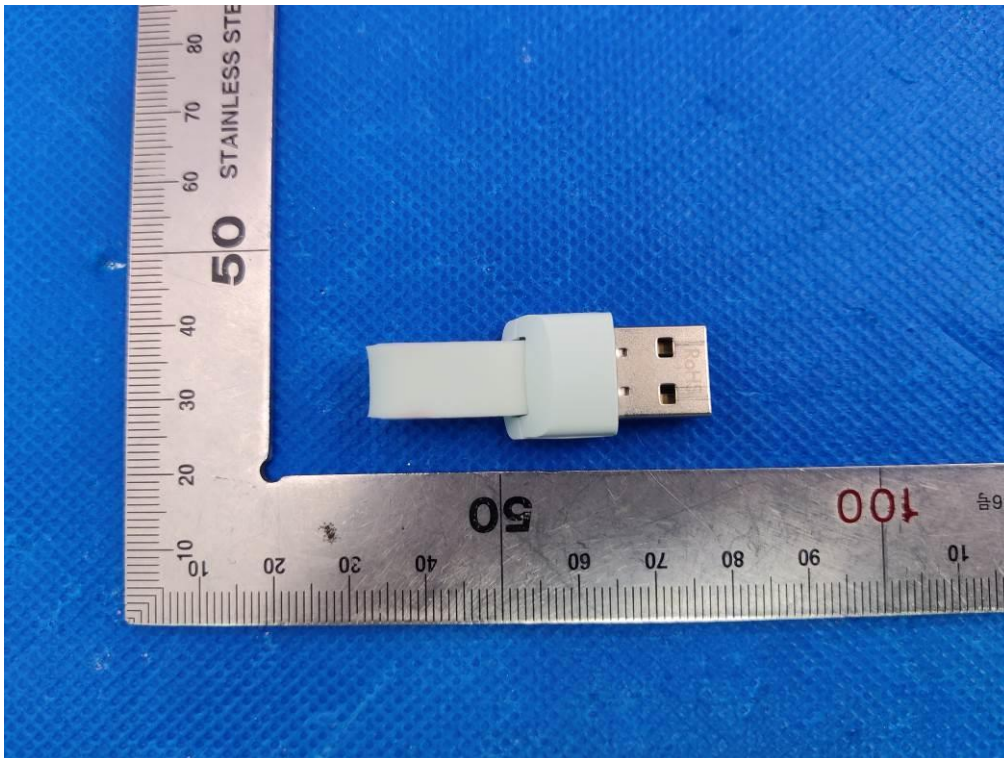

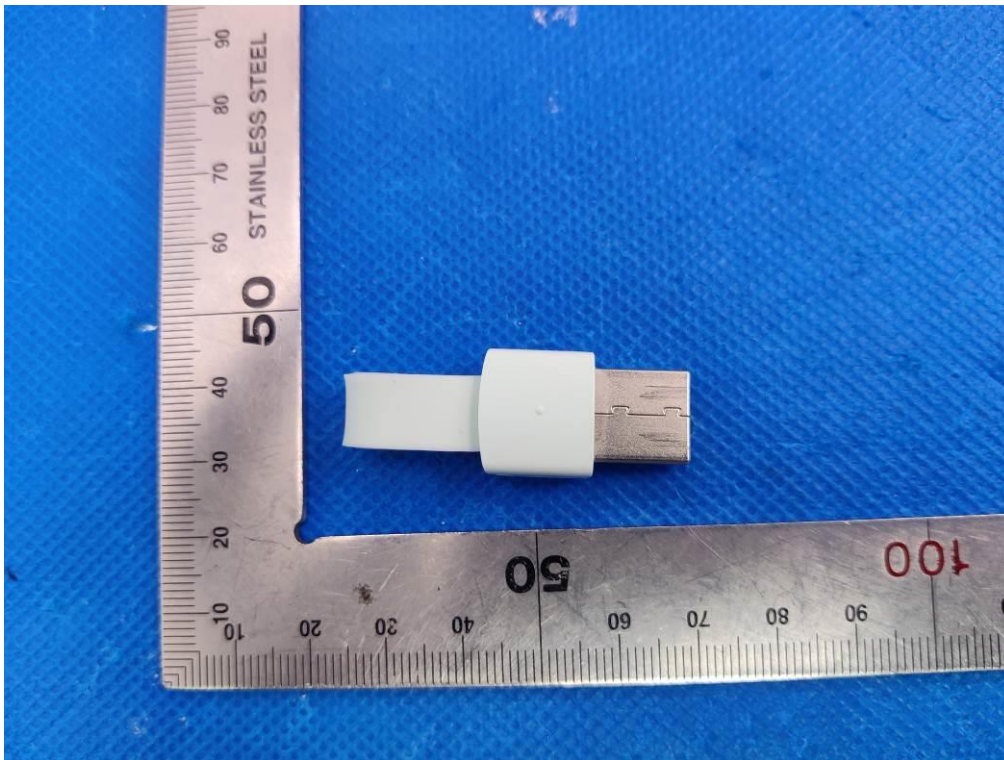


TOP VIEW OF EUT

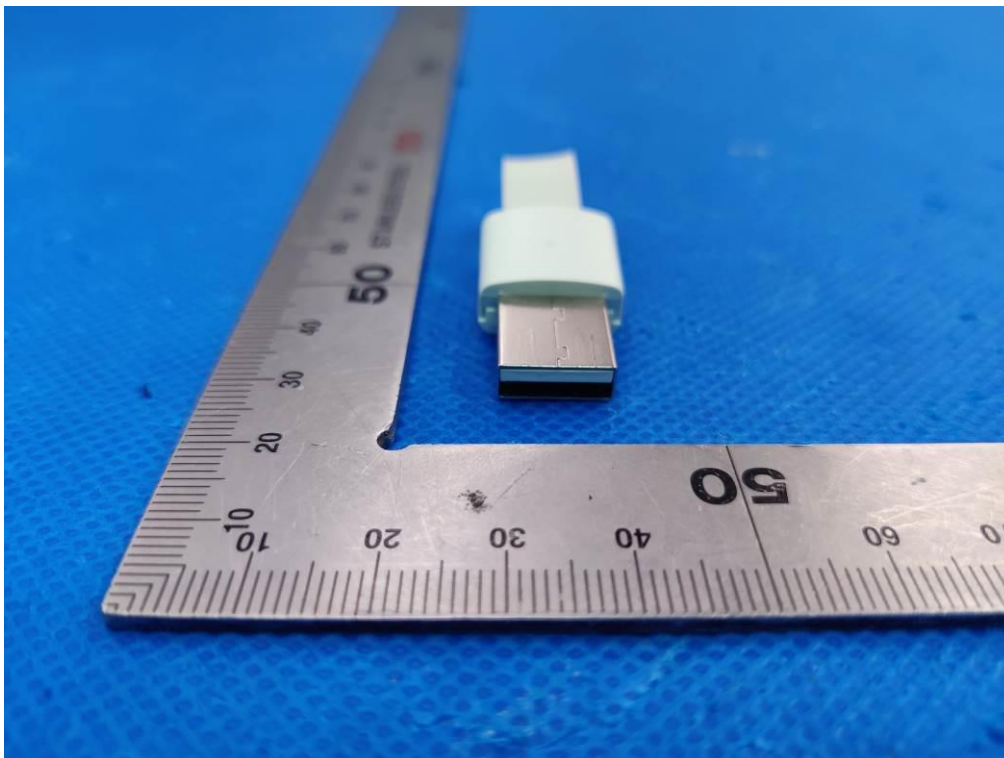

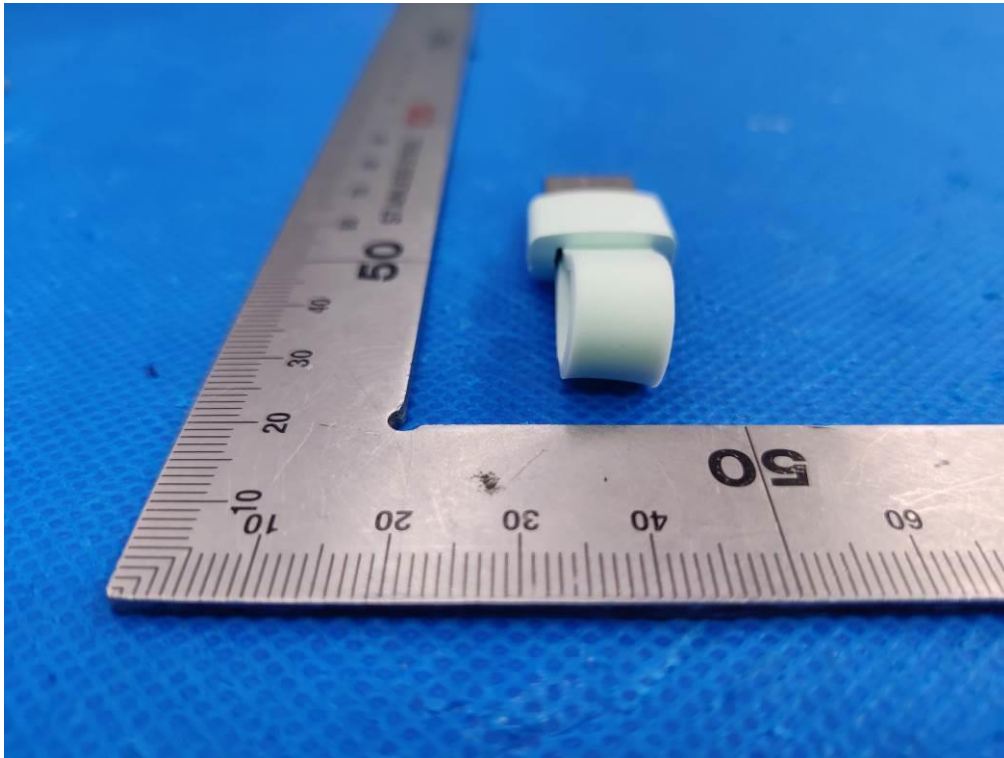


FRONT VIEW OF EUT

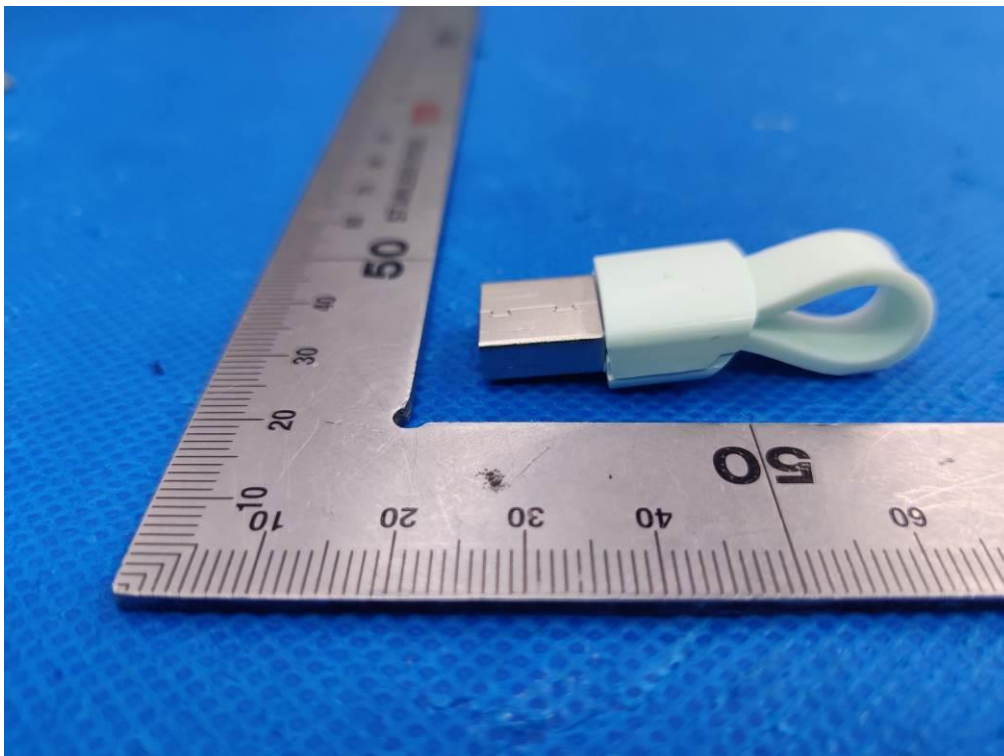

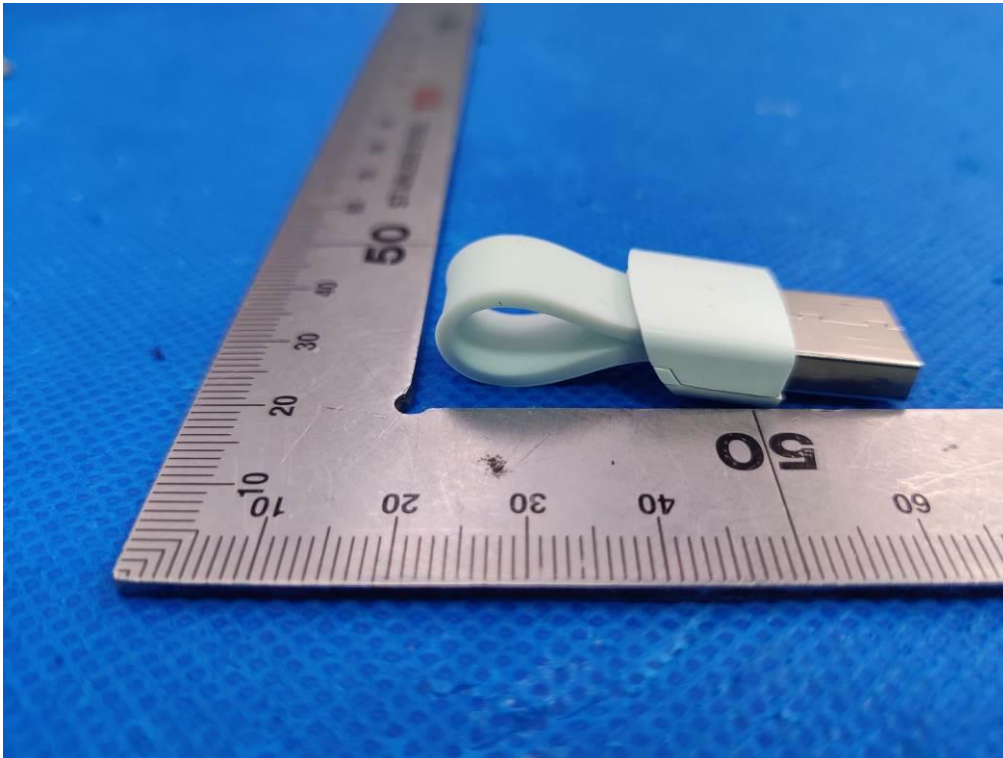


LEFT VIEW OF EUT

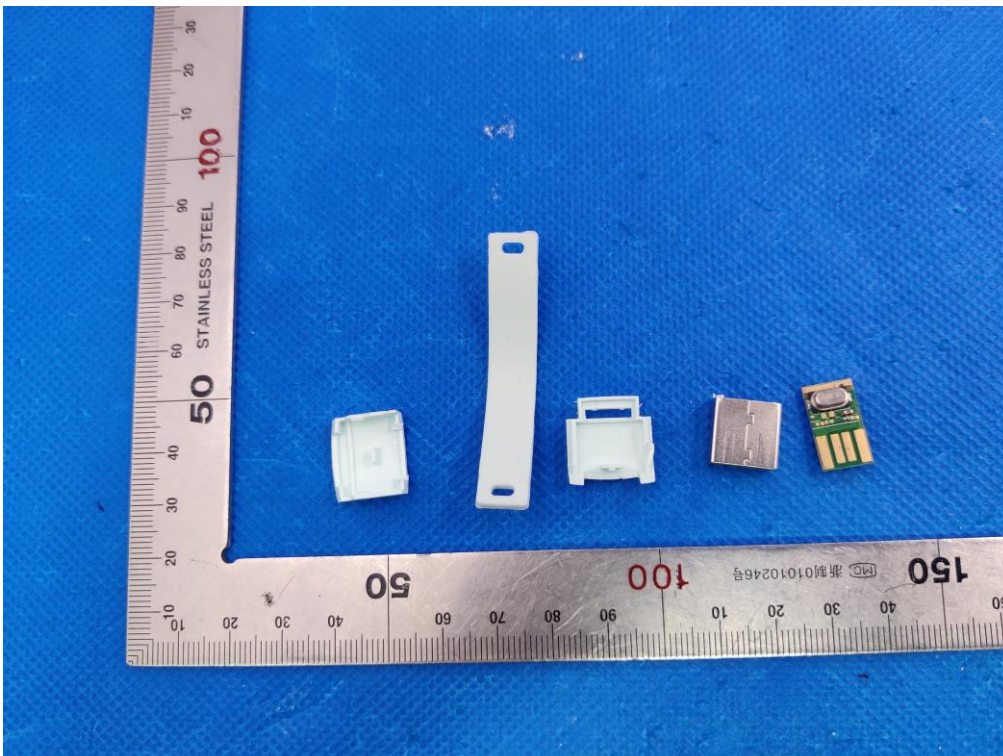

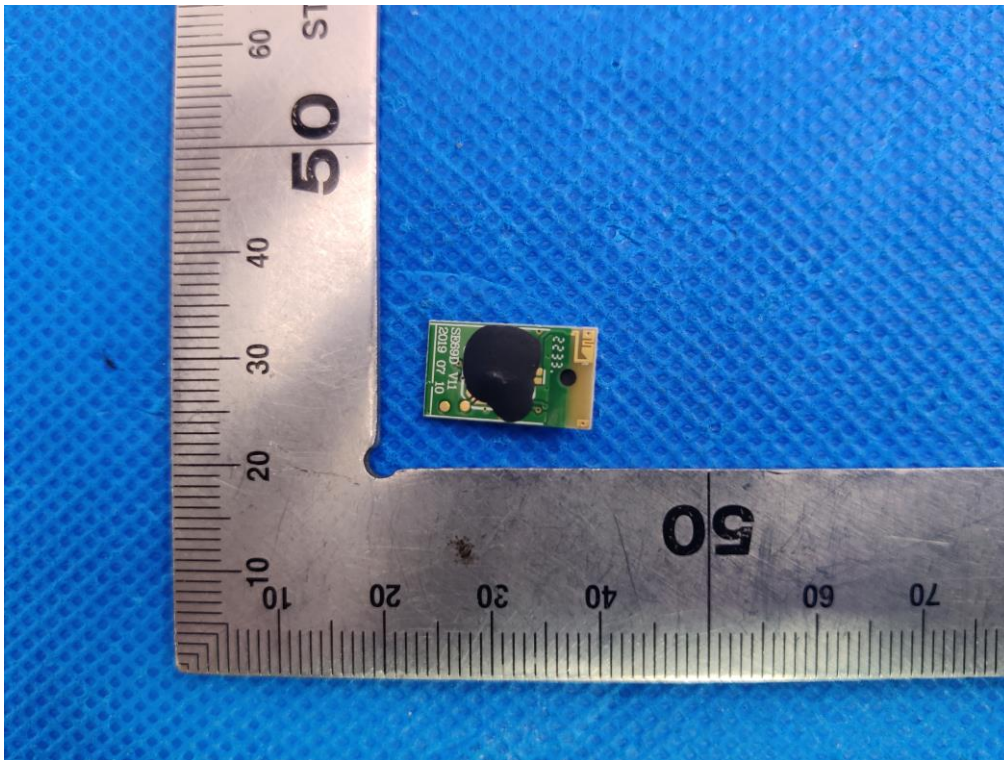

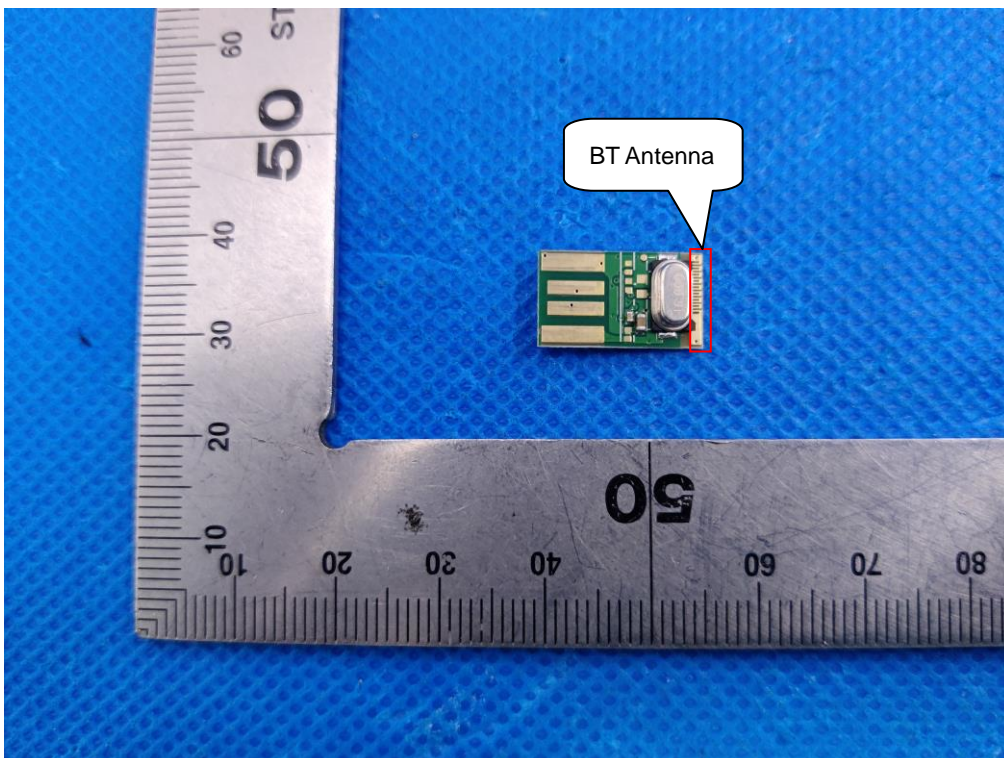
