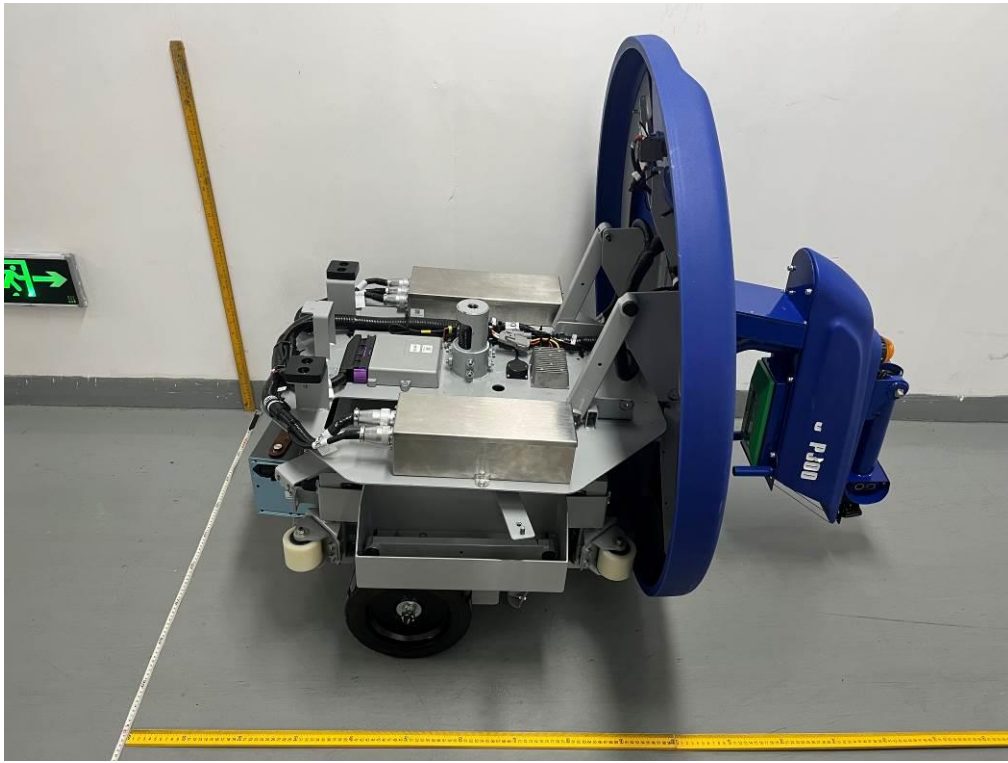

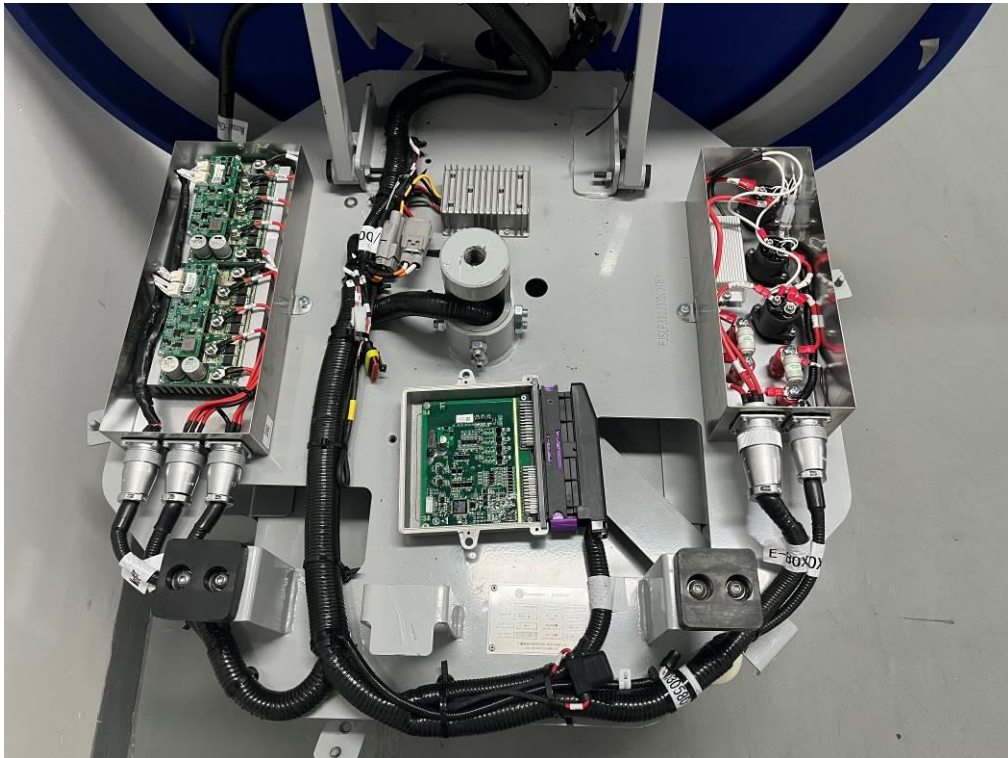

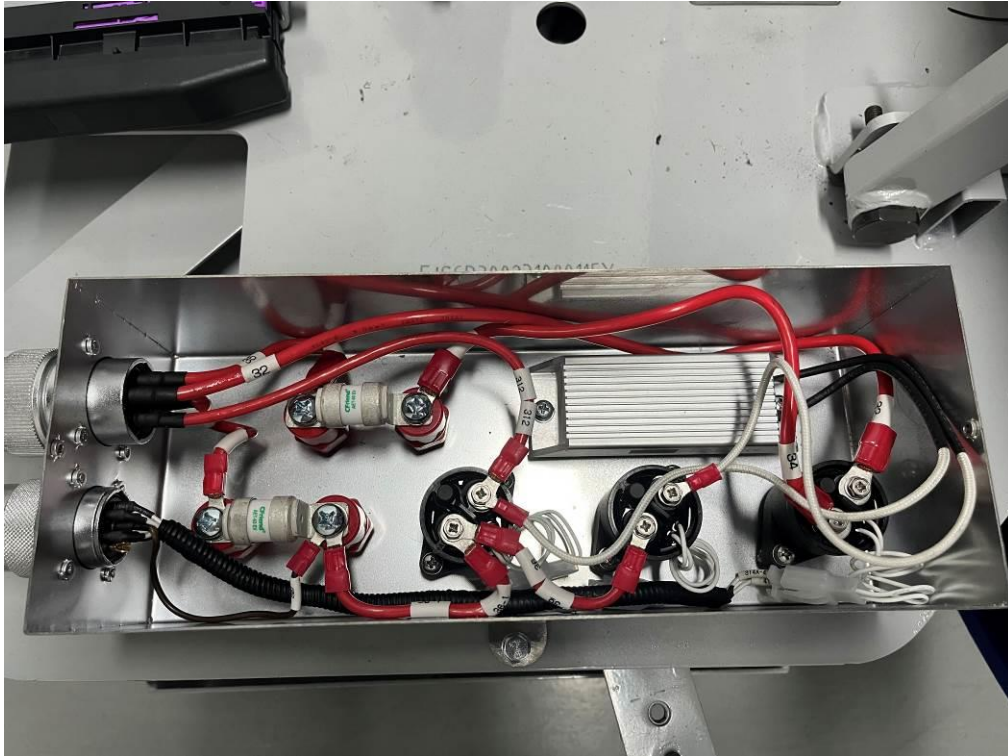
OPEN VIEW OF EUT (FIGURE 4)



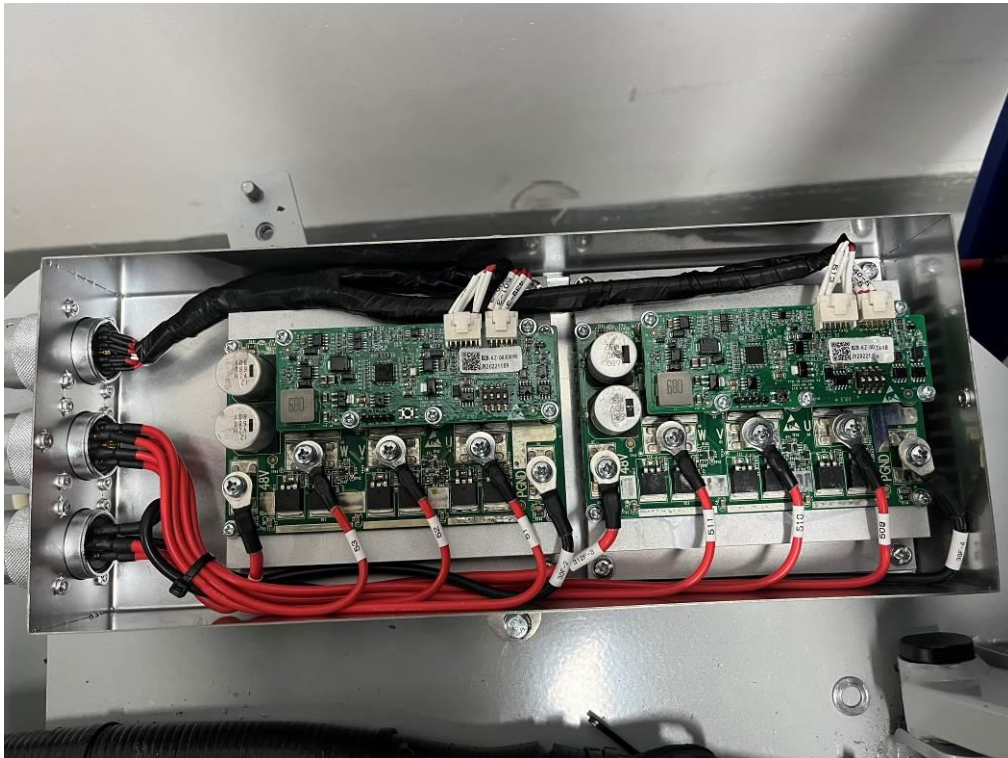

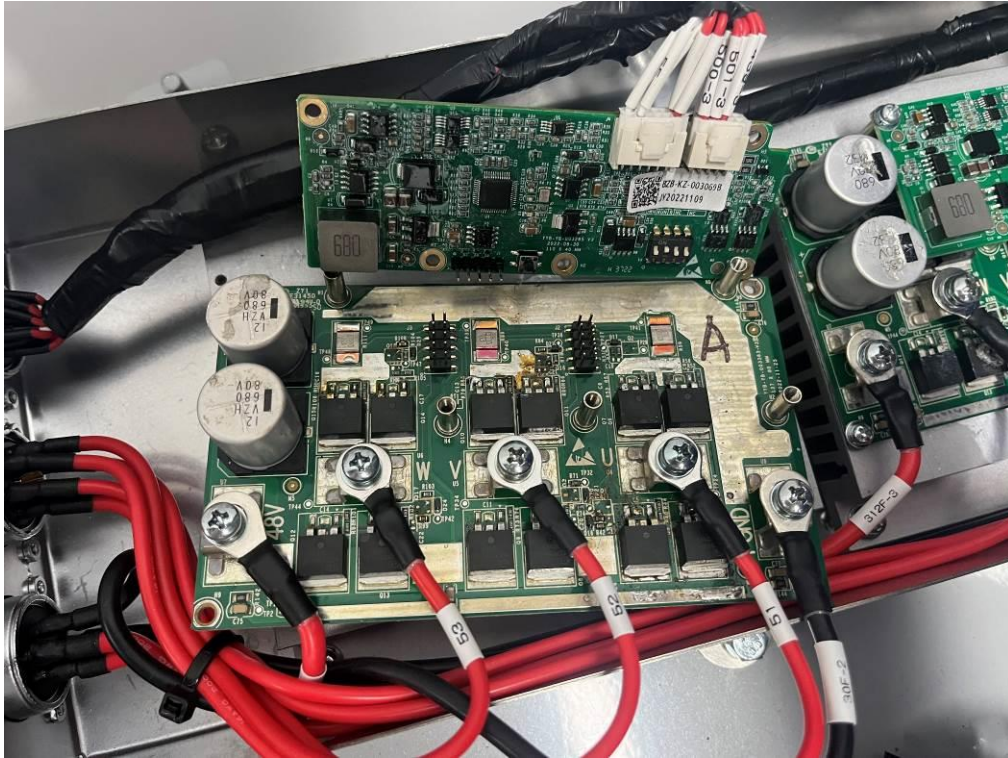

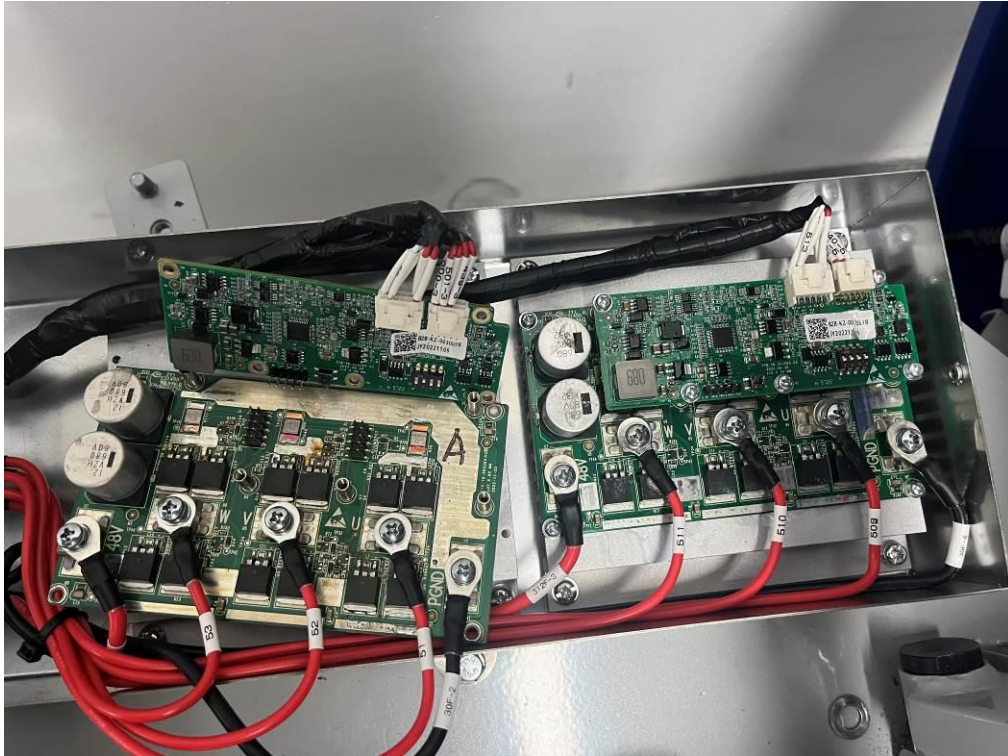

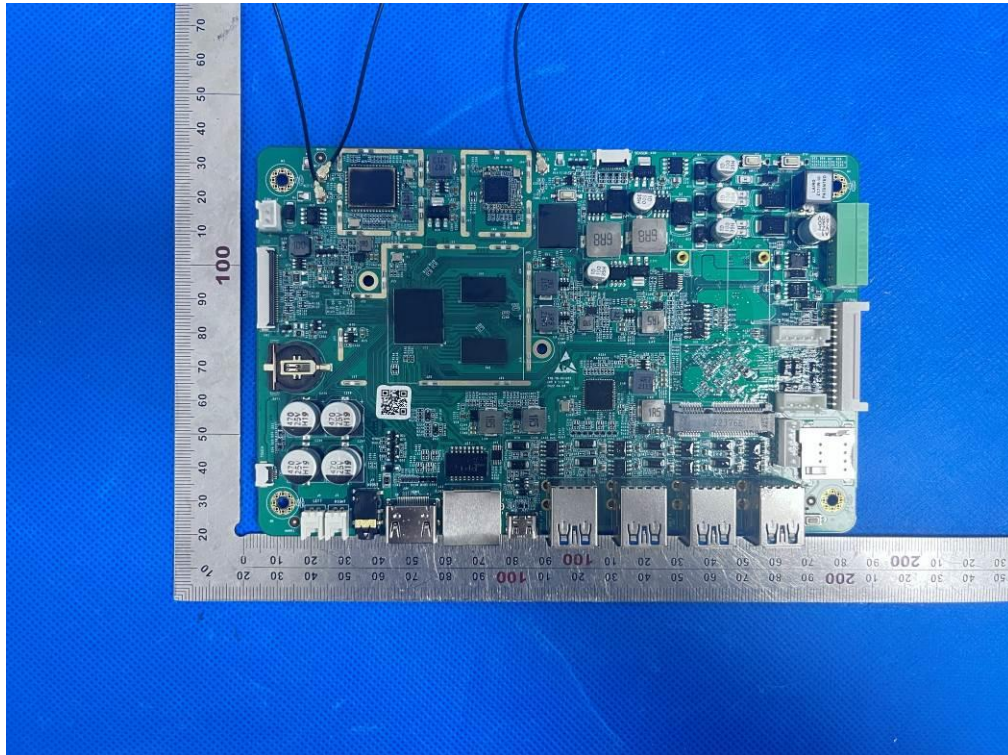

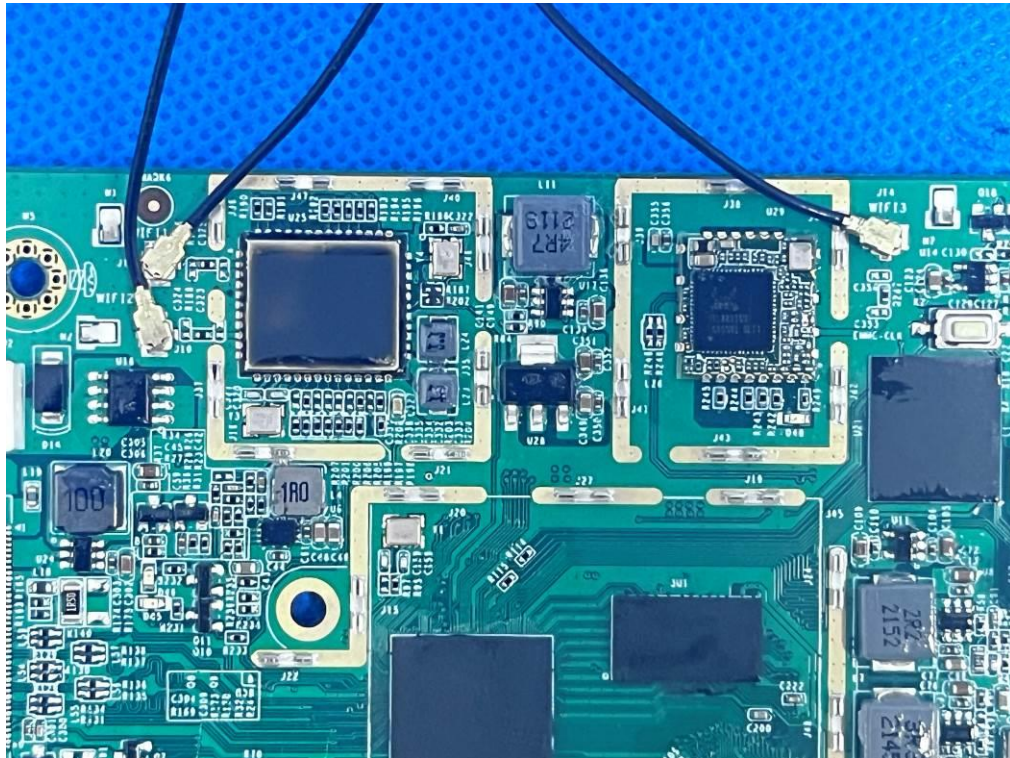

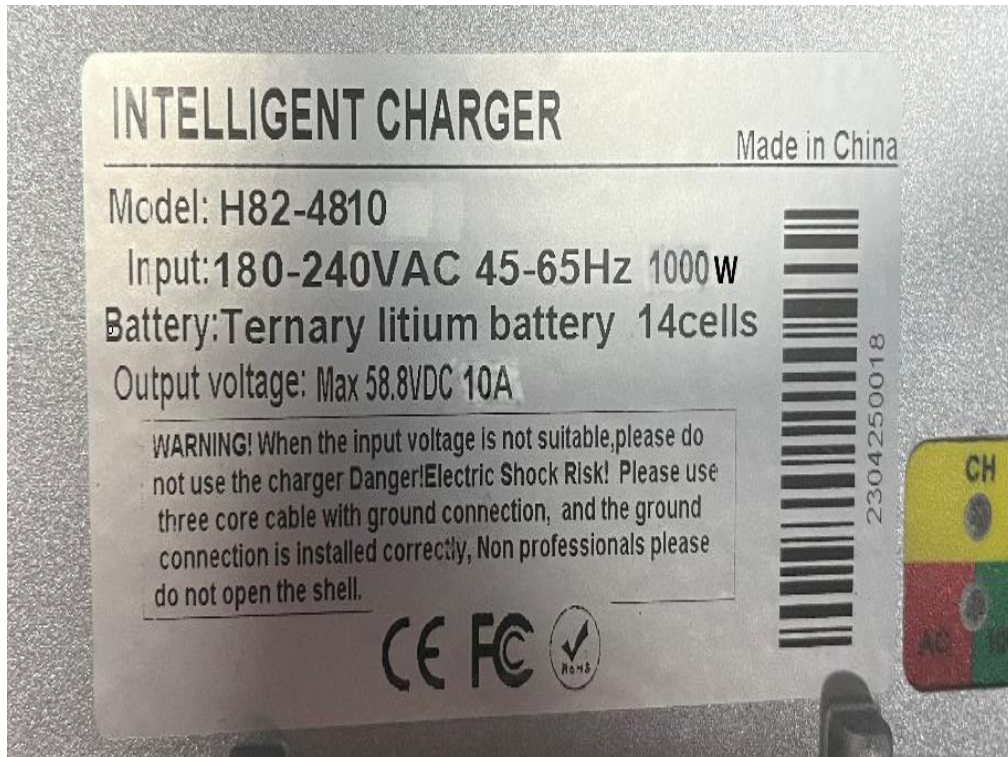
