

2.2. Test Setup



Note: Measurements should be made at 15 cm surrounding the EUT and 20cm above the top surface of the EUT.

2.3. Test Procedure

- 1) The RF exposure test was performed in anechoic chamber.
- 2) The measurement probe was placed at required test distance which is between the edge of the charger and the geometric center of probe.
- 3) The highest emission level was recorded and compared with limit as soon as measurement of each points
- (A, B, C, D, E) were completed. (A is the right, B is the back, C is the left, D is the front, and E is the top.)
- 4) The EUT was measured according to the dictates of KDB 680106 D01 v03. Remark;

The EUT's test position A, B, C, D and E is valid for the E and H field measurements.

2.4. Test Result

- 2.4.1. Equipment Approval Considerations item 5.b of KDB 680106 D01 v03.
- 1) Power transfer frequency is less that 1 MHz
- The device operate in the frequency range 110.1-205KHz.
- 2) Output power from each primary coil is less than 15 watts
 - The maximum output power of the primary coil is 10W.
