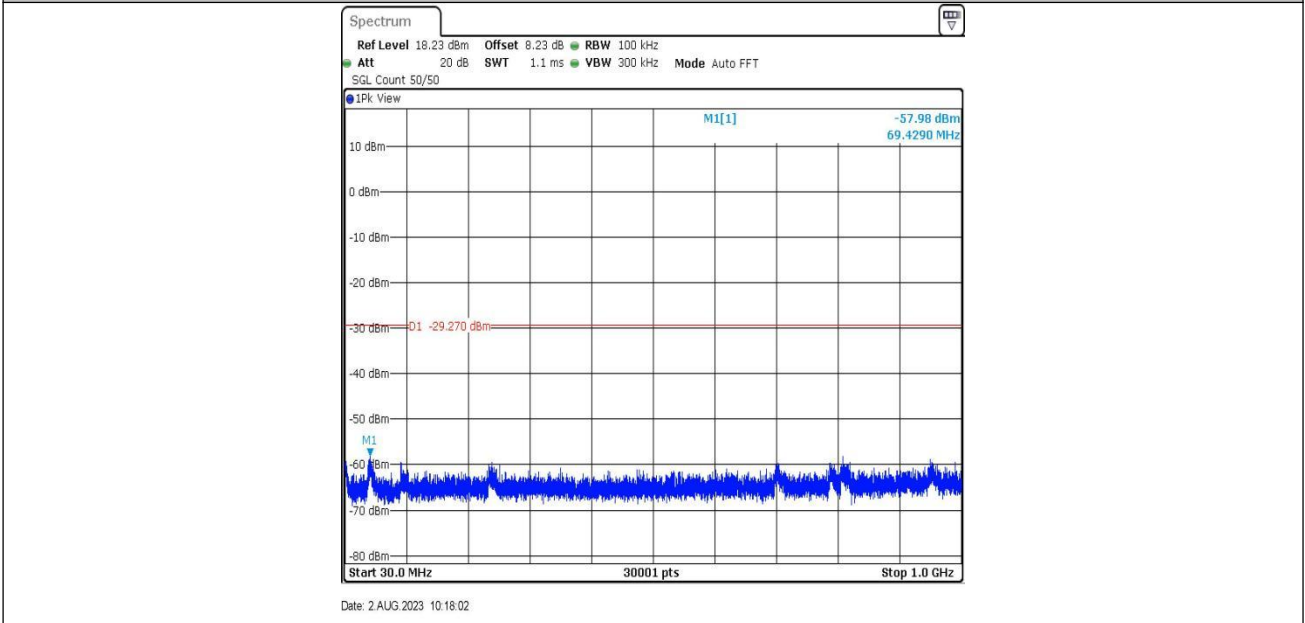
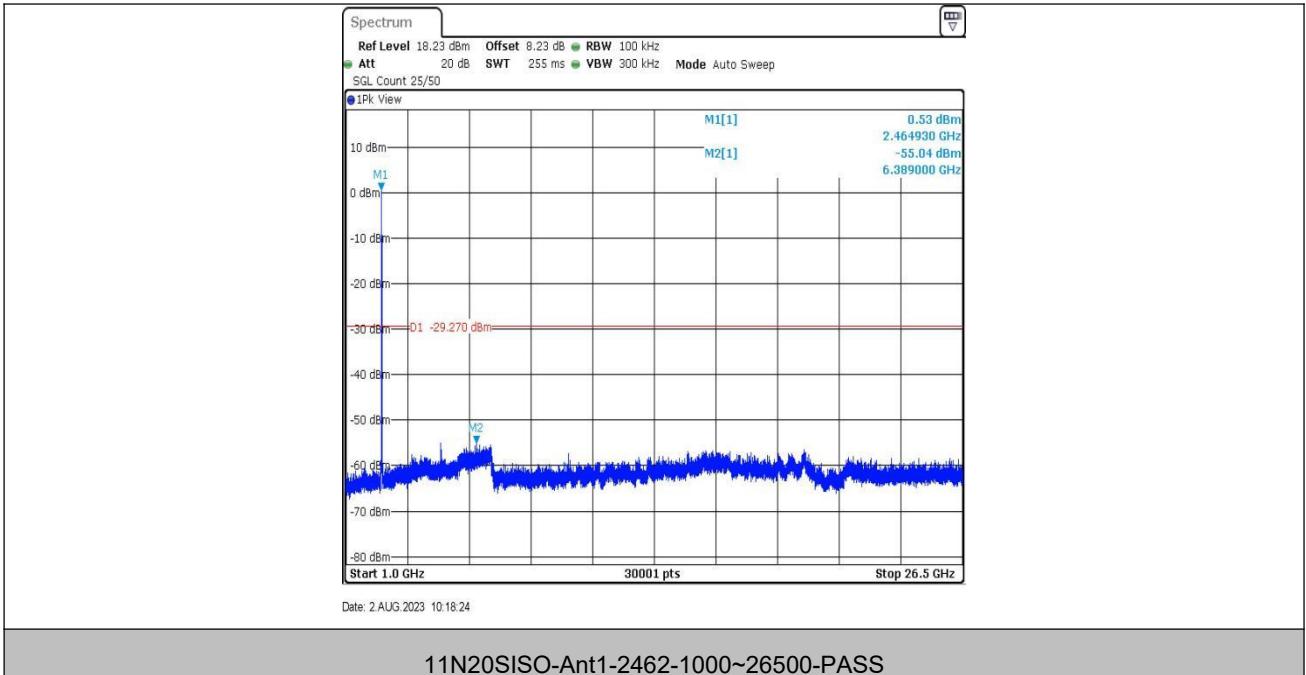

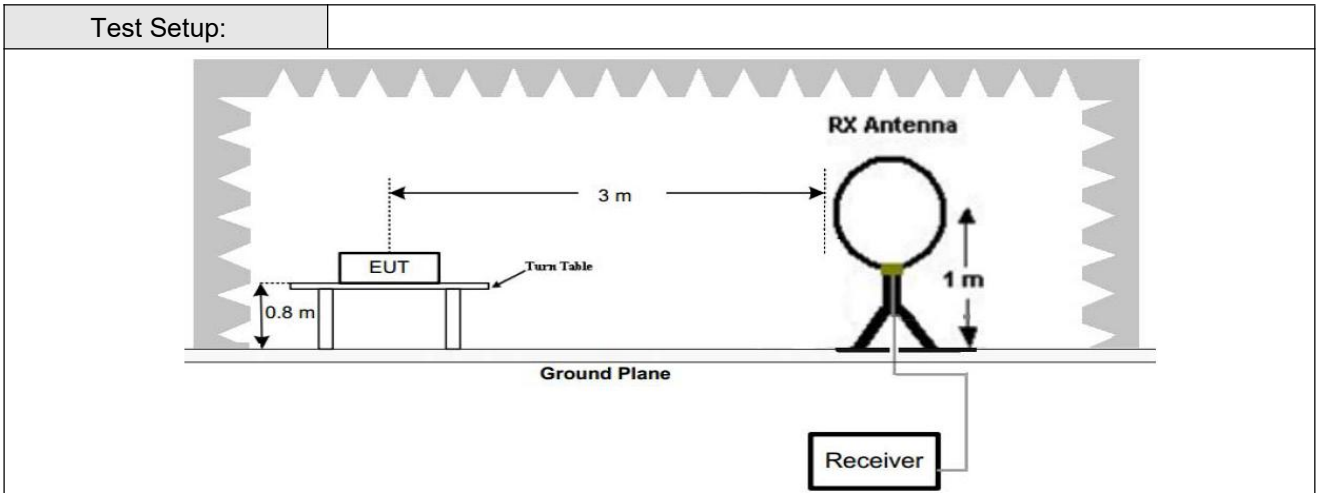


Figure 1. Below 30MHz

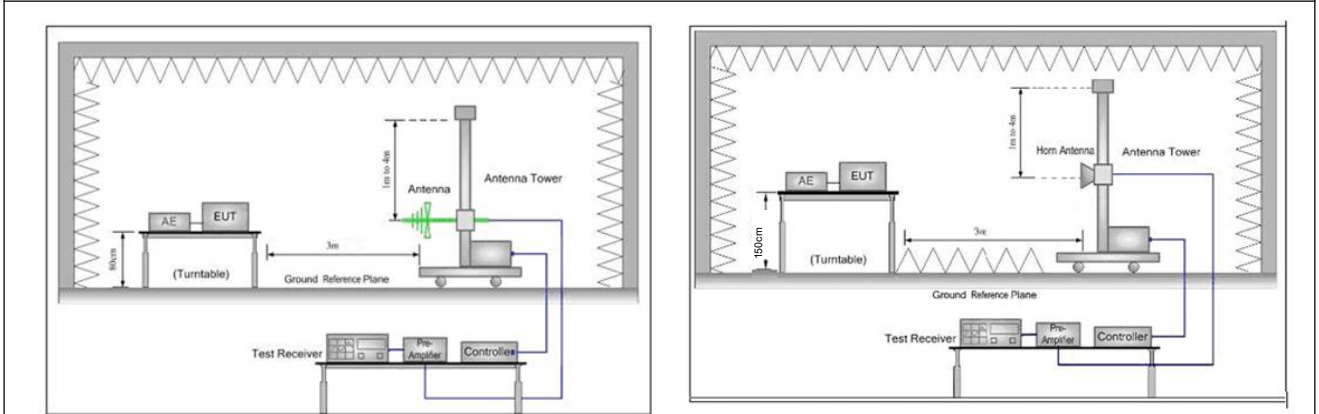


Figure 2. 30MHz to 1GHz

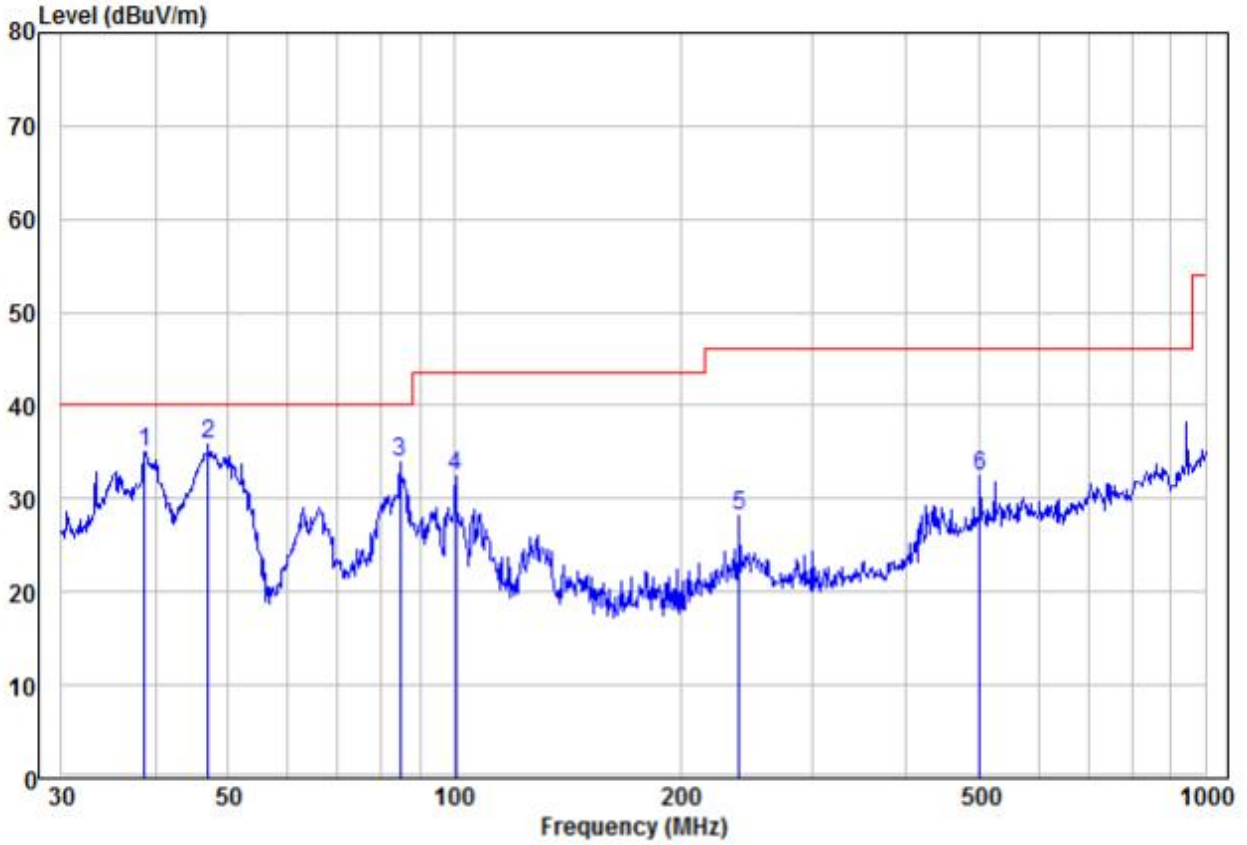
Figure 3. Above 1 GHz

The table was rotated 360 degrees to determine the position of the highest radiation. 2) Above 1G: The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter semi-anechoic chamber. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode. f. 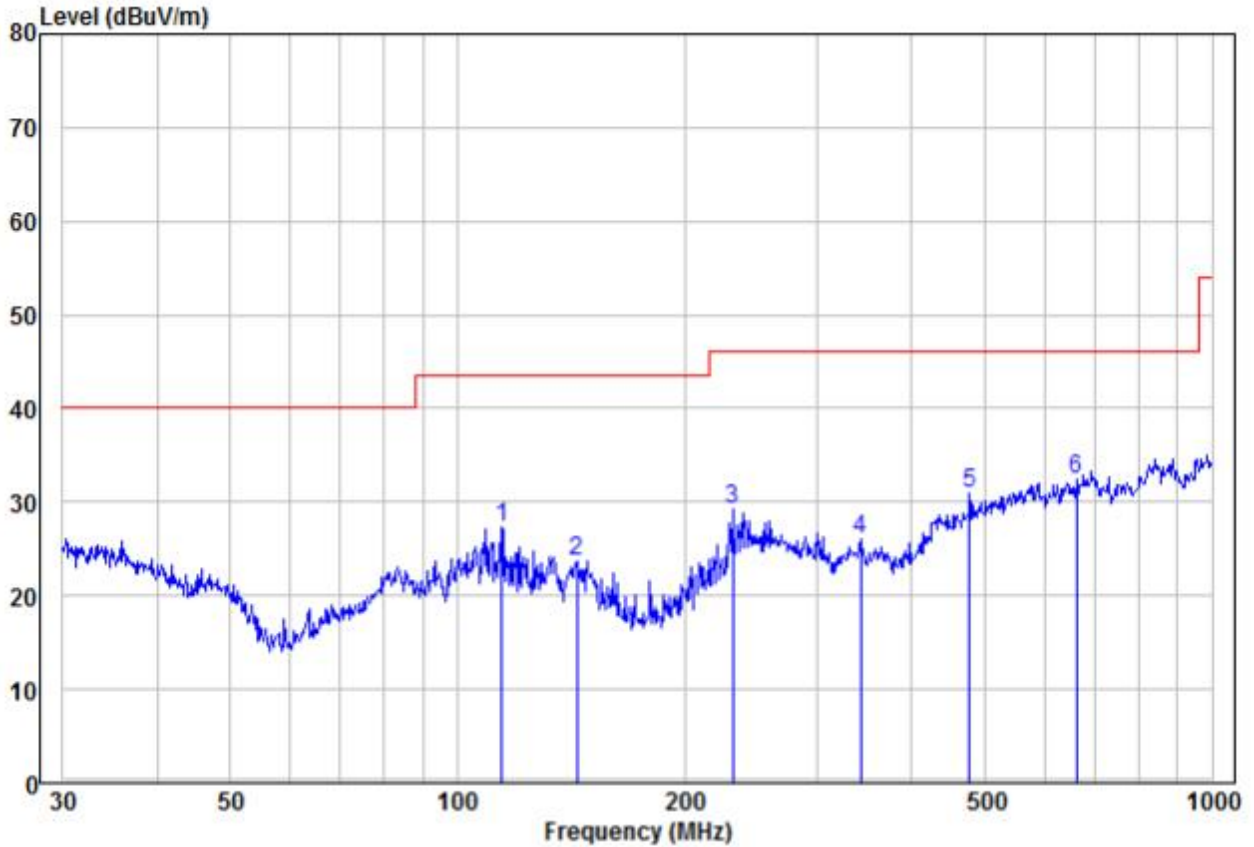

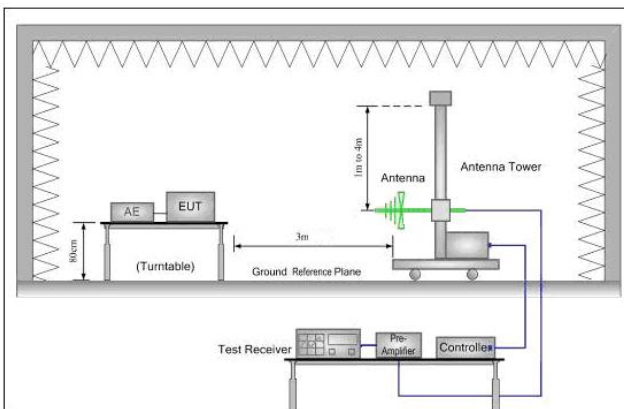


Figure 1. 30MHz to 1GHz

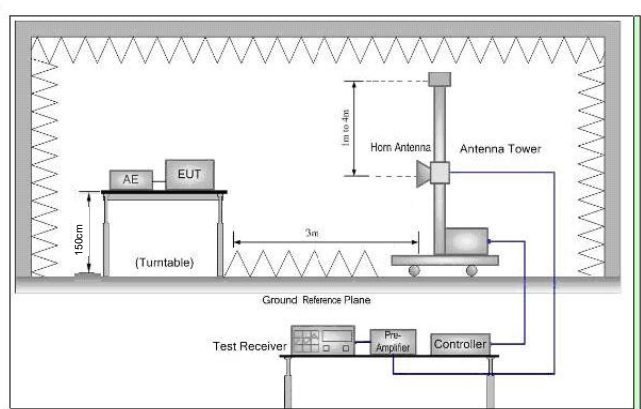


Figure 2. Above 1 GHz

The field strength is calculated by adding the Antenna Factor, Cable Factor & Preamplifier. The basic equation with a sample calculation is as follows:

Final Test Level = Receiver Reading + Antenna Factor + Cable Factor – Preamplifier Factor

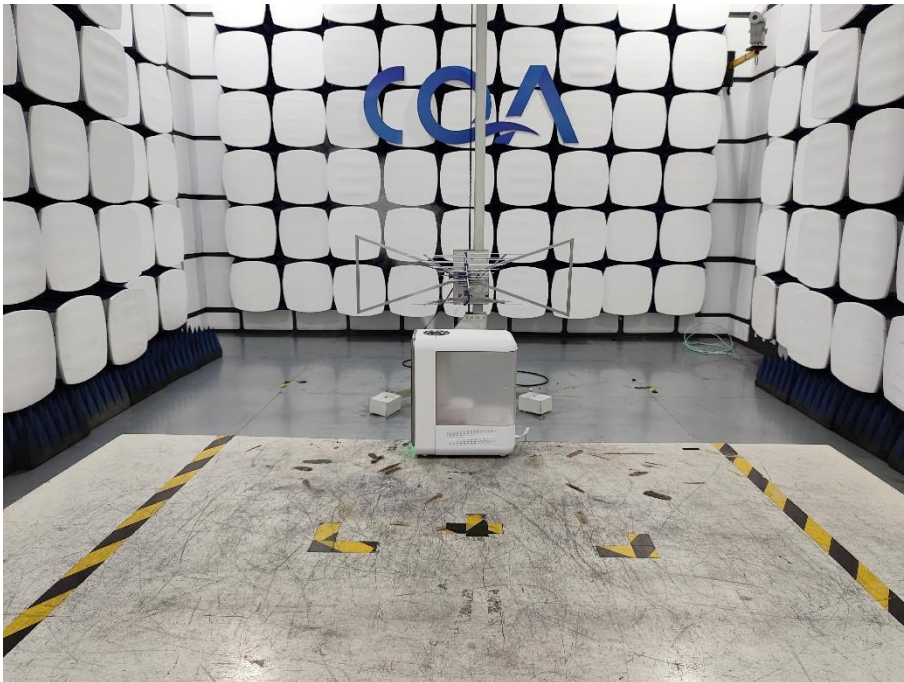

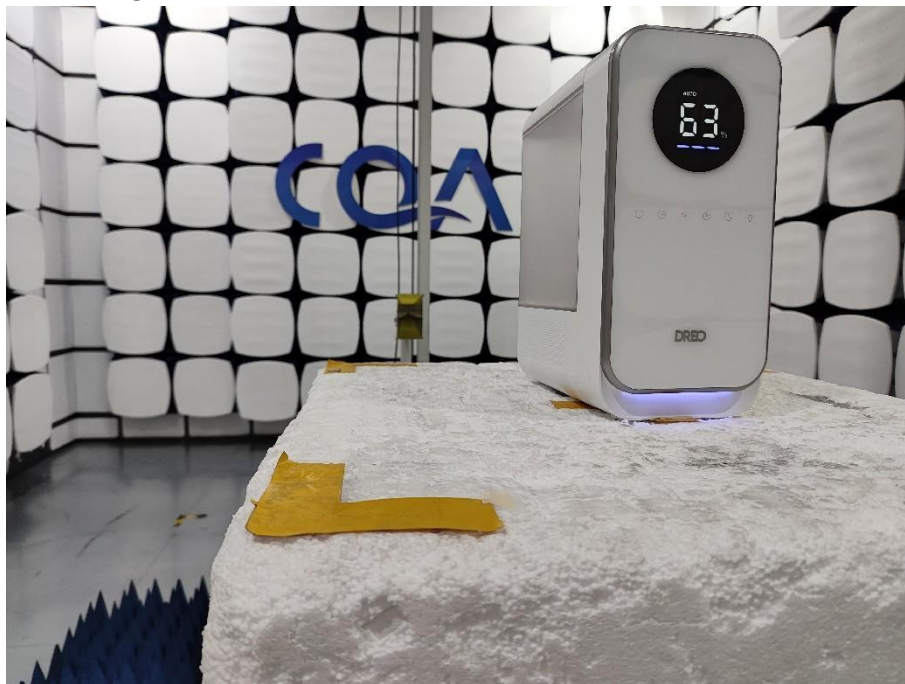
