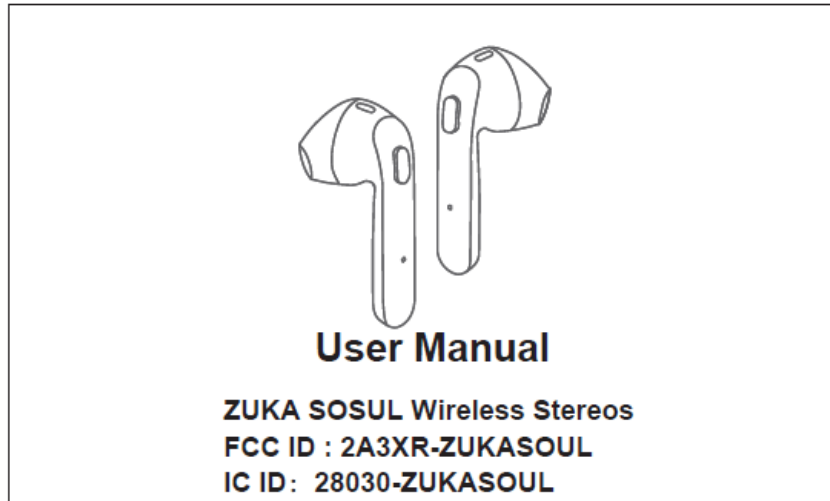


FCC ID and IC Label Location

The product does not have enough space to place the label, and FCC ID label is reflected in the user manual and package, as below:

Tips

- 1.To extend the service life of the battery, you are advised to charge the Zuka in-ear stereos at least once a month.
- 2.Please use the charger provided by company to charge the Zuka in-earstereos. Use of other low-quality chargers may cause danger and void warranty.
- 3.Adjust the volume to an appropriate levels when using the Zuka in-earstereos.
- 4.DO NOT wear the Zuka in-earstereos when sleeping; otherwise, the device may be damaged or cause injuries to you.
- 5.When driving, you are advised to use the Bluetooth Zuka in-earstereos to ensure your driving safety. It is dangerous to directly use cell phones when driving.
- 6.Keep the Zuka in-earstereos away from under age children. Small components of the Zuka in-earstereos may cause suffocation or other injuries to under age children.
