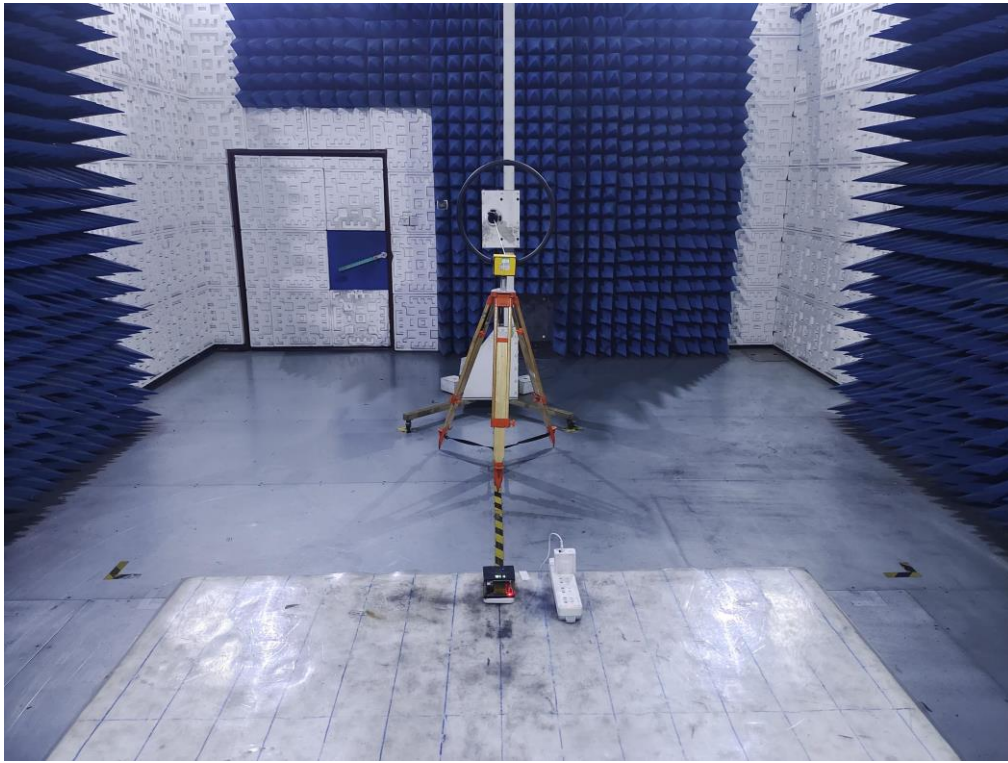
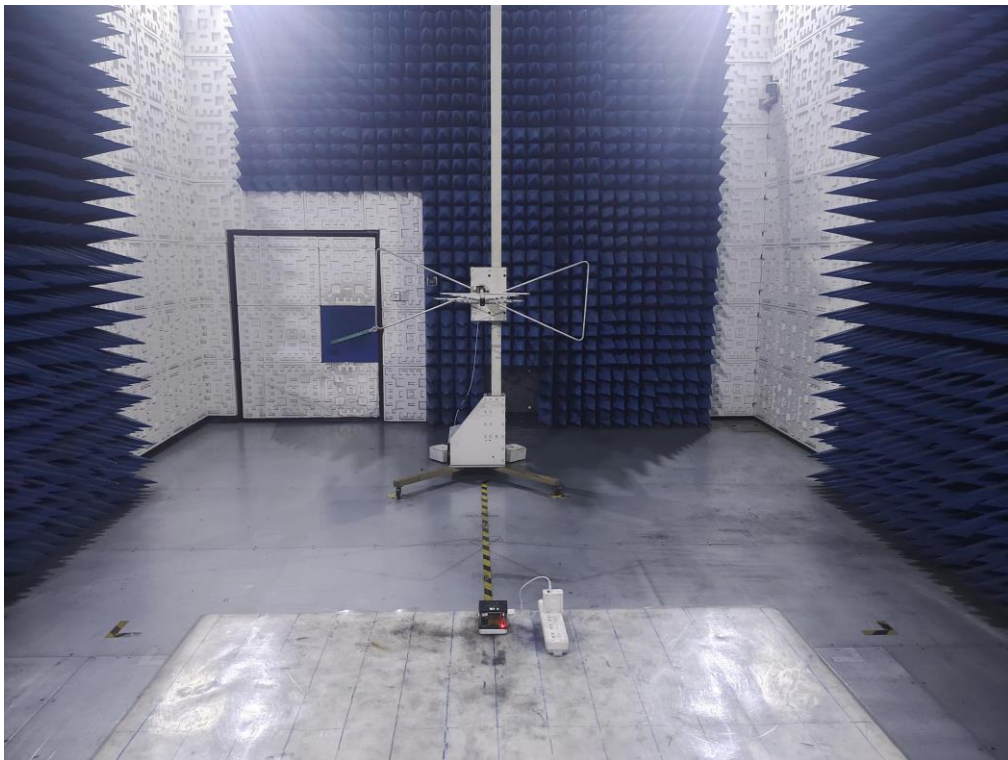

RADIATED EMISSION TEST SETUP BELOW 30MHz

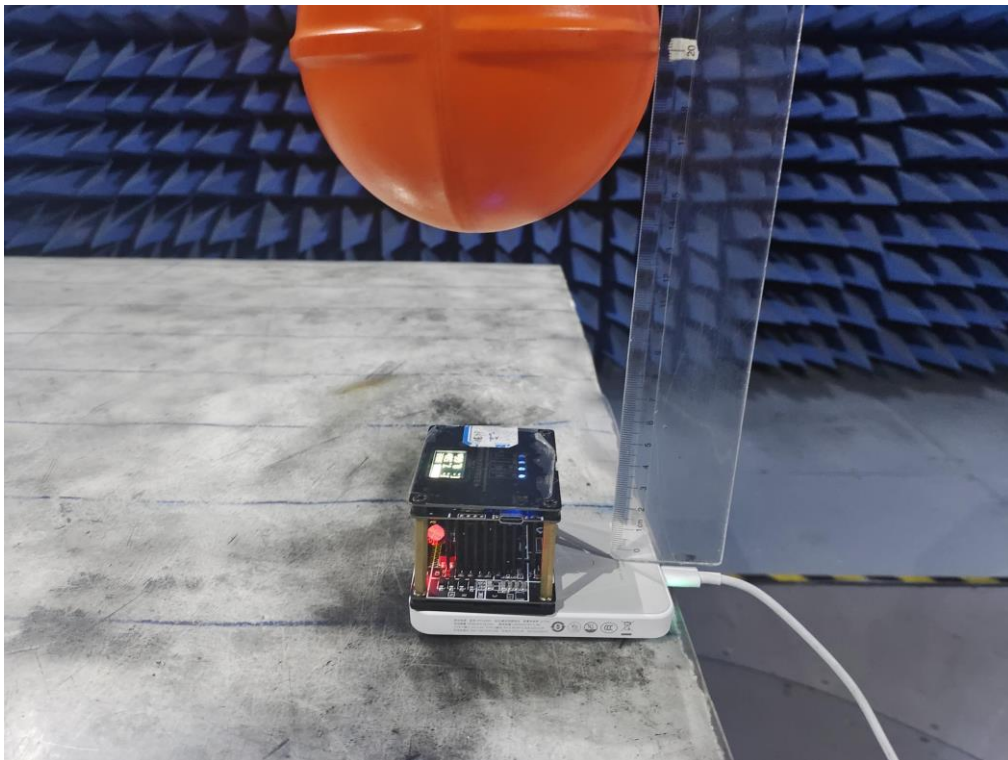

AC POWER LINE CONDUCTED TEST SETUP

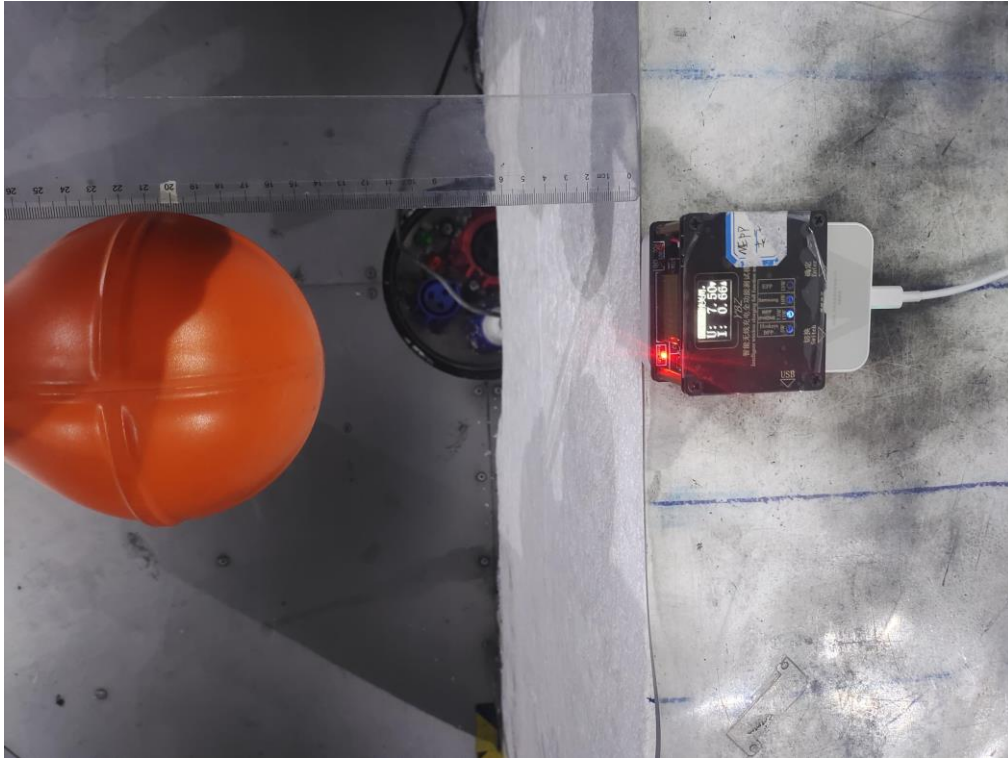

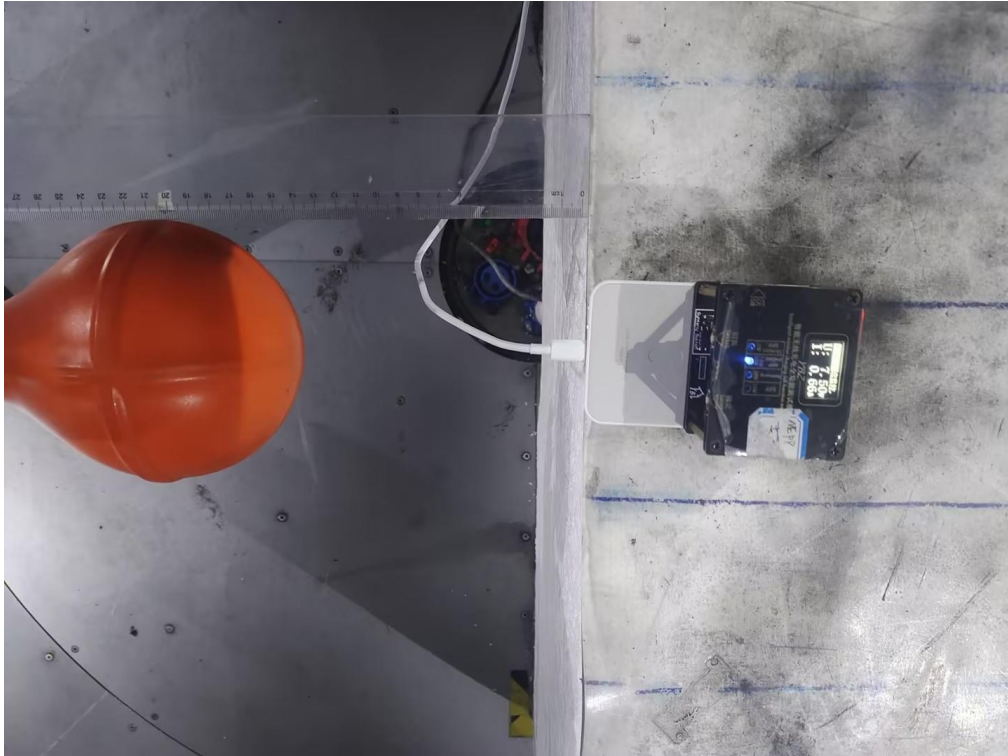

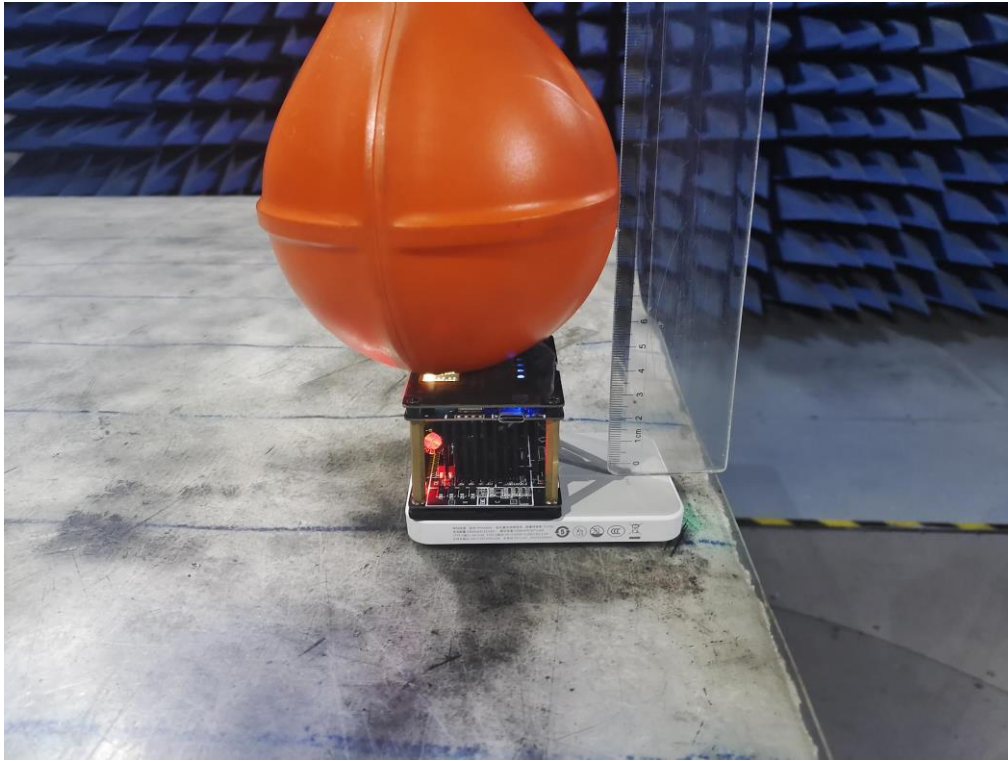
