


#### 4. Method Of Measurement

#### 4.4 Test procedure

a)The RF exposure test was performed in anechoic chamber.

b)The measurement probe was placed at 0 cm surrounding the device for test setup A; and the measurement Probe was placed from 0 cm to 20 cm, in 2 cm maximum increment measured from the edge of the device For the test setup B.

c)The highest emission level was recorded and compared with limit as soon as measurement of each d)The highest emission level was recorded and compared with limit as soon as measurement of each points (A, B, C, D, E) were completed.

d)The EUT was measured according to the dictates of KDB680106 D01v04

f)Remark:The EUT's test position A, B, C, D, E and F is valid for the E and H field measurements.





#### 4.5 Equipment Approval Considerations

The EUT does comply with item 5(b) of KDB680106 D01v04

1) Power transfer frequency is less than 1MHz Yes, the device operate in the frequency range from 115-205kHz

2) Output power from each primary coil is less than or equal to 15 watts. Yes, the maximum output power of the primary coil is 15W.

3) The system may consist of more than one source primary coils, charging one or more clients. If more than one primary coil is present, the coil pairs may be powered on at the same time. No, the prototype has only a single coil.

4) Client device is inserted in or placed directly in contact with the transmitter. Yes, client device is placed directly in contact with the transmitter.

5) Mobile exposure conditions only (portable exposure conditions are not covered by this exclusion). No, the product is portable

6) The aggregate H-field strengths at 15 cm surrounding the device and 20 cm above the top surface from all simultaneous transmitting coils are demonstrated to be less than 50% of the MPE limit. Yes, conform.
