



(B) Radiated Emission Test-Up Frequency 30MHz~1GHz



- c. The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.

- d. - f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. - g. Test the EUT in the lowest channel, the middlest channel, the Highest channel.
