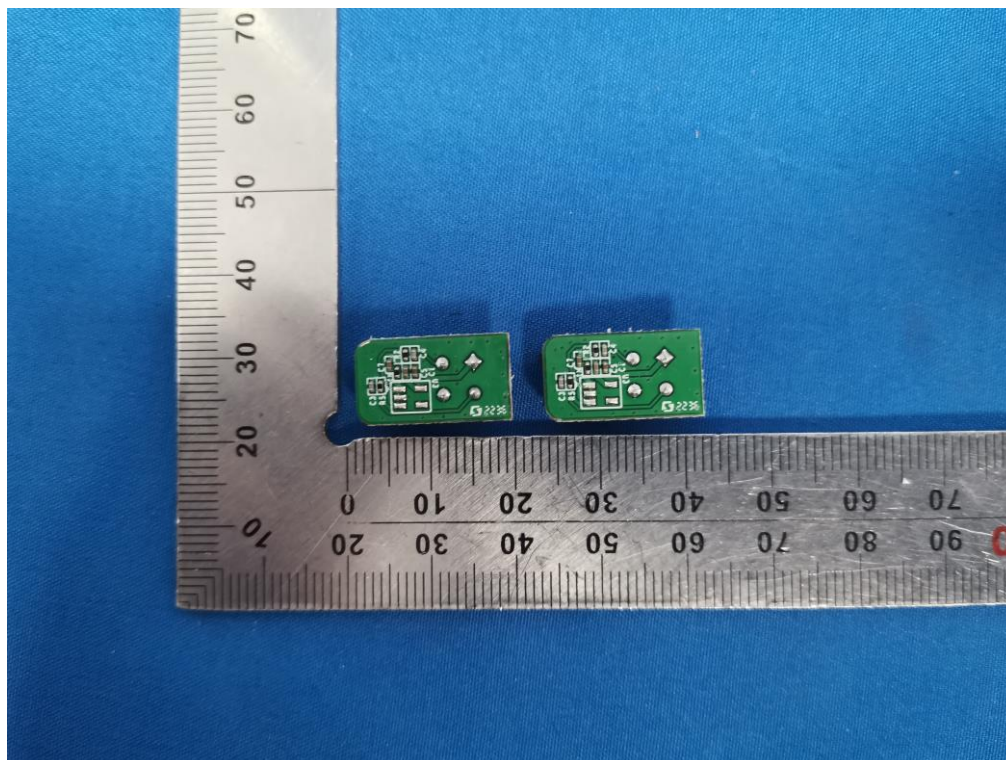

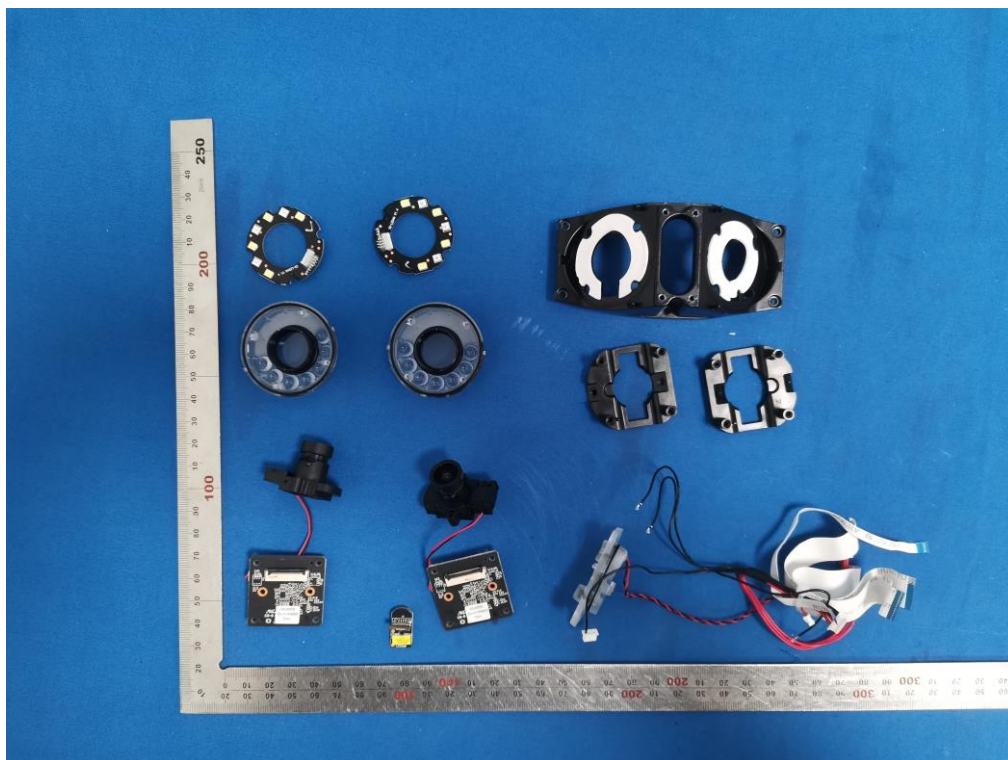

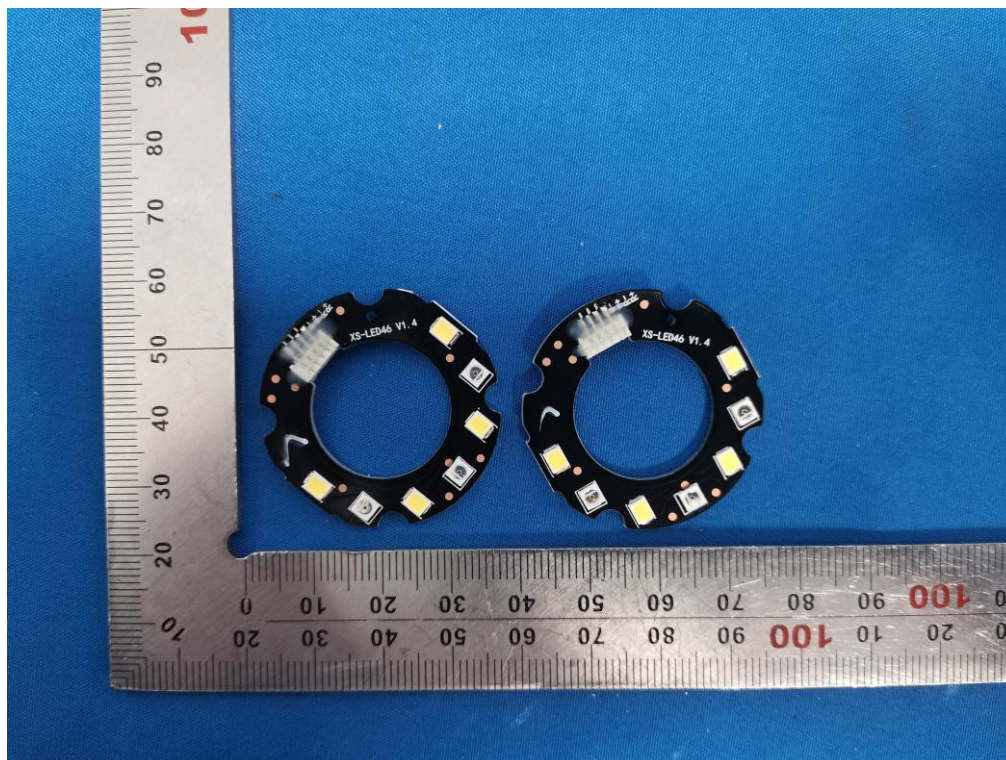


INTERNAL VIEW OF EUT(FIGURE 5)

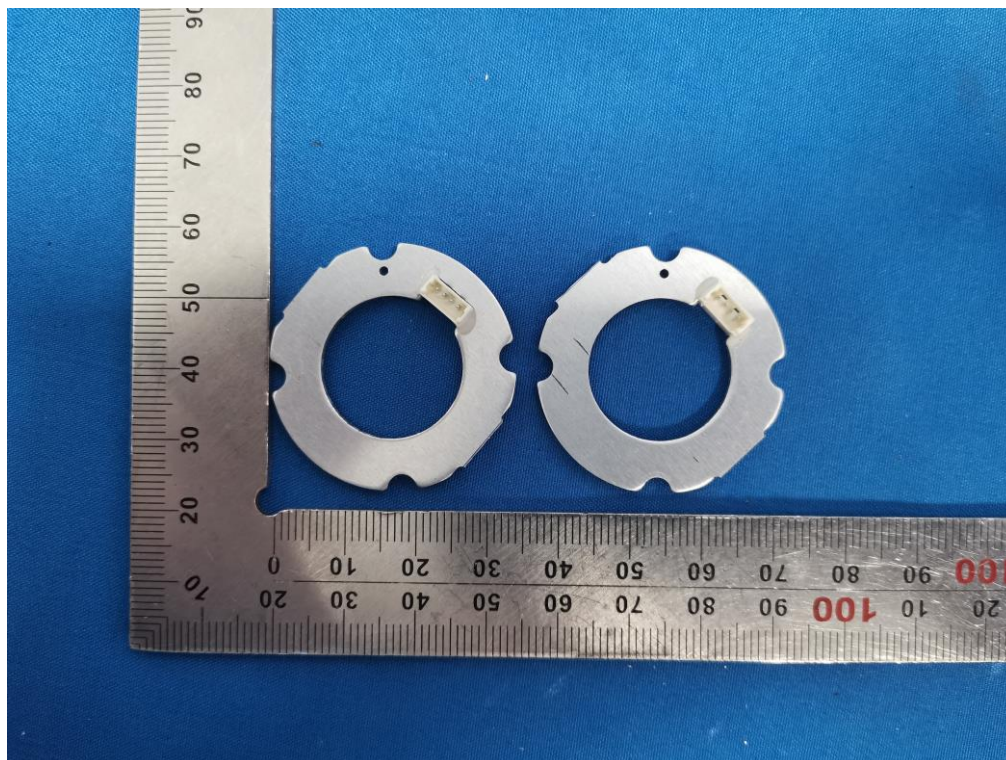

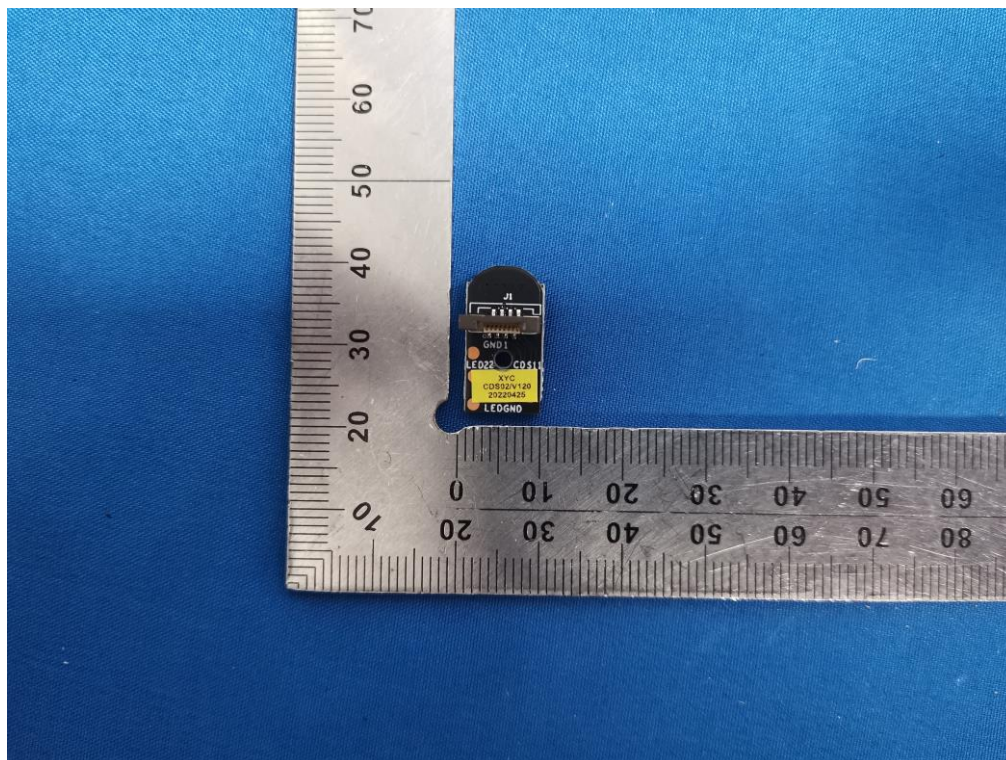

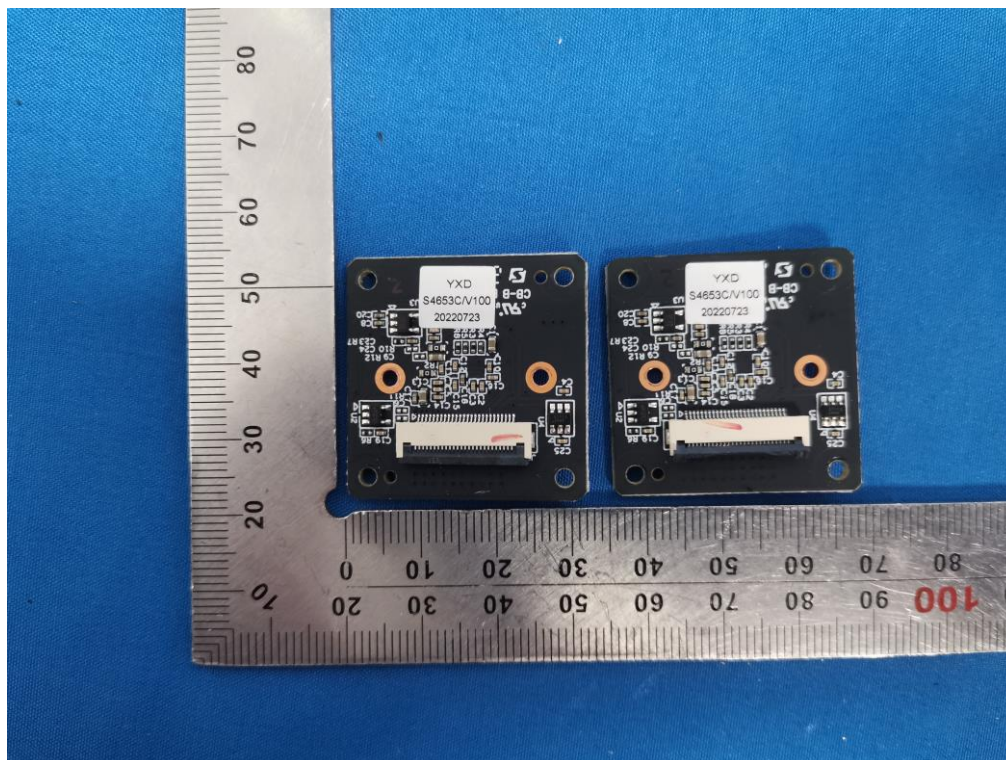

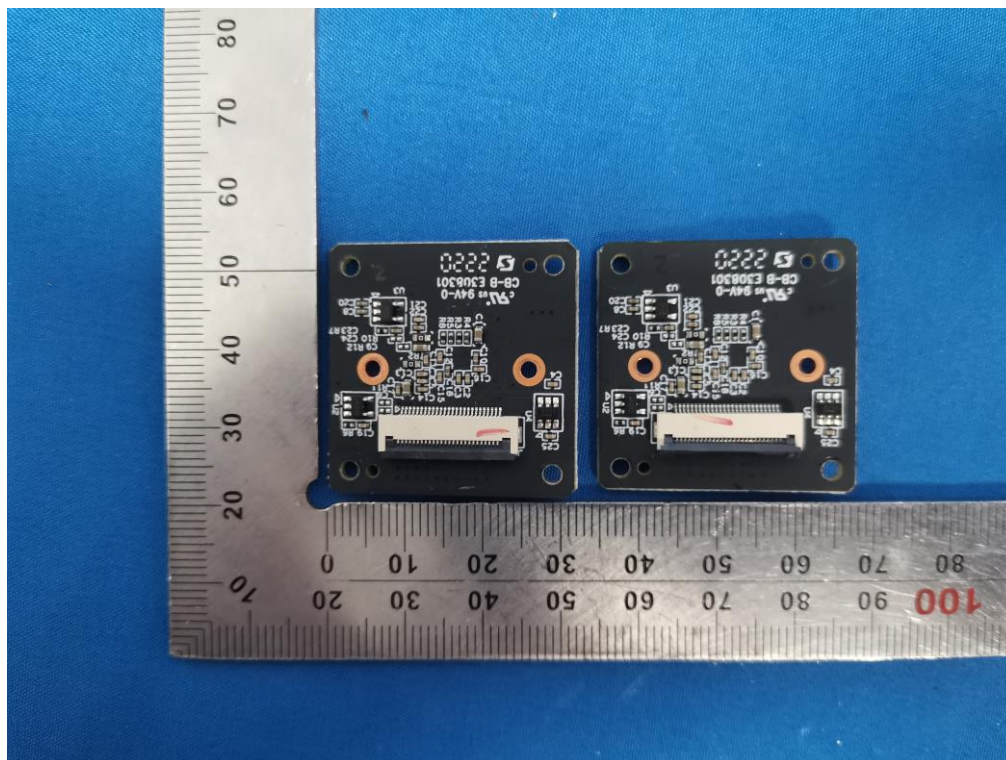

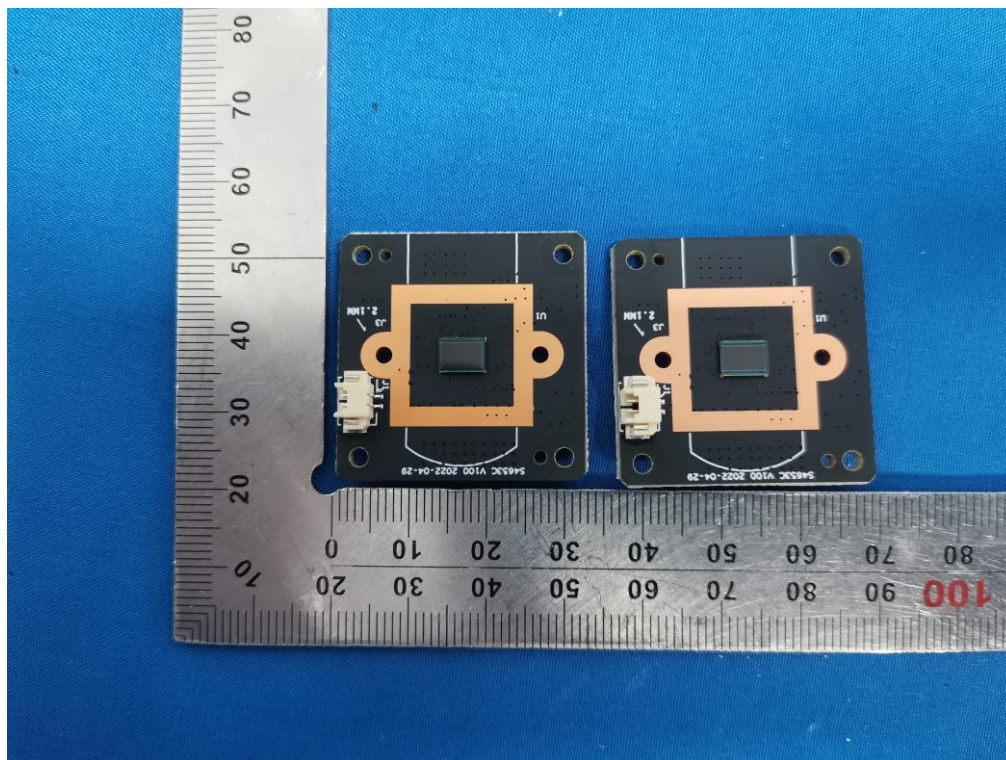

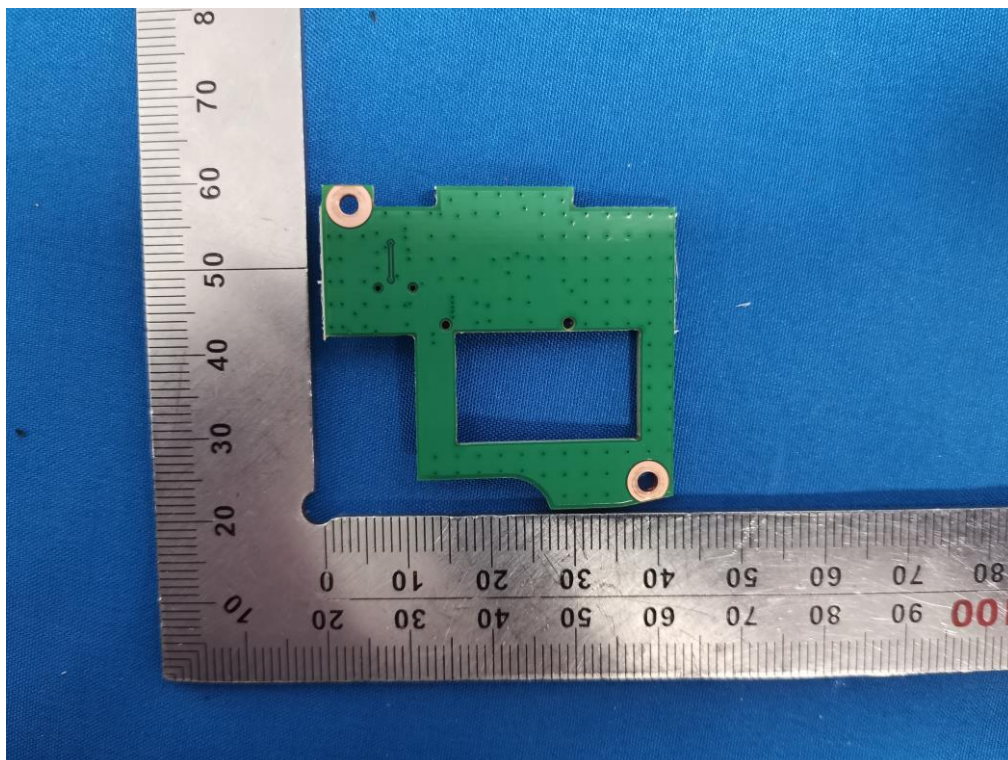

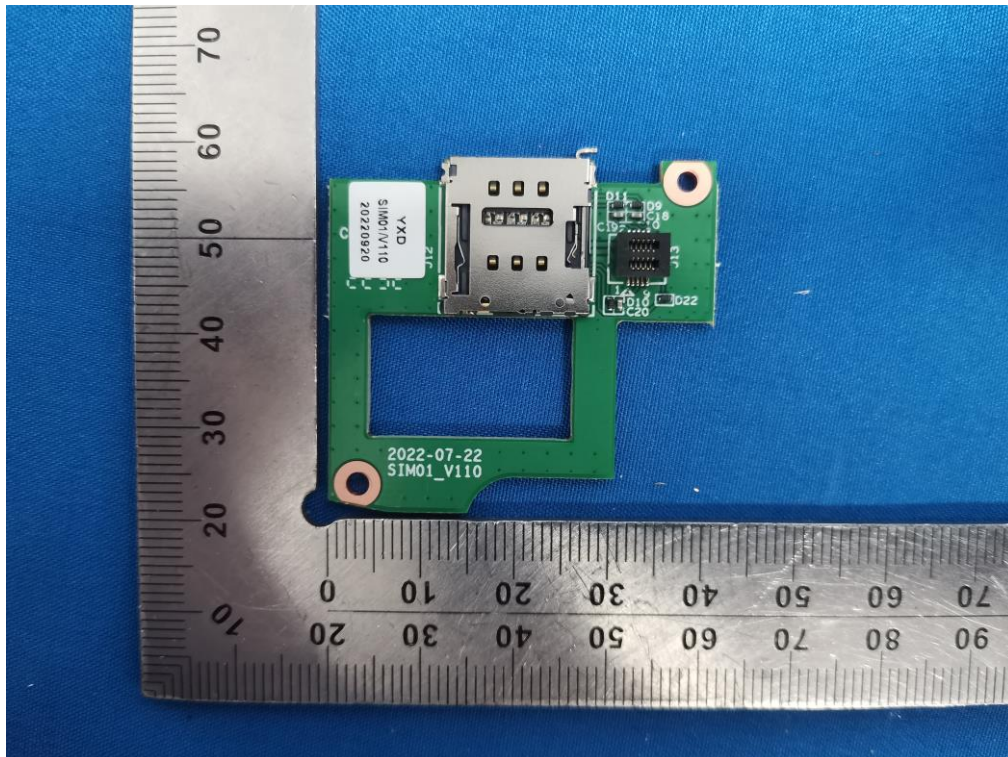


INTERNAL VIEW OF EUT(FIGURE 15)

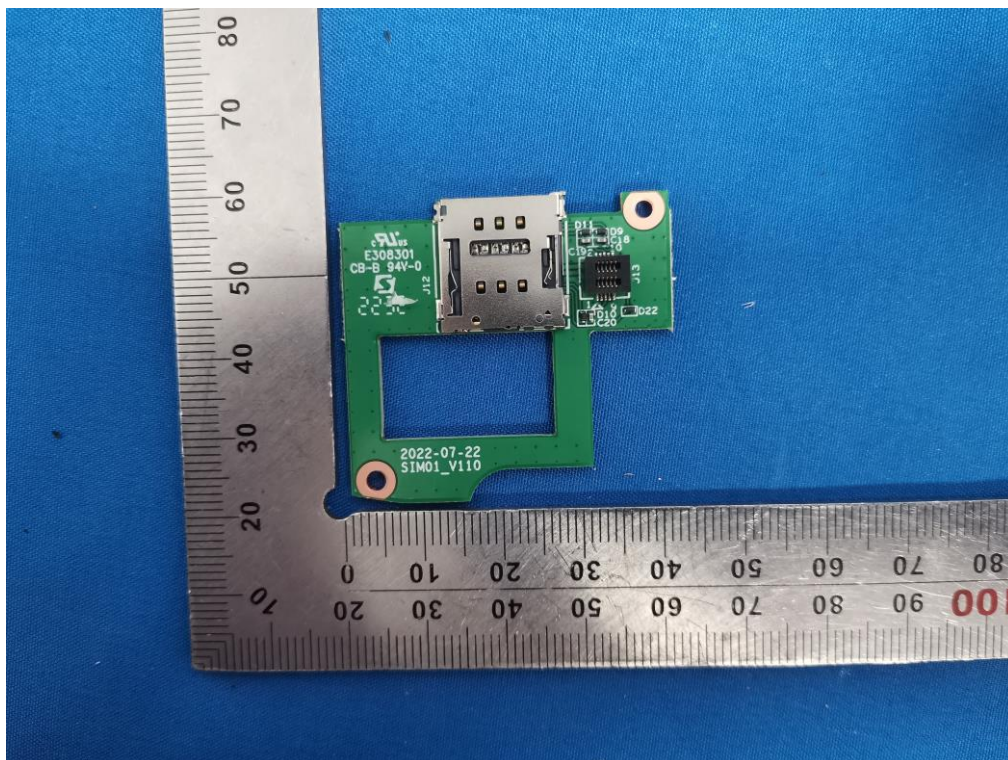

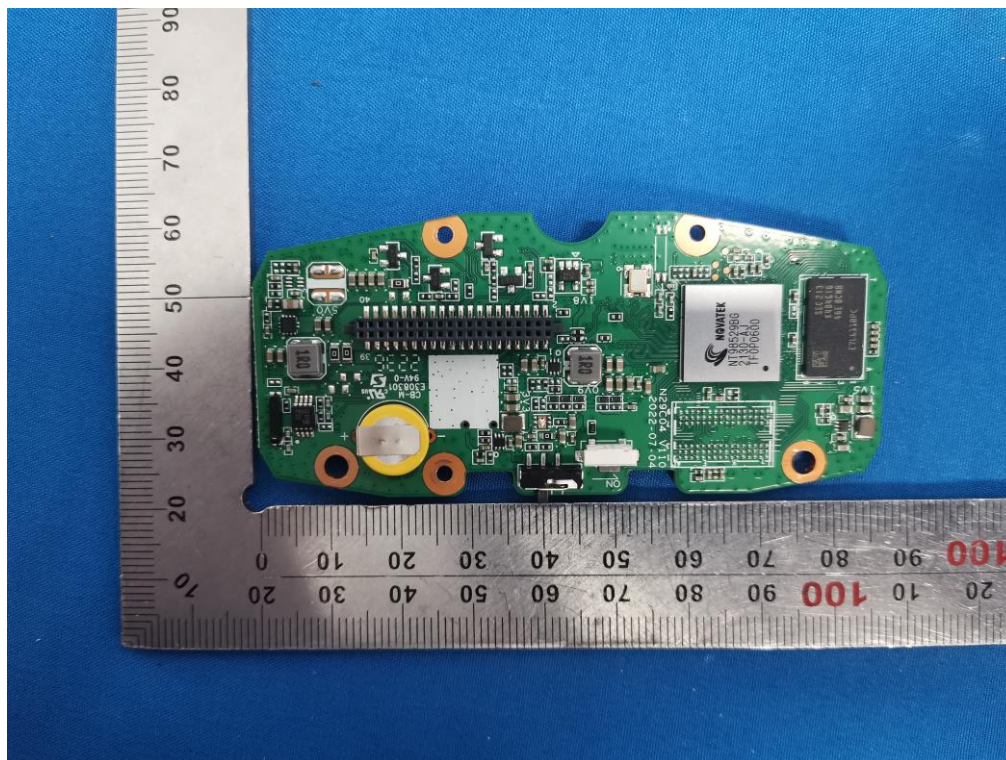

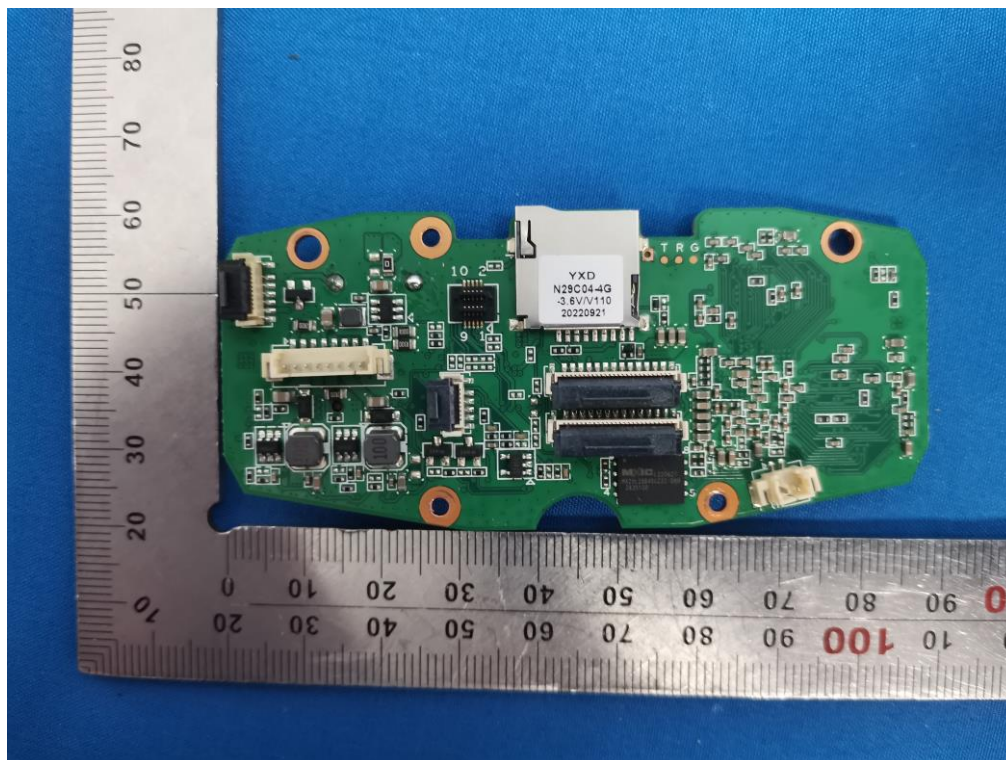

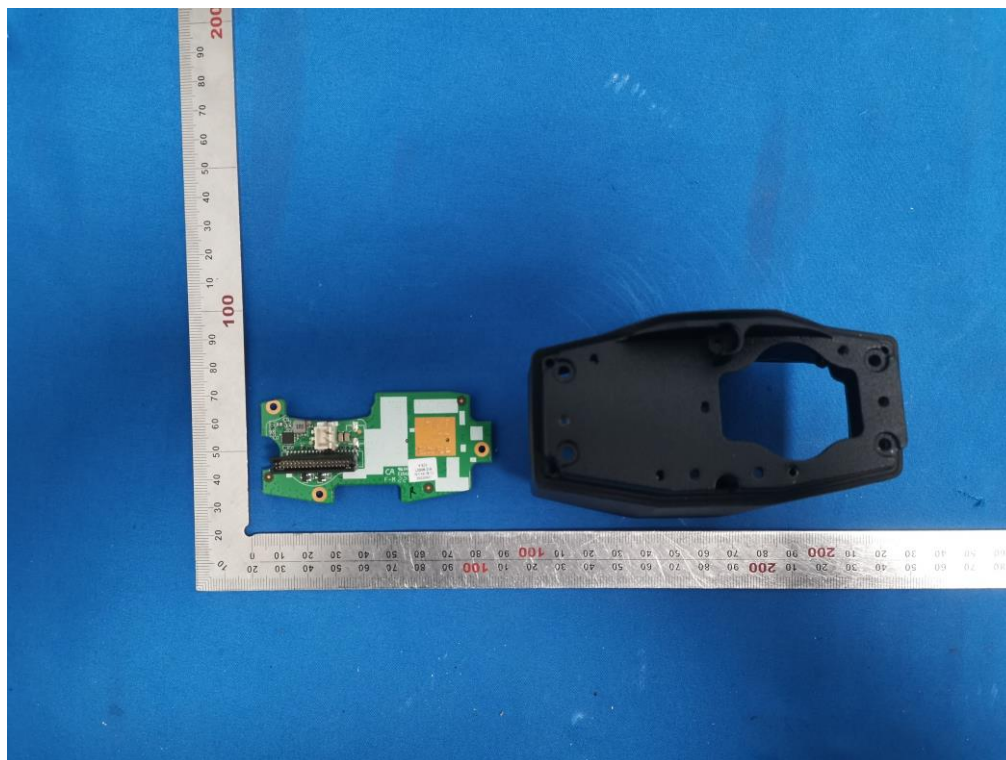

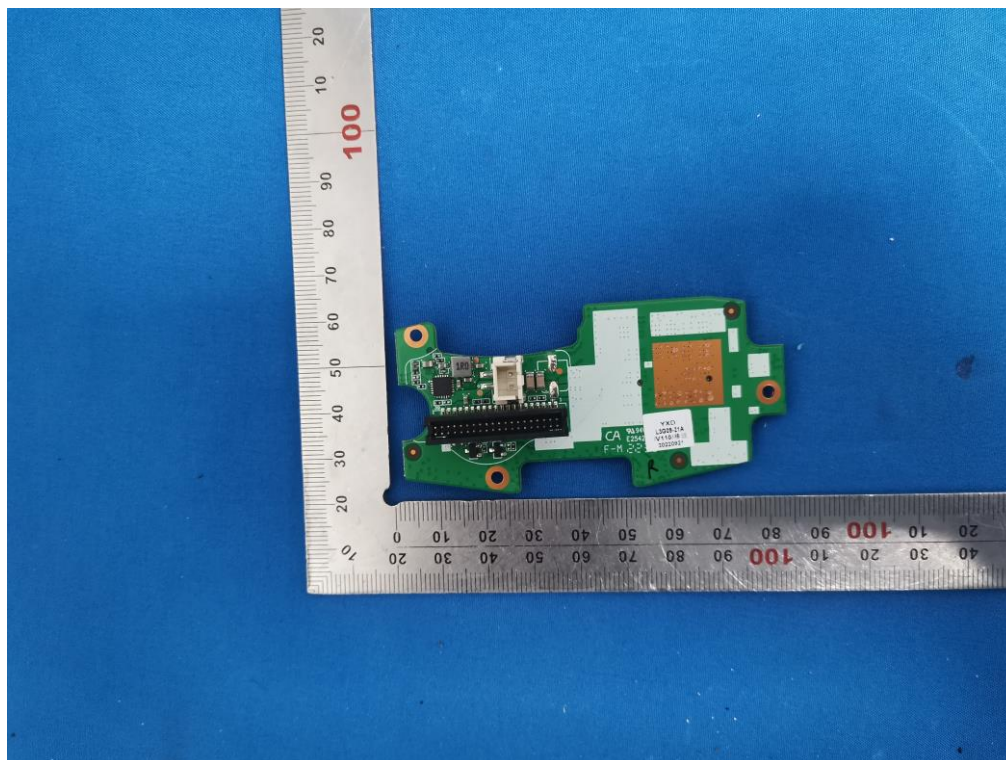

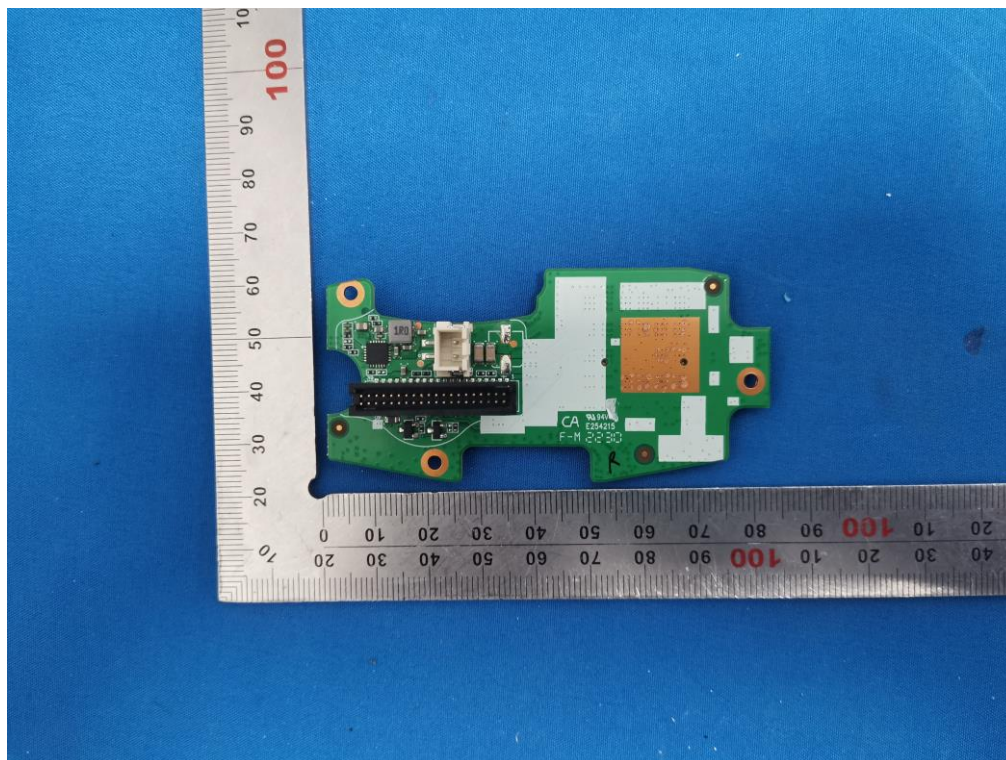

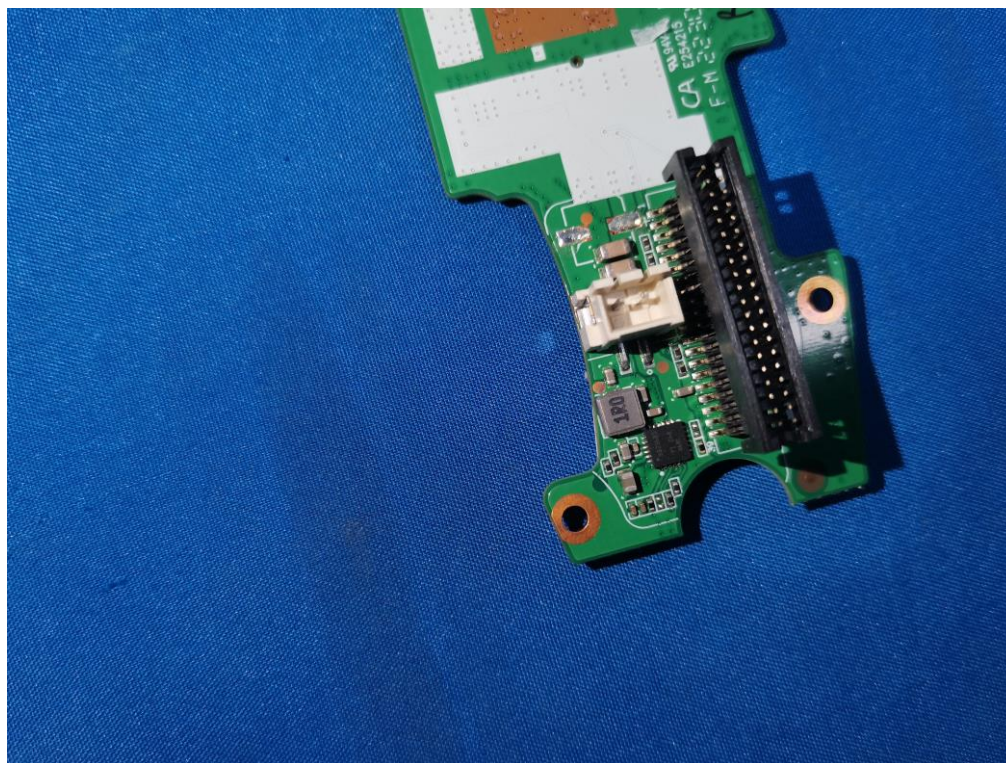

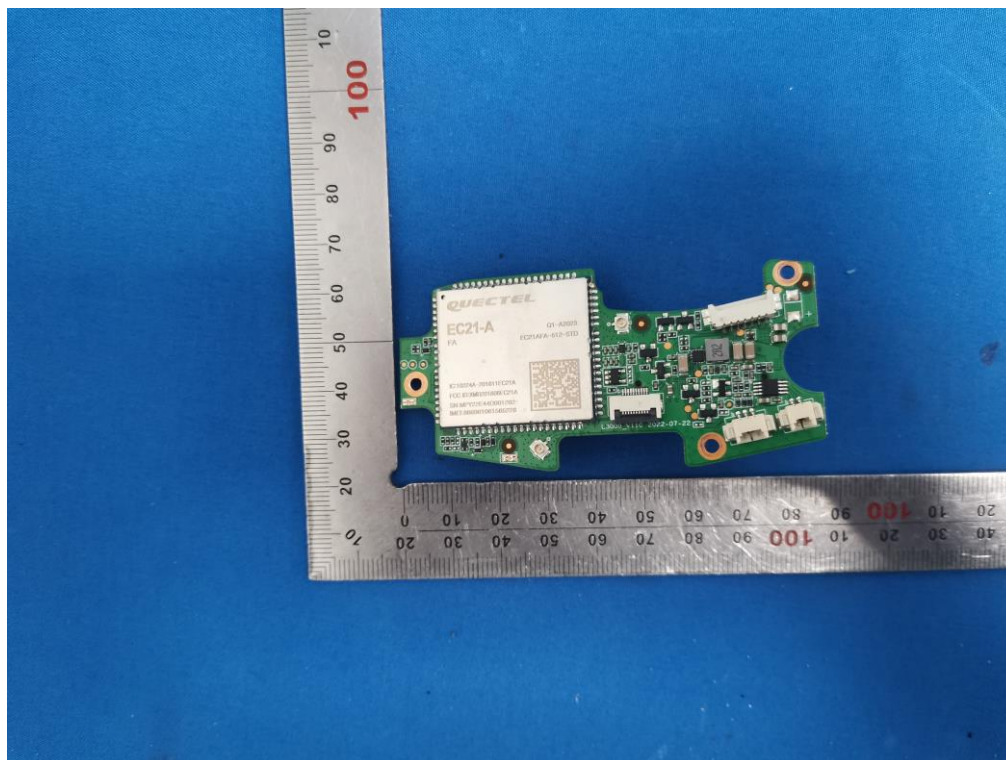

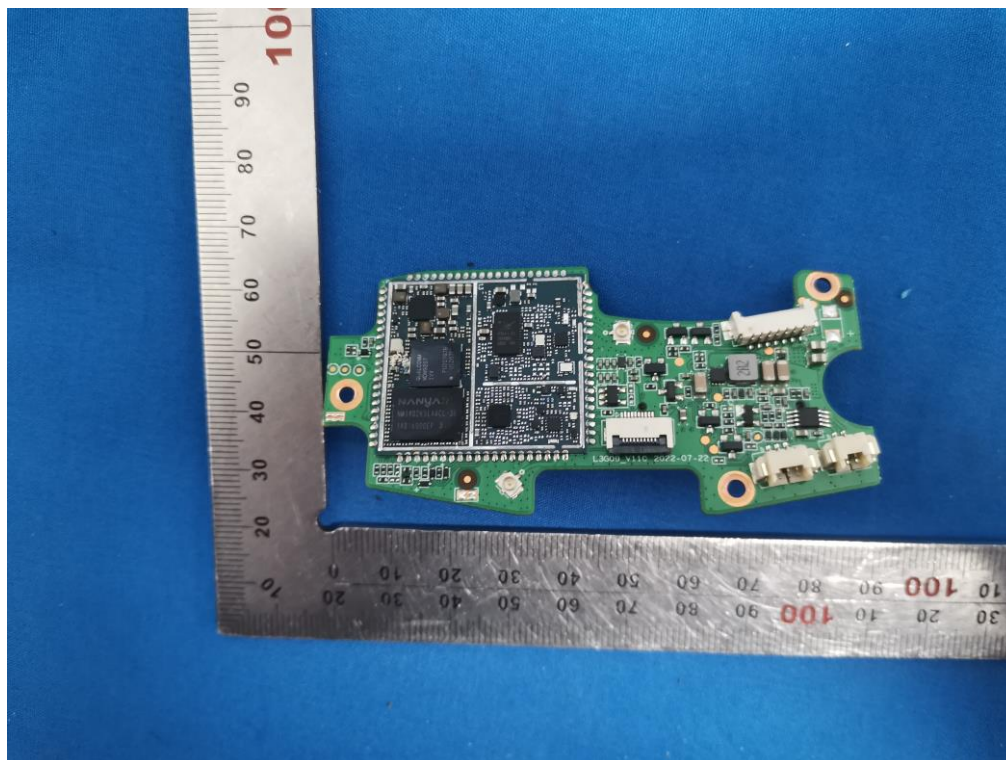

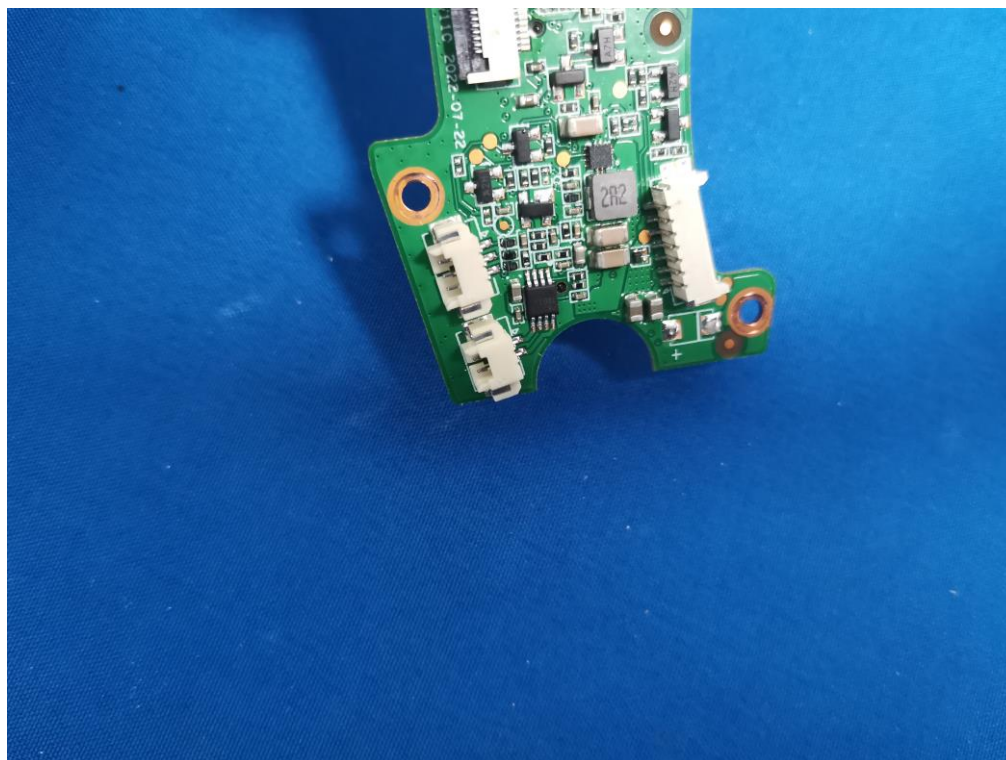

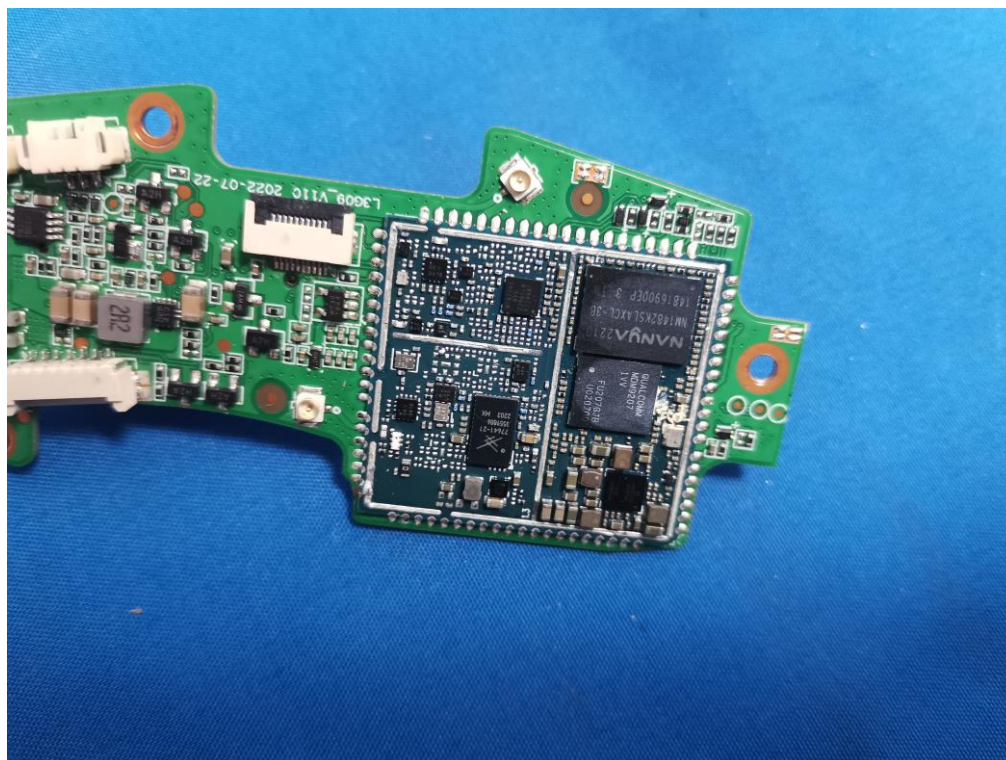
