Band2-20MHz-16QAM-18700-100RB#0

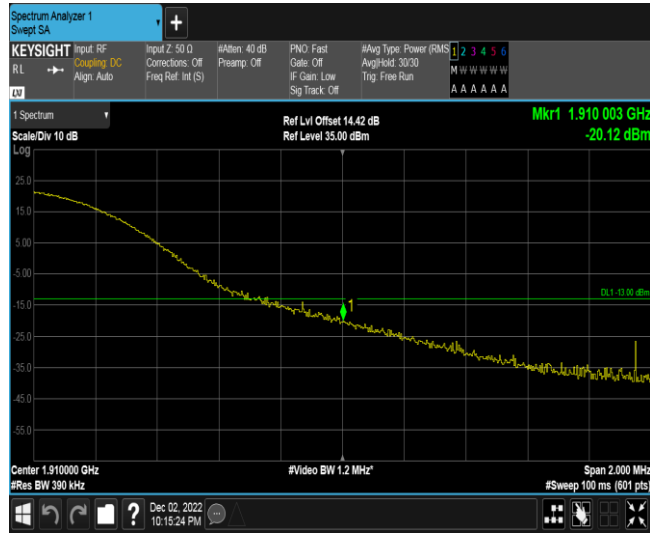


Band2-20MHz-16QAM-19100-1RB#0

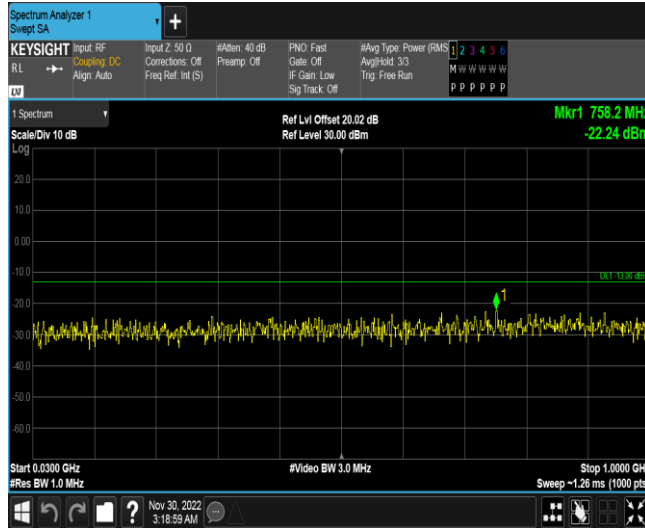

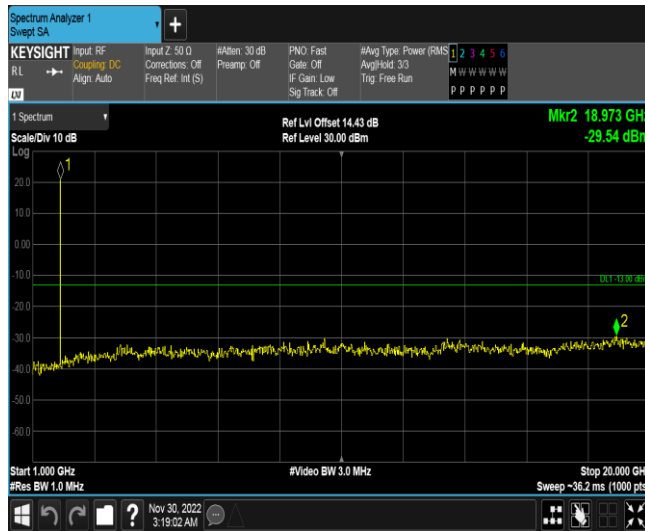

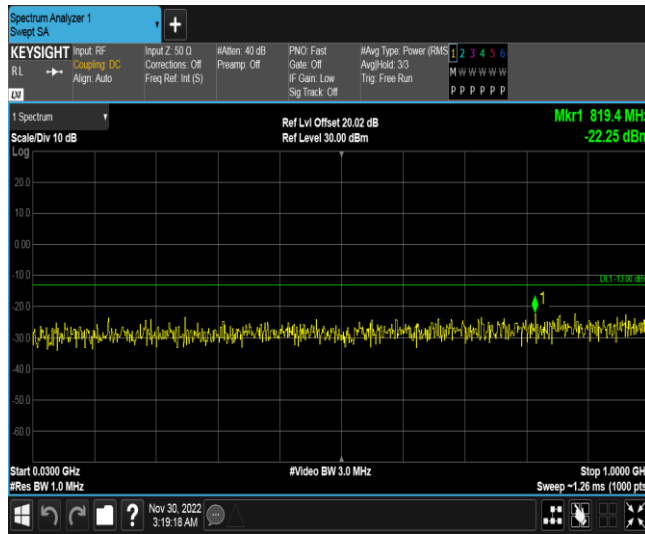


Band2-1.4MHz-QPSK-18607-1RB#0-Range2:1000~20000MHz

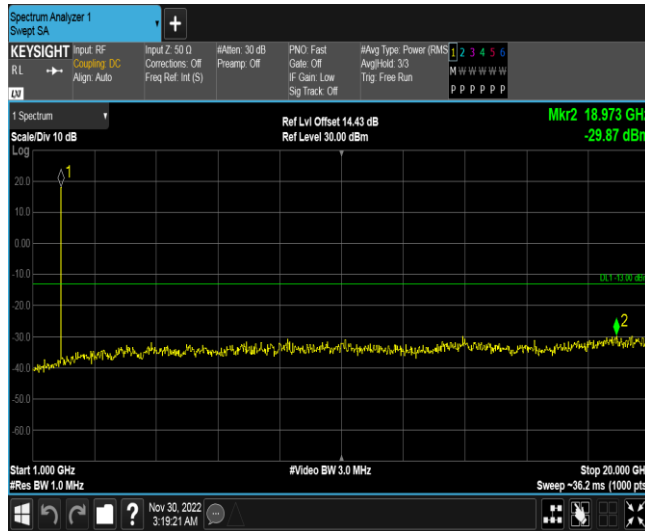

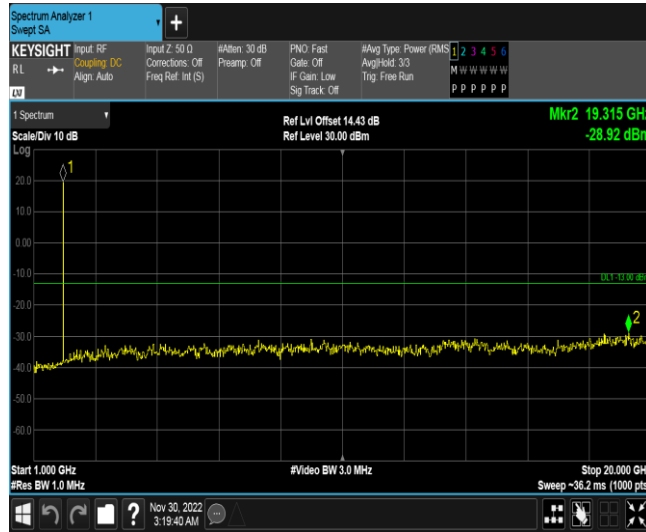
