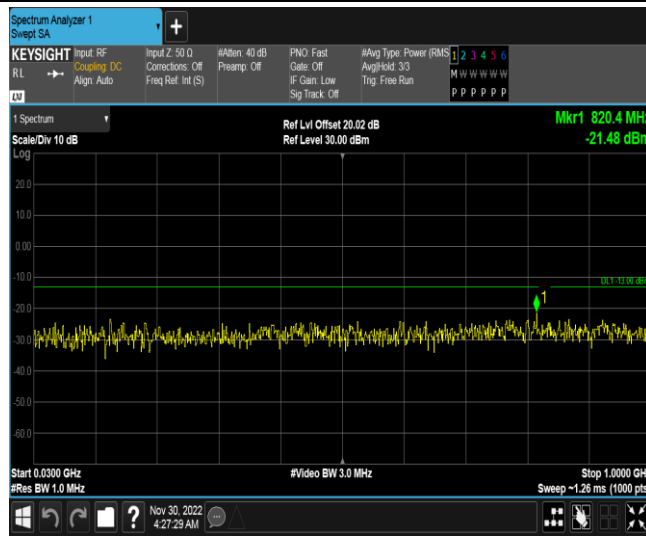


Band4-1.4MHz-QPSK-19957-1RB#0-Range2:1000~20000MHz

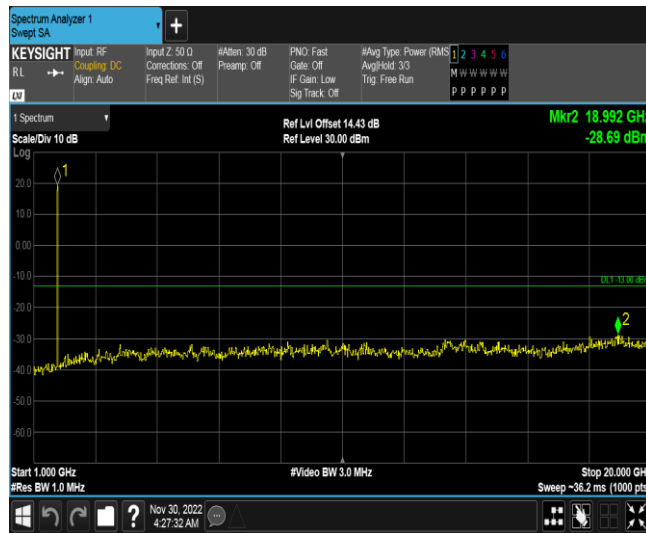

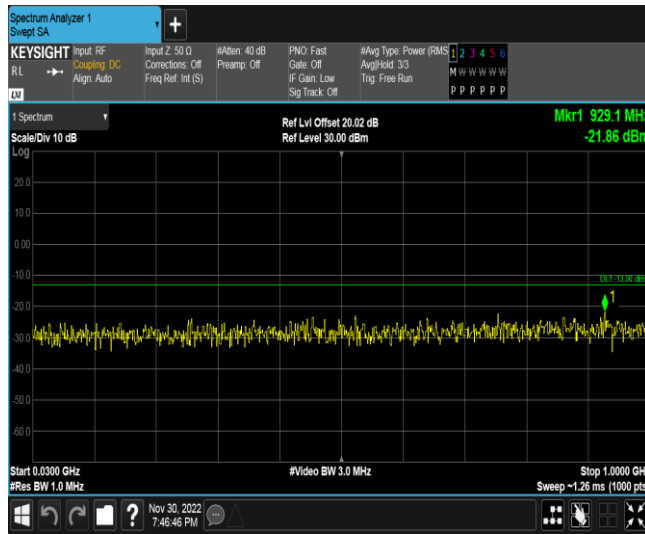

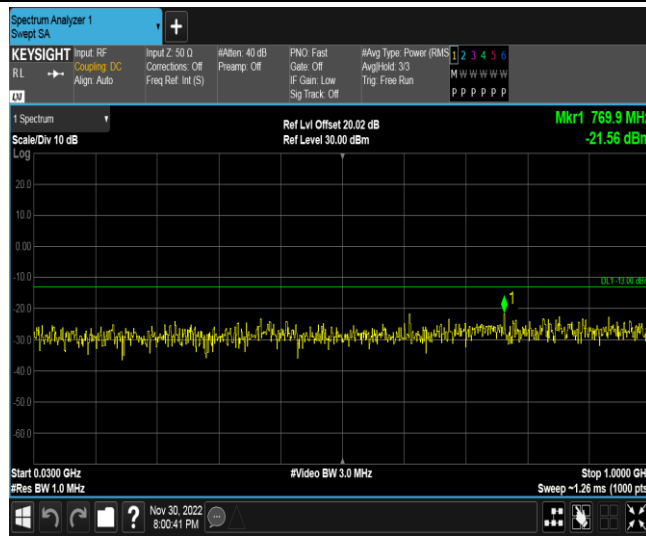


Band4-15MHz-QPSK-20175-1RB#0-Range2:1000~20000MHz

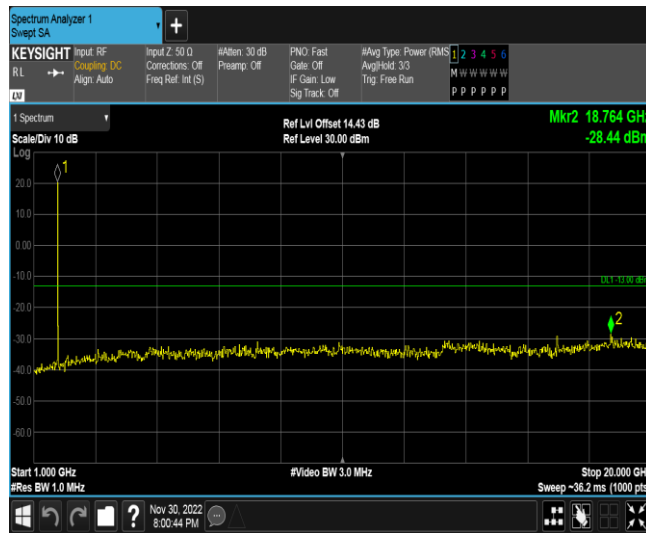
