Band2-15MHz-QPSK-18675-1RB#0-Range1:30~1000MHz

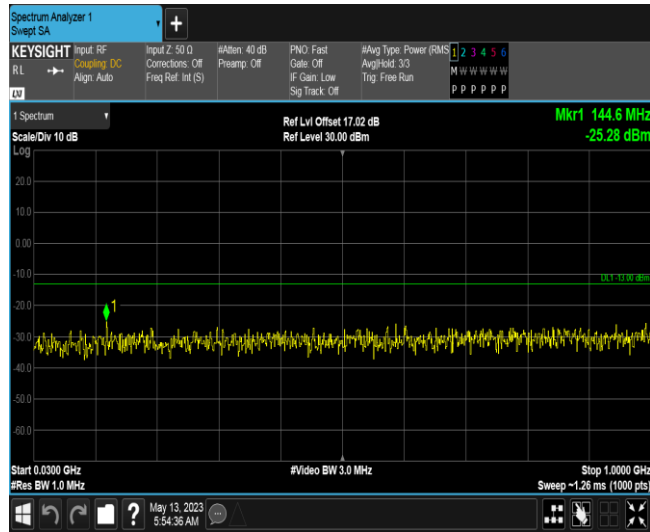


Band2-15MHz-QPSK-18675-1RB#0-Range2:1000~20000MHz

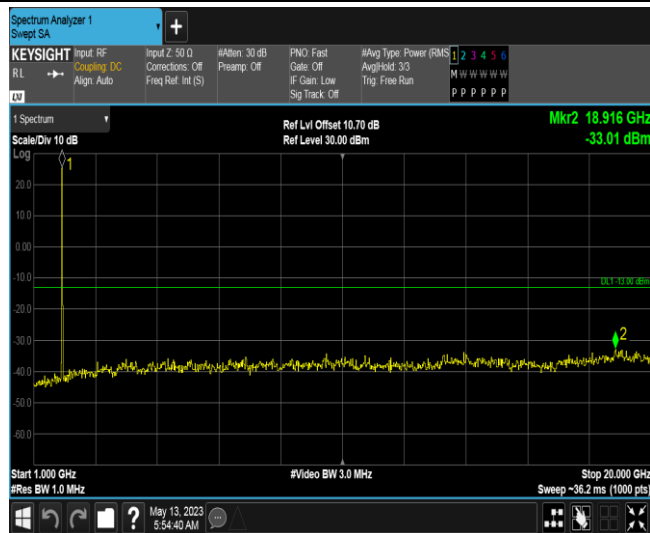
