Band2-20MHz-16QAM-18700-100RB#0

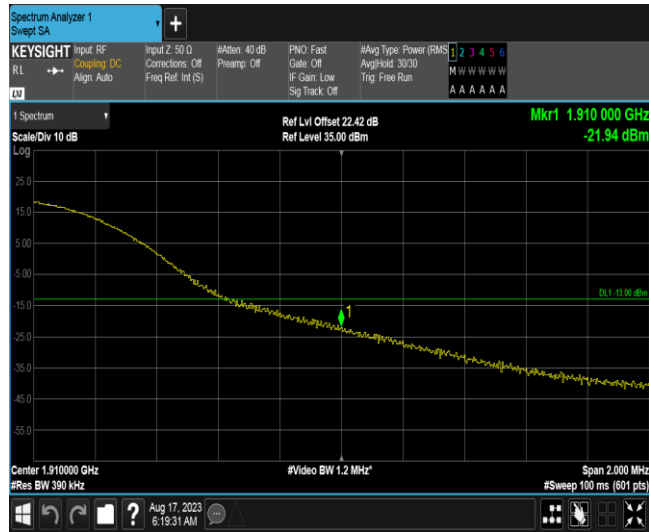

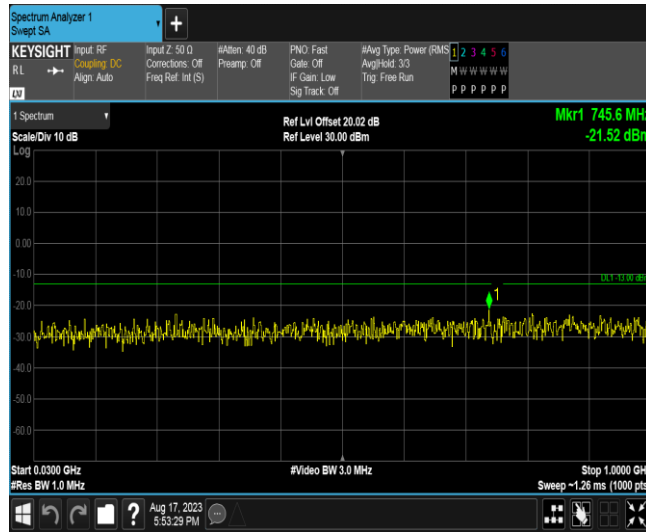
