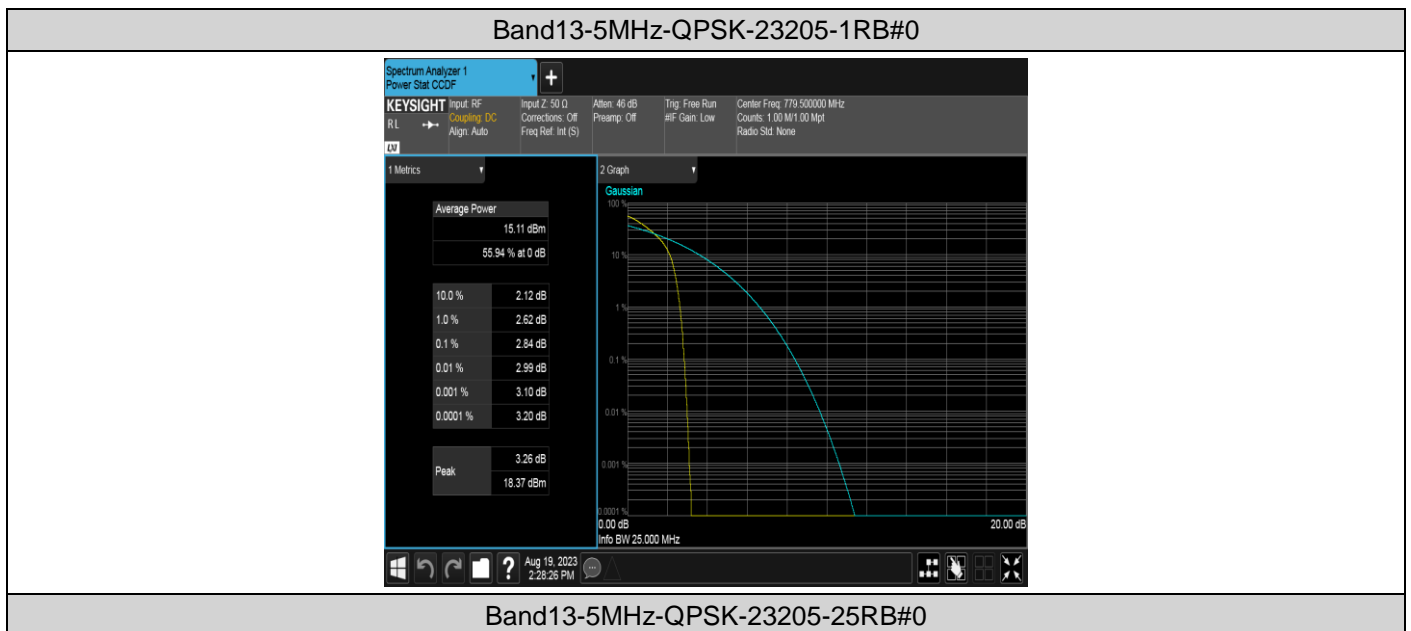

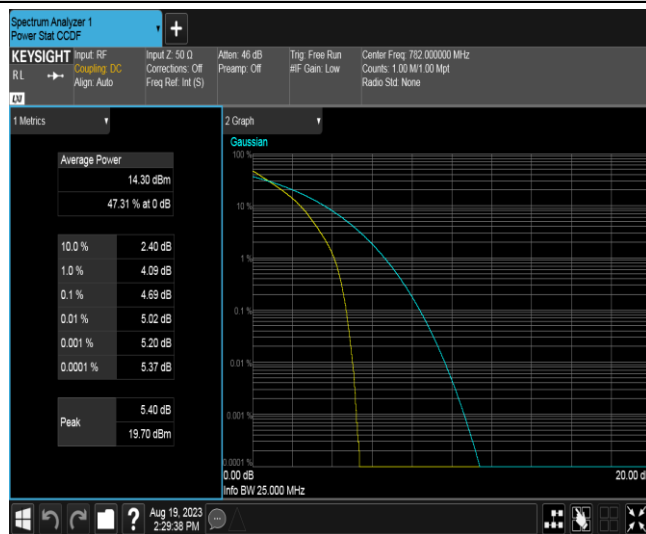

Band13-5MHz-QPSK-23230-1RB#0

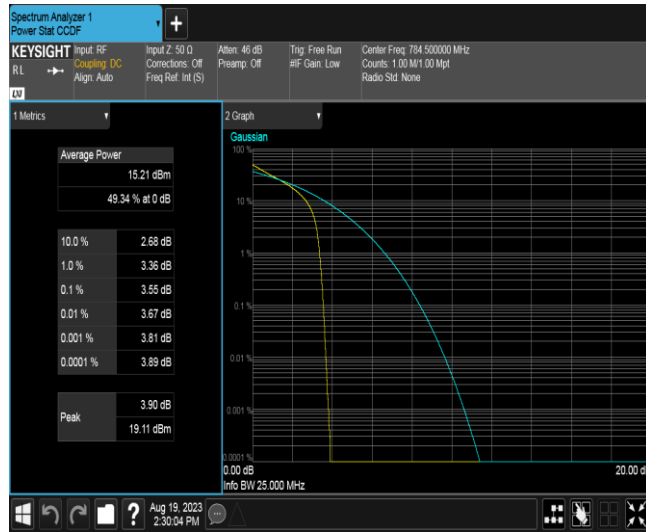
